Dear Sir;

On the night of October ninth an object was seen in northwestern sky. The object appeared about forty degrees above the horizon and covered the distance of twenty degrees in five seconds from first observation at 8:05 P.M.

Upon sighting I immediately compared the width of my thumb to the object and found it was about the size of a half-dollar at arms length. There was no wind, at that time, and no sound heard.

My observation was thus: a pale green object traveling from south to west-south-west at a forty-five degree angle. It appeared self-luminous rather than to be reflecting light. The object seemed to be a ball with an irregular glow. The stars were visible around the object so there was no cloud bank.


The place it was sighted from was the Student Center lounge. The moon was on the opposite side of the building to the object. Sighted while watching television, only few of us saw the object. There were no colors or marks of vision and no halo around sun or moon.
