SUBJECT: Unidentified Flying Object

TO: Operations Services Division

1. On 4 Nov 60 a call from the Secretary of Champaign T.V. station reported two UFO calls were received from Monticello citizens. Investigation of the reports revealed the following:

2. Description of Objects

- a. Objects were described as round flat discs.
- b. Size of objects approximate a bushel basket held at arms length.
- c. Two objects observed.
- d. Appeared as trailing formation.
- e. No discernible features.
- f. No tail or exhaust visible.
- g. No sound audible.
- h. Movements of objects appeared to be back and forth tracking motion and was observed for 30 minutes to one hour before disappearing.

3. Description of Course of Objects

- a. Mrs. ██████ sister called by phone to attract attention initially.
- b. Mrs. ██████ and Mrs. ██████ then observed the objects from 30 minutes to one hour outside the home of Mrs. ██████ before reporting it to Champaign T.V. station.
- c. Elevation and azimuth when first observed was estimated to be 20 to 25 degrees above the horizon in a direction of west to n.west.
- d. Angle or elevation upon disappearance same as above 20 to 25 degrees above the horizon.
- e. Description of flight path was as a elongated or circular motion or tracking back and forth.



f. Object disappeared suddenly as in a short burst to the northward.

4. Manner of Observation:

a. Objects were observed by naked eye.

5. Time and Date of Sightings:

a. Time of observation was 0250G on the 3rd day of Nov 60.

b. Sky conditions at time of sighting was dark and cloudy near objects and clear sky in opposite quadrant.

6. Location of Observers:

Sighting was at Monticello, Illinois on Route 47. Coordinates are 40 degrees 02 minutes north and 88 degrees 34 minutes west.

7. Identifying Information on Observers:

a. Observers were two civilians.

b. Mrs. [REDACTED] 25 years of age lives on [REDACTED] Monticello who is a housewife. Mrs. [REDACTED] 26 years of age lives on [REDACTED] Monticello also and works as a bookkeeper in the First State Bank of Monticello.

8. Weather and Winds Aloft:

a. At Chanute AFB located approximately 25 miles north, northeast of Monticello the weather conditions at the time of the sighting were as follows:

9. Comments of Preparing Officer:

a. Both women appeared in earnest in their reporting of the UFO however I had talked to several other people in the Monticello area who I believe saw the same phenomena and in their opinion the objects were lights played on the base of a clouds layer.
