10. BRIEF SUMMARY OF SIGHTING Elliptical, size of grapefruit. Color was very similar to a star, very bright. Objt was traveling on a steady course, seemed to bounce every five seconds. First observed angle 45° and azimuth 295°. Disappeared on an approx heading of 60°.		11. COMMENTS Objt was probably planet Venus. On day of sighting planet was of magnitude -4.3, as bright as it ever gets. Planet was low on horizon and in a direction which coincides with that reported by witness. Objt disappeared with setting of planet. Description of objt favorably matches that of objts which are distorted and given apparent motion by atmospheric refraction.



Report on Unidentified Flying Object (UFO)

1. Description of the Object:

- a. Shape - elliptical
- b. Size of a grapefruit
- c. Color - similar to a star, very bright
- d. Number - 1
- e. Formation - N/A
- f. Discernible Features: Object was traveling on a steady course, seemed to bounce every five seconds.
- g. Tail or Trail - None observed
- h. Unusual Features - The object seemed to stop and bounce.

2. Description of Course of Object:

a. When I first noticed the UFO at 1935 hours, 26 February 1961 at Capehart Housing, Tyndall Air Force Base, Florida, azimuth 295° , it seemed to be stopping and bouncing. I observed it for a while to make sure it was not an aircraft. I called Master Sergeant Maloney's children to observe it, while I called Captain Allan E. Aaronson. After talking to Captain Aaronson, I went over to Captain Norman R. Smedes and we observed it.

b. Angle or elevation and azimuth of object: Angle - 45° and azimuth 295° .

c. Angle and azimuth of object seemed to disappear on an approximate heading of 60° .

d. Description of flight path and maneuvers of object: The object traveled from west to east.

e. Manner in which object disappeared - all at once.

f. Length of time object was visible - 10 minutes.

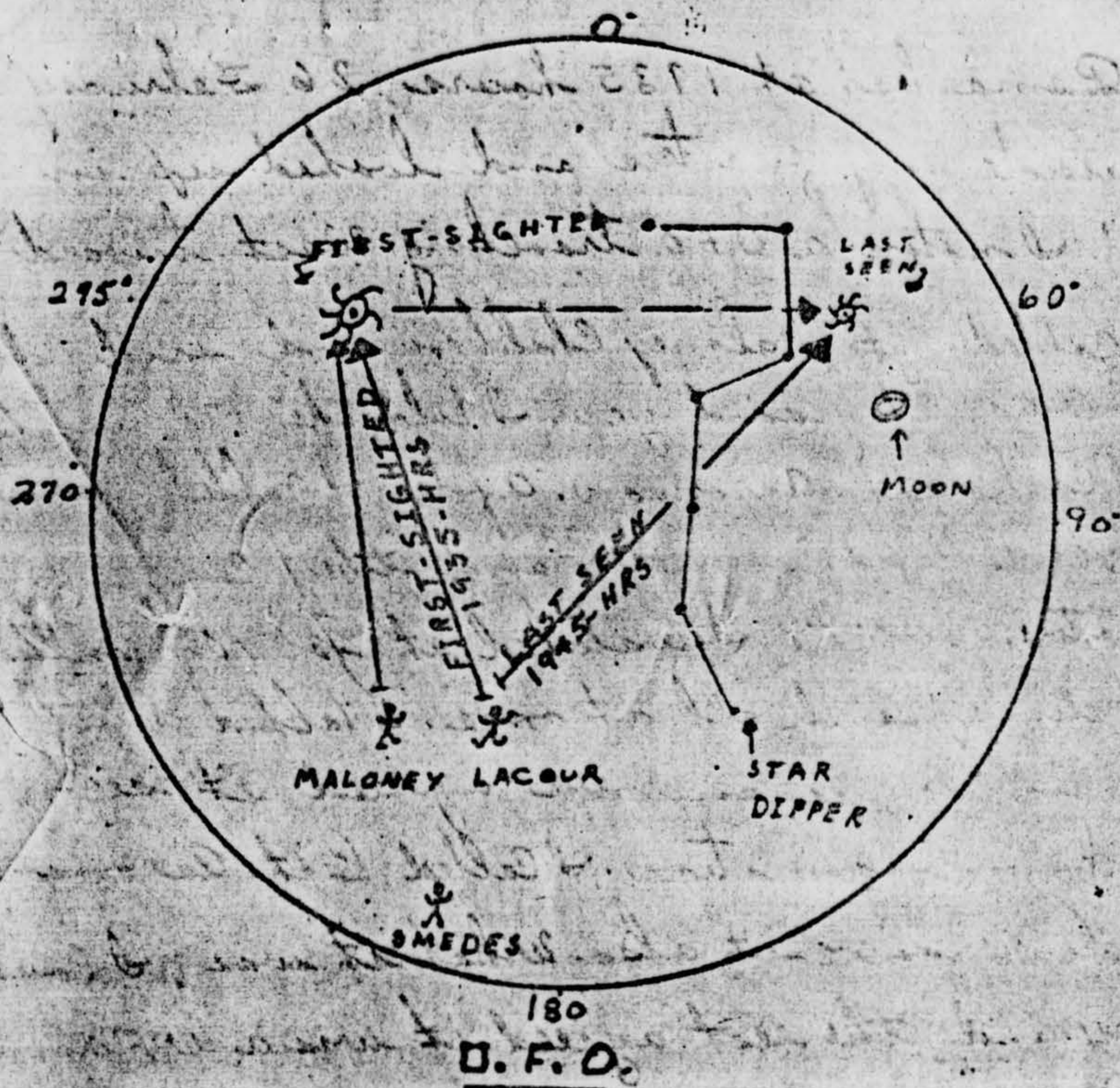

I'll call Capt. Aronson. After I called him, I
went over to West in a hurry and they came out
and I told them the UFO. I watched it for 10 minutes
and it disappeared all at once. I talked in the
middle of the area and we agreed it seems to
be a hovering motion. I called Capt. Aronson
back and he saw it also. What it was, I could
not say and the rest agreed it was a UFO.

Analysis and Conclusions: THE OBJECT VIEWED BY THE WITNESS OF THIS SIGHTING WAS PROBABLY THE PLANET VENUS. ON THE DAY OF THIS SIGHTING THE PLANET WAS OF MAGNITUDE -4.3, AS BRIGHT AS IT EVER GETS. THE PLANET WAS LOW ON THE HORIZON AND IN A DIRECTION WHICH COINCIDES WITH THAT REPORTED BY THE WITNESS. THE OBJECT DISAPPEARED WITH THE SETTING OF THE PLANET. THE DESCRIPTION OF THE

OBJECT FAVORABLY MATCHES THAT OF

OBJECTS WHICH ARE DISTORTED AND

GIVEN APPARENT MOTION BY ATMOSPHERIC

REFRACTION.

IT IS CONCLUDED THAT THE OBJECT

VIEWED BY THE WITNESSES REPORTING

THIS SIGHTING MISIDENTIFIED THE

PLANET VENUS.
