- H. NOTHING UNUSUAL THAT CAN ACCOUNT FOR THE SIGHTING.
- I. NO INTERCEPTION ACTION TAKEN.
- J. THERE WAS NO AIR TRAFFIC OR KNOWN BALLOON RELEASE IN THE VICINITY TO ACCOUNT FOR THE SIGHTING.
- K. THE BASE INTELLIGENCE OFFICER, RAF UPPER HEYFORD IS THE PRE-PARING OFFICER OF THIS REPORT. THE REPORTING OFFICER DID NOT WITNESS THE UFO.
