UFO Sighting, Osgood, Indiana (Mr. ██████████)

1. On 17 March 1961 Mr ██████████ of Osgood, Indiana forwarded to ATIC the report of a UFO sighting which he experienced on 13 March 1961. Mr ██████████ requested that he be advised of our findings regarding his sighting.
2. The witness reported that the object appeared as a star oscillating in brightness. The UFO was reported as traveling from low in the south toward the southeast and reaching a maximum elevation of approximately 45° above the horizon. The sighting occurred at Osgood, Indiana and lasted from 1955 to 2000 hours EST.
3. Coordination with the National Space Surveillance Center revealed that the object sighted by Mr ██████████ on 13 March 1961 was the U. S. Satellite Echo I. It is requested that the witness be advised of this conclusion regarding his sighting.
