J. A balloon was released from San Antonio International Airport Weather Station at 2330Z 16 April 61. Winds would put this balloon in the approximate area of the UFO.

K. Wing Operations, Randolph AFB, Texas. UFO was in all probability the balloon mentioned in "J". The setting sun would reflect from the sides of the balloon which were at an angle with the observer. The center of the balloon would not reflect being 90 degrees to the observer and in line with the sun.
