COMMENTS Object was at great altitude to give appearance of orbital flight. Check with Space Track determined that the object was not a Satellite. Also if the object were at the altitude of Echo it's speed would have been excessive. Information offered does not lead to a valid conclusion, therefore the case is listed as an unidentified. If additional information is received the analysis will be altered depending upon the nature of the additional information.
