k. 2nd Lt William E Stearley, acting as Officer of the Day for Brookley AFB, Ala, on 19 May 1961, received a report at 2000Z of Unidentified Flying Object from Mr [REDACTED], Mobile, Ala. Lt Stearley interviewed Mr [REDACTED] and believes him to be a qualified and reliable witness. Mr [REDACTED] had previously seen "A shooting star", "a dirigible" and "a Discover Satellite". Mr Matthews compared the object to the Discover Satellite and said it had the exact same appearance. Lt Stearley, making a follow-up investigation, learned that an Air Policeman at Mexico Beach near Tyndall AFB, Panama City, Fla reported the object. Oak Grove scrambled AF102 at 1605Z and an M15 at 1627 Z. Both Reports were negative.
