COMMENTS There was broken clouds and smoke present at time of 1st sighting. Venus was in in NE at about 20° elev. This is lower than that reported by witness, but it has been found that average individual cannot estimate elev accurately, especially at night and while lying down. Presence of smoke would tend to make planet appear at a higher elevation. 2nd objt was probably the star Capella.

1. The following information reported by Mrs. [REDACTED] on 30 June 1961 to the Selfridge AF Base Detachment Office of the Fifth District Office of Special Investigations, Wright-Patterson Air Force Base, Ohio concerning SUBJECT, is furnished for your information and action deemed appropriate.

a. Description of the object:

- (1) Shape - saucer
- (2) Size - about the size of a dime or nickel held at arms length
- (3) Color - white
- (4) Number - 1
- (5) No discernable features or details.
- (6) No tail, trail, exhaust or sound
- (7) Observer stated object was bright and seemed to be hovering or at least was motionless.

b. Description of Course of Object:

- (1) Observer awoke from sleep for some reason and lay looking out her bedroom window that faces the East. Brightness of the object caught the observer's attention.
- (2) Angle or elevation of object when first observed - approximately 60° from the horizon.
- (3) Angle or elevation of object upon disappearance - approximately 60° -- it just seemed to fade away.
- (4) Object just faded out like you would cut down a rheostat at a fast rate.
- (5) Object was visible for about 10 minutes.

c. Manner of Observation:

- (1) Ground - visual
- (2) Sighting made from bedroom
- (3) No photograph taken - no physical evidence
