B. DESCRIPTION OF COURSE

(1) First observer: Noticed the lights through the windshield of car while driving west toward Monticello, Ill.

Second observer: Was sitting in front seat of same car and his attention was drawn by first observer.

Third observer: Was driver of the car. All three observers were in front seat.

(2) First observer: Lights appeared banked to left, travelling approximately parallel to auto's course, seemed to be descending slightly. Stayed in same relative position. Was about  $30^{\circ}$  high to the left of car.

Second observer: Seemed to be banked like an airplane. Approximately  $30^{\circ}$  angle high from car to the left of road.

Third observer: It was over to the left approx. Rather like an airplane banking to the left.

(3) First observer: Stayed in same relative position.

Second observer: Stayed in same place.

Third observer: Remained right in same place.

(4) First observer: Third light joined other two lights.

Second observer: Third light came from left to right other two lights were stationary.

Third observer: There were two lights together and a third further to the left. The third light travelled over to the other lights.

(5) First observer: The lights just seemed to fade out.

Second observer: They just faded out.

Third observer: All of a sudden they faded out.

(6) First observer: Three minutes

Second observer: One and a half minutes

Third observer: One to two minutes

J. There was a Commanche type light aircraft inbound from South Carolina which landed approximately 2200 local.

K. Course supervisor, minuteman maintenance officers course. After checking with the University of Illinois airport control tower manager, the student flight scheduling of U of I and the flightline mechanic, I came to the conclusion that it was a transient Commanche circling for a landing at the U of I airport. The mechanic said he thought this Commanche had an additional landing or taxi light on its nose gear. The double landing lights on the Commanche are located out in the wing tips. The double lights on each wing tip plus the nose light would account for the three lights. The pilot of the aircraft probably turned on his lights to give the tower his position while requesting landing instructions as he circled the area west of the field. The statement that the lights did not change their relative position to the car could be due to the car travelling west at 50 to 60 mph. The aircraft was probably beginning a turn from a west to east heading and its ground speed west at the time seen was approximately the same as that of the car. Each observer said they couldn't see any other lights. The lights were seen for approximately two minutes and when they went out there were a few moments of night blindness during which time the aircraft probably passed to the rear and out of sight through the windshield. The observers said they heard no sound. The window on the left side was rolled up. The road was in very poor surface condition. We drove it at 55 mph and it would have been extremely difficult to have heard an aircraft under those conditions. I was unable to talk to the tower operator to see if he remembered any details of the Commanche's landing pattern. But the serial number of the Commanche is N 7375P. It came from South Carolina and stopped at U of I airport for refueling and later departed prior to the investigation.

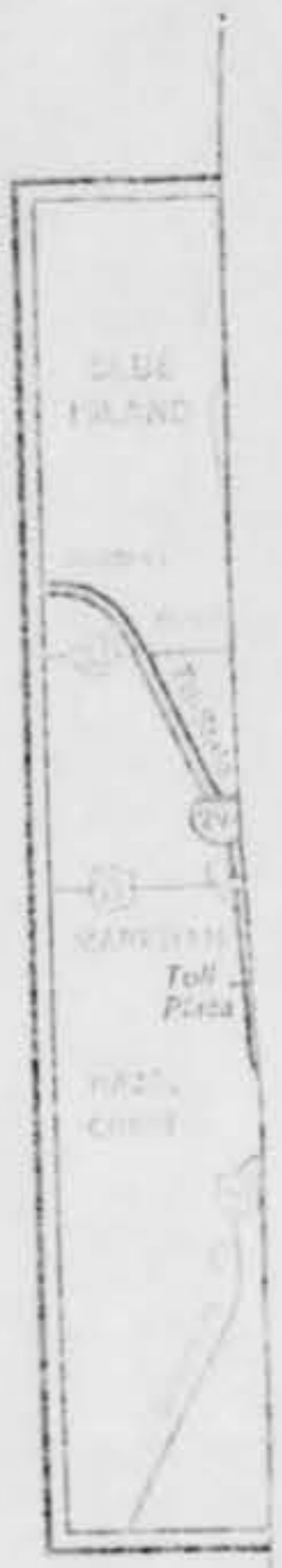

Dear Sirs:

This is the information given to me.

On July 15, 1961 about 4 miles east of Monticello, Illinois three people were in a car on a highway and saw in the sky, about 500 ft., high three lights traveling through the sky, to the north. The time in the evening was about 9:45 P.M., the lights were two in front and ~~7~~ setting at an angle, about 30 to 40 ft., apart one other light in the rear which keep getting a little closer to the two lights in front. When the one light in the rear caught up with the two lights in front they all began to fade out and the last the people saw of them when they had faded away they were within about fifteen feet of the earth. The lights were real light white in color.
