1. The subject photography has been examined but no conclusion can be reached as to the identity of the object. However it appears to be a small object photographed at close range.
2. On two of the photographs the light source was apparently the same, while on the third image the light came from a radically different angle. This indicates either a large passage of time out of doors, or indoor photography, either of which would preclude a chance encounter with a flying saucer.
3. It is our opinion that this is a deliberate effort to mislead us.
