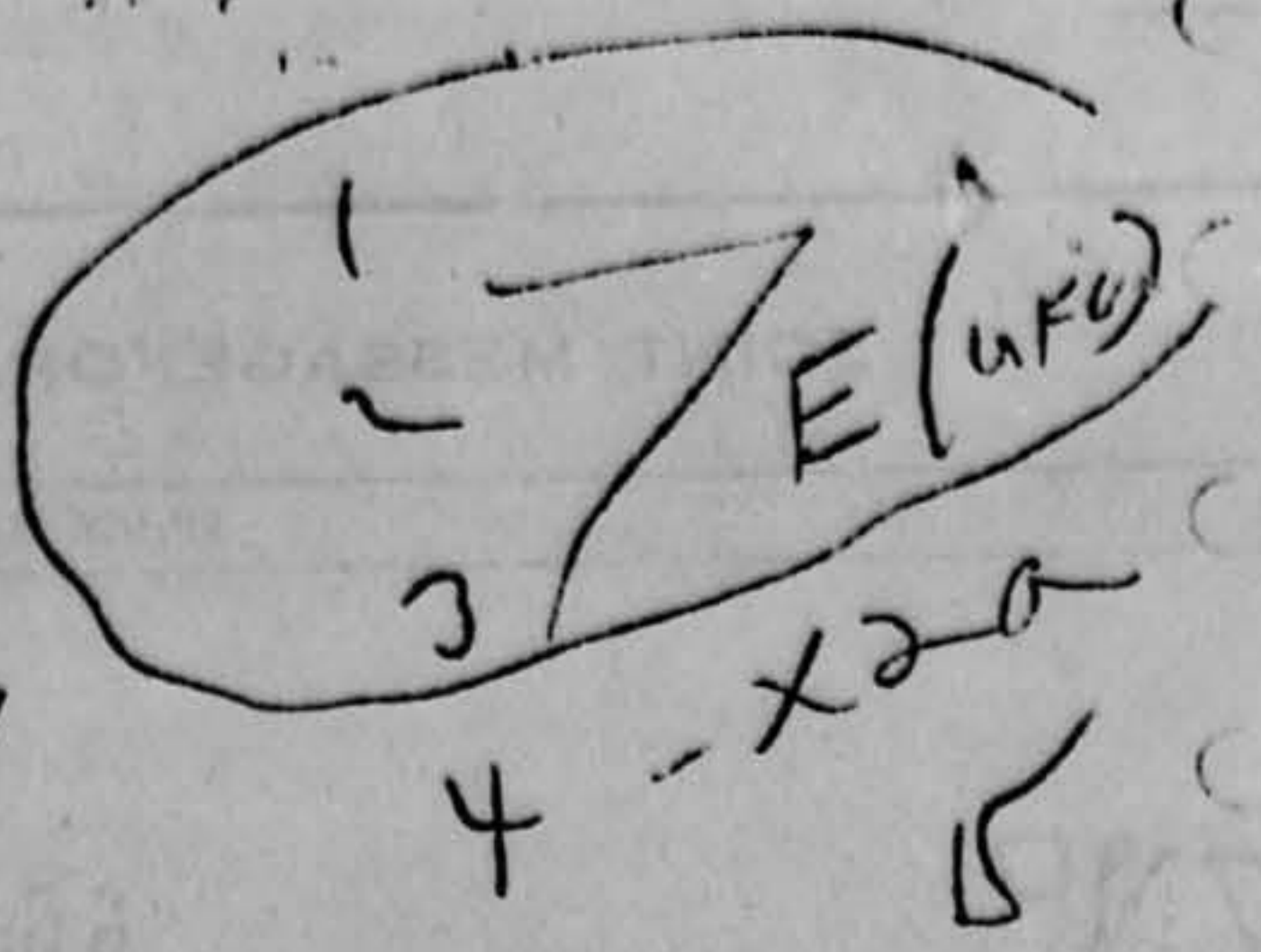

YOUR MSG TD-E 6-9-69, 6 SEP 11. THE LAST TWO OBJECTS APPEARED AFTER THE FIRST FIVE HAD MADE THEIR TURN BACK AROUND TO THE WEST. THE FORMATION OF FIVE WHEN FIRST SIGHTED WAS MOVING FROM WEST TO EAST AND SEEMED TO MAKE A LARGE TURN THROUGH NORTH BACK TO A WESTERLY HEADING. THEN THE TWO BRIGHTER OBJECTS APPEARED. THEY SEEMED TO MAKE A SMALL 360 DEGREE TURN, THEN FOLLOWED FIRST FORMATION. TIME WAS ZULU. SMITHS CONTACTED PRIOR TO FIRST REPORT.
