Dear Sir I had heard over Radio/Television
& news paper that the Air Force had fired a
midas satellite into orbit from Point Arguello
Calif. to eject 350 million copper needles into space
on Oct. 21. Now I see in the news paper that
these needles or Dipoles as they call them have not
located by this time. Now I would like to relate
to you my experience. As I went after our mail
on Oct. 25 at about Eleven Thirty A.M. I saw a very
peculiar sight. It was a bright forenoon the sun
was out and we had a westerly wind. There was
before me in my line of view to -ward the horizon
a glittering belt running North & South of me as if
the air was full of glittering golden
needles I watched it until it was out of sight
^{over}

toward the east. I related my sight to
the rest of my family as I got back to the
house. Now we see in the papers over
the radio that they have not found any
trace of these needles or Dipole. We thought
it was our duty to report this incident to you.
