Dear Sirs:

On April 2, 6:00 A.M. eastern standard time I was on my newspaper route and I saw something very unusual.

My town is about 30 miles from the sea shore. I was facing east just before the sun came up. The sky was very bright and above the clouds I saw a large rocket leaning over about 40 degrees with no exhaust. It all seemed very small. A little exhaust came out the top while two vehicles flew out that looked like small, long, dots. The rocket fell out of sight. The vehicles traveled across the sky south west. Then they curved around so they would be parallel to each other traveling directly north. Every few minutes exhaust would come out of them to give them more speed. After about fifteen minutes I lost sight of them.

It could be a U.S. experimental rocket but I really don't know.




