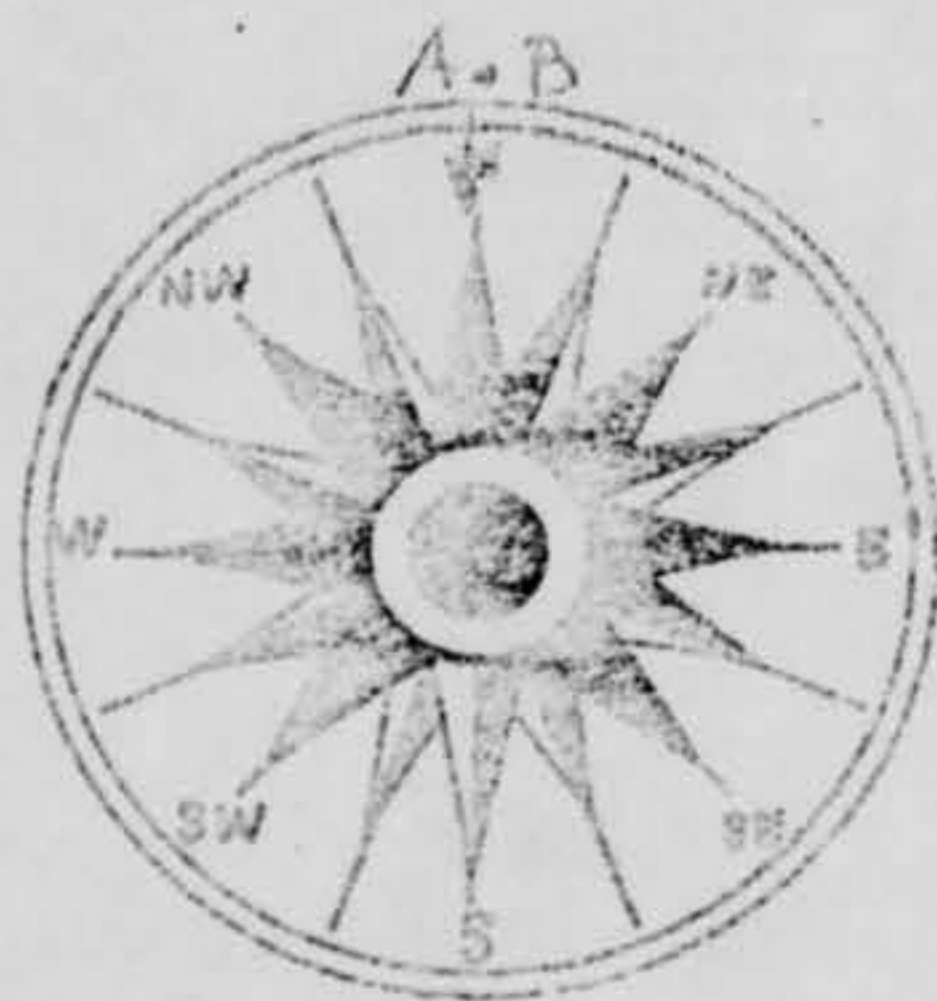
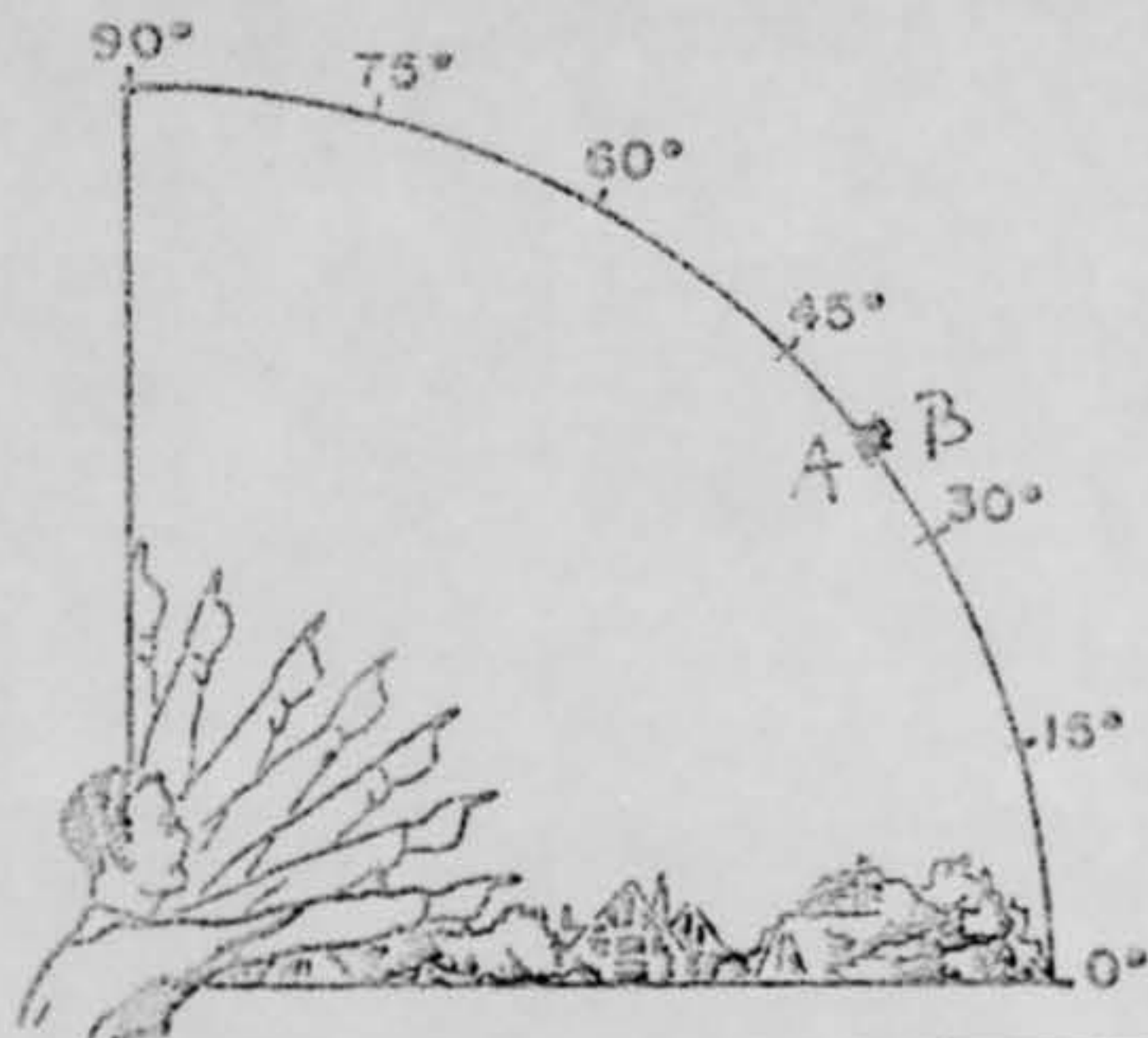

While driving north-bound on Route 128, noted four small identical round-topped parachute-like objects grouped 3"-5" apart (no particular formation), some distinctly nearer than others, uniform in color (blue-gray) lustrous, but with no reflections (high-light) though bright sun shining on them & sky clear blue. Apparently were moving slowly north, beyond & above a transport plane coming over me low from vicinity of Hanscom Field & traveling south.
