MEMORANDUM FOR THE RECORD

██████████, Central Airlines Agent

2030 local time 2 August 1962 Liberal, Kansas

1. ██████████ received a telephone call reporting bright objects moving East to West at a very fast speed. He tried to see the objects but could not. He talked with Captain ██████████ a pilot on the flight (#61) from Wichita to Liberal who reported several green and blue objects moving East to West at terrific speed. The objects were in sight for two seconds.
2. Captain ██████████, an airline pilot, reported an extremely bright object looking like an aircraft with landing light stationary in the Eastern sky. About 2100 Mr. ██████████ went outside and observed a white object moving from East to West at a high speed. The object was in sight for two seconds and appeared to pass overhead.
3. There were numerous phone calls made to Mr. ██████████ office regarding these objects. One witness reported a roaring noise. Mr. ██████████, while in contact with agents of Pueblo and Garden City, was informed that they saw the objects also.
4. The stationary object was Jupiter at a magnitude of -2.4, its maximum brightness, and at a 10 degree elevation. Jupiter was in the East at azimuth of 100 degrees. The moving objects are evaluated as meteors.

...On the night of August 2nd, a series of brilliantly-colored flying objects lit up the runways of the airport at Liberal, Kansas, and were seen by many people there. Similar reports were made at the same time in Albuquerque, New Mexico; Pueblo, Colorado; Garden City, Kansas, and Gayton, Oklahoma.

Liberal, Kansas Sightings

On August 2, 1962, personnel at the Liberal, Kansas airport were shaken considerably when various colored brilliant objects lit up the runways. Whether or not this indicates the objects were low enough and bright enough to actually shed light on the ground is not known. However, similar reports came from Albuquerque, N. M., Pueblo, Colorado, Garden City, Kansas and Gayton, Oklahoma. Central Airline Agent Fred Jones said about a dozen individuals at the Liberal airport saw the phenomena at about 8 p.m.

According to Jones, Capt. Jack Metzker, VA pilot enroute from Wichita, Texas, to Amarillo, told airport officials he saw the objects which he said were moving higher and faster than any plane he had ever seen. Metzker's aircraft was at between 5000 to 7000 feet at the time he sighted the objects.

Witnesses described the lights as about the size of car headlights, and they varied in color from white, green, blue to brilliant orange. There were four of the objects, Jones said, which moved singly across the sky. One became stationary over the airport and seemed to produce a landing-type light directly under it.

All sighting took place at approximately 8:45 p.m. The reports came to Liberal over the airport's telephone communications system. The FAA said no planes which could produce such lights were scheduled in the area at the time.

At Amarillo, Metzker made this statement: "People I talked to after landing here seemed to think it was a meteorite, but it wasn't like any meteorite I've ever seen."

Witnesses at Pueblo described a blue ball of light traveling north
