1. The attached report of an unidentified flying object is submitted in accordance with AFR 200-2. AF Form 112 is not available to this unit but the format used is patterned after par 14 of the above regulation.
2. An inquiry to the radar site at the Saratoga Air Force Station indicated they observed nothing unusual on their radar equipment during the period in which this reported object was sighted.
3. We suspect the observer may have an overactive imagination but this is our first experience with UFO's and are forwarding the report for examination by more competent personnel.
4. Our information officer has written Mr [REDACTED] in accordance with AFR 200-2, par. 6d.

1. UFO Report

a. Description of the Object

- (1) Shape: Undefined and blurred
- (2) Size: Baseball held in hand at arms length
- (3) Color: Amber
- (4) Number: One
- (5) N/A
- (6) Features: Bluish rays of light projecting from object, intermittent, position varied.
- (7) No tail, trail, or exhaust seen.
- (8) No sound heard
- (9) Motionless for approximately two hours then moved horizontally for a distance, thence straight up and out of sight. Motion took place during later 10 minutes of sighting.

b. Description of Course of Object

- (1) Object noticed while observer scanning sky for "falling stars."
- (2) Object observed approximately at 40 deg. elevation and azimuth of approximately N 90 deg. E
- (3) Object disappeared at approximately 90 deg. elev
- (4) Object motionless for about two hours then traveled West-South-West to a point over the observer, thence straight up.
- (5) Object disappeared while traveling straight up, becoming smaller and fainter as it appeared to recede.
- (6) Object visible about two hours from first sighting.

k. Comments -

Mr. [REDACTED] did not exhibit any technical knowledge concerning the reported events nor did he admit to any technical qualifications. Constellations or planets in the area of sighting could not be identified by the observer. The description of the object's appearance and motion was very vague and inconsistent. Unfortunately the interview did not take place at the scene of the sighting and an accurate location of the object in the sky could not be determined. The supervisor's opinion of Mr. [REDACTED]'s tendency towards exaggeration seemed substantiated in my personal interview.

The first impression of this officer is that the object would be a scientific or meteorological balloon reflecting light from the moon. The motions could be attributed to a change in wind velocity and direction.

Secondly it is noted that the object appeared approximately due east of the observer. The city of Albany is about 15 miles in this direction although not directly visible from this mountainous location. The lights of the city accompanied by a certain atmospheric conditions may put the sighting in the class of an optical illusion.

The movements described would seem to eliminate the visible planets (Jupiter and Saturn) and the meteor shower (Perseids) from consideration. However, Jupiter is at about the elevation and azimuth described and is a very prominent object in the sky.

In conclusion, the lack of scientific method in the observations and the questionable reliability of the observer makes an accurate hypotheses difficult. My opinion would be that the view of Jupiter accompanied by possible moonlit vapor trails and imagination brought about this reported observation. It could be suggested that the two other witnesses, having returned to Long Island, be interviewed in an attempt at clarification.

1. Physical evidence to support the observation does not exist.
