

The foil pieces you inclosed in your letter are known as "chaff". Dropped from aircraft in bundles, they quickly separate and each piece of chaff gives a radar return resembling an aircraft. These radar returns clutter the monitoring radar scopes masking the movement of the aircraft. They are extremely effective as they fall slowly and permit the aircraft to pass undetected. Chaff are dropped by USAF aircraft on practice missions.

Description: Shape was similar to a lemon (a little different than an egg) and the front was more round than the back. Three objects were crowded together and would have been touching each other, very close. The leading object was approximately 2 or 1½ lengths ahead of the other two. The objects were longer than they were wide. No windows, form, exhaust, tail, or trail was seen. There was no sound or odor. The objects were a dull aluminum color.

The objects were in a formation like geese - a leader and two behind, one on either side. Observer could not tell whether one was higher than the others, but it might have had to be in order to fly so closely.

Observer could not tell whether objects were on a slant or flying straight, but said they were in level flight.

The objects were lit up but with no lights. Observer said he thought the moon must have been below the mountains throwing light and also that the light from Washington Boulevard might have been lighting the objects.

The objects were estimated to be at an elevation of about a thousand feet. Witness indicates that the objects could have been three or four times that estimate.

WX Conditions: It was fairly light out. Stars and faint outline of mountains could be seen by witness. At 9:30, the witness looked at his watch and at the same time noticed heavy white clouds moving in from the Northwest. They completely covered the area in a few minutes. Witness stated that if any odor accompanied the objects, it would have been blown away rapidly.

Optical Aid: Observer wears glasses but did not have them on at the time of the sighting. He has vision of 30-40 (good enough to pass driving test, but not good enough for job according to Doctor at the railroad).

The observer and his grandson were in the yard hoping to see some satellites. Objects appeared in space between two trees in witness's yard. The objects disappeared behind and rising to the top of the tree (second tree).

**SUMMARY** At 1530Z hours on 21 August 1962 a report of a UFO sighting was received from [REDACTED] railroad engineer for the Union Depot Company, Ogden, Utah. Pierce reported while sitting in his back yard at [REDACTED], Ogden, Utah, he sighted three objects approximately one block away and at a minimum of 1000 feet high, traveling from north to south or possibly turning toward the southwest moving at a very high speed, being in view from 10 to 15 seconds.

1. At 1530Z hours, 21 August 1962, [REDACTED] reported that at 0348Z hours, 18 August 1962 he sighted 3 objects approximately one block away and 1000 feet high traveling from north to south at a very high speed.

2. At 1535Z hours, 22 August 1962, Mr. [REDACTED] Ogden, Utah, was interviewed at this location. Following is the information received on the interview: The following information and answers to questions is prefaced by paragraph number of items of information requested in paragraph 14, AFR 200-2, dated 20 July 1962.

14a(1) Shape - Lemon shape rounded off a little more on front than on the back.

14a(2) Size - Could be covered with a half dollar at 7 inches from the eye.

14a(3) Color - Dull aluminum.

14a(4) Number - Three.

14a(5) Formation - In V formation.

14a(6) Discernible Features - Appeared to be solid metal.

14a(7) Tail, trail or exhaust - Could see none.

14a(8) Sound - No sound heard.

14a(9) Pertinent features - None observed.

14b(1) What called attention to objects - Was sitting on lawn watching for satellites.

14b(2) Angle, elevation, azimuth - Was first noticed in East as they came in view from behind house, about 30 degrees from ground level.

14b(3) Angle, elevation and azimuth at time of disappearance - At same level as when first sighted.

14b(4) Flight path and maneuvers - Moved from north to south at very high speed.

14b(5) How did the object disappear - Went out of sight behind a tree, wasn't seen again.

14b(6) How long object visible - About 10 seconds.

14c(1) Manner of observation - Naked eye.

14c(2) Optical aids - None.

14c(3) Airborne sighting - N/A.

14d(1) Time and date of sighting - 0348Z hours, 13 August 1962.

14d(2) Light conditions - Dark and clear.

14e Location of observer - [REDACTED]  
west.

14f Information on observer - [REDACTED] is a civilian, appeared to be an emotionally stable person, 56 years old and gave a clear, consistent report on the sighting. Has 37 years experience as an engineer for the railroad and seemed exact in all his information.

14g(1) Weather and wind - The weather was clear with a few scattered clouds, with a slight breeze.

14g(2) Report of weather and wind - Hill Air Force Base reported weather at time of sighting was clear. Surface winds NW  $300^{\circ}$  at 6 knots - 6,000 feet.  
 $230^{\circ}$  at 20 knots - 10,000 feet,  $240^{\circ}$  at 20 knots - 16,000 feet.  
 $230^{\circ}$  at 25 knots - 20,000 feet,  $220^{\circ}$  at 25 knots - 30,000 feet.  
 $240^{\circ}$  at 30 knots - 50,000 feet,  $210^{\circ}$  at 20 knots - 80,000 feet.  
 $200^{\circ}$  at 20 knots.

14g(3) Ceiling - Unlimited.

14g(4) Visibility - 20 miles..

14g(5) Cloud cover - Clouds scattered, total cover - .3.

14g(6) Thunderstorm - Possible thunder southeast through south.

14g(7) Temperature -  $77^{\circ}$ .

14h Unusual activity or condition - None.

14i Interception or identification - Observer sighted objects on a Saturday evening and didn't report until Monday morning. No interception or identification attempted.

14j Air traffic and balloon releases - Hill Air Force Base reported no known aircraft in area - no balloons released.

14k The preparing officer is an investigator, CS-7, Security and Law Enforcement Division, Hill Air Force Base, Utah. Preliminary analysis indicates the observer is a logical and mature person. He is convinced the objects were not conventional type aircraft. No leads nor clues were developed that would lead to the identity of the objects. The observer with his 10 year old grandson were the only reported witnesses to this sighting. There are no known manufacturers of experimental type aircraft in this area, and no known missile firings are being conducted other than static tests. With the supervision of this report, it is believed that all logical efforts to identify the objects have been exhausted.
