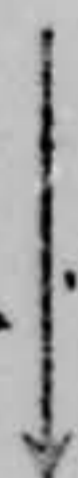

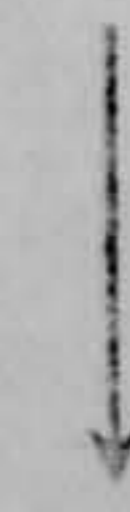

NEWS BRIEFS: Twenty-four UFO's were spotted moving in single file across the night sky by several police officers in Wisconsin last September 4th. "They resembled shooting stars but were spaced out, one after another across the sky, and they didn't burn up," said Deputy Sheriff Stanley Kukanich of Vilas County. The Deputy added that checks by radio and telephone indicated that flying objects were spotted at the same time by police authorities in three places within an area of 80 miles..

In the early morning hours of 5 September 1962, residents in Minnesota and Wisconsin witnessed a spectacular and awesome sight: Brilliant, glowing red objects appearing to be in formation, streamed down through the atmosphere. Several small and one large piece of residue landed in Manitowoc, Wisconsin. The cry of "UFO" and "censorship" went out among many UFO researchers and enthusiasts, but as the information streamed in to APRO headquarters it became quite apparent that the above-mentioned witnesses had observed the dying throes of a Russian satellite as it burned and broke up coming into earth's atmosphere.

SCIENTISTS HAD EXPECTED SPUTNIK IV TO BREAKUP WEDNESDAY. SHORTLY BEFORE THE PIECE OF METAL WAS FOUND THERE WAS NUMEROUS REPORTED SIGHTINGS OF FLAMING OBJECTS IN THE WISCONSIN SKY.

DR. FRED L. WHIPPLE, DIRECTOR OF THE SMITHSONIAN ASTROPHYSICAL OBSERVATORY, SAID THE FIRST TESTS WERE TO DETERMINE WHETHER THE OBJECT WAS RADIO-ACTIVE.

SPUTNIK IV WAS LAUNCHED MAY 15, 1961 AMID UNCONFIRMED REPORTS THAT IT POSSIBLY CONTAINED A MAN. ANOTHER UNCONFIRMED REPORT SAID THE SATELLITE HAD A DUMMY ABOARD.

THE METAL IN QUESTION WAS FOUND BY TWO POLICEMEN. IT DUG OR BURNED A THREE-INCH HOLE IN THE GROUND. OFFICIALS SAID LIMESTONE IN THE ROAD WAS POWDERED, AS IF BY EXTREME HEAT. A LABORATORY SPOKESMAN SAID THE TEST MAY TAKE FIVE DAYS.

6 SPUTNIK PIECES

MELWAUKEE, (AP)--A 20 1/2 POUND PIECE OF METAL, POSSIBLY PART OF RUSSIA'S FOUR-TON SPUTNIK IV HAS BEEN FOUND AND FORWARDED TO THE SMITHSONIAN ASTROPHYSICAL OBSERVATORY FOR EXAMINATION, IT WAS REPORTED TODAY.

THE SPUTNIK IV, LAUNCHED 23 MONTHS AGO, APPARENTLY BROKE UP OVER WISCONSIN EARLY WEDNESDAY, CAUSING A RASH OF REPORTS OF FLAMING UNIDENTIFIED FLYING OBJECTS.

THE CHUNK OF METAL WAS FOUND ON A STREET IN MANITOWOC, 35 MILES NORTH OF MELWAUKEE. IT WAS SPOTTED FIRST BY TWO PATROLMEN, HOWARD RUFFOLDT AND MARVIN BAUCH, WHO THOUGHT IT WAS CARBOARD IN THE DAWN DARKNESS.

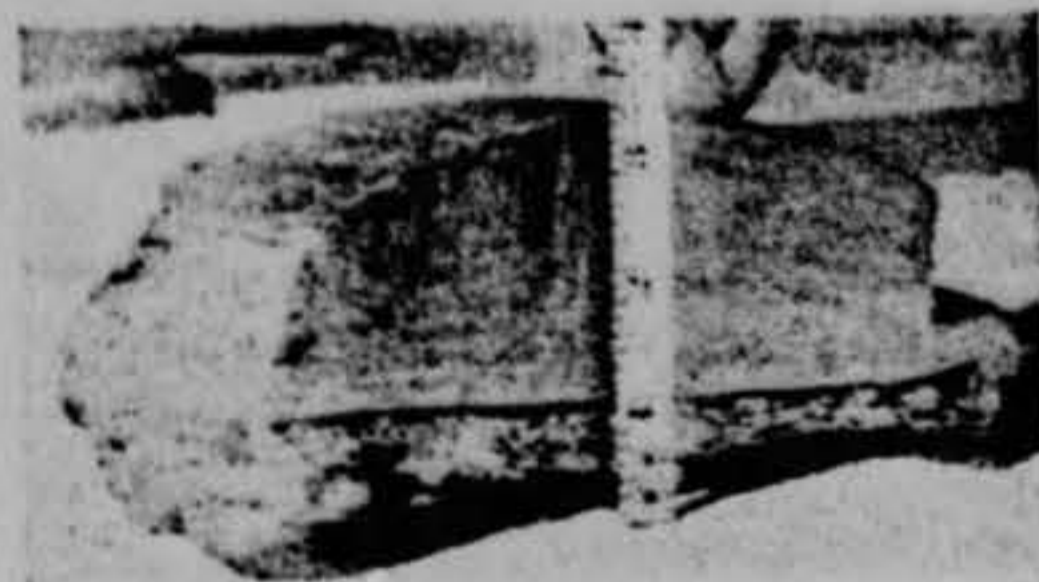
RUFFOLDT AND BAUCH RETURNED LATER AND FOUND THE METAL TOO HOT TO HANDLE. WHEN THEY HEARD THE REPORT THAT FLAMING OBJECTS APPARENTLY WERE PART OF SPUTNIK IV THEY WENT BACK AND RETRIEVED THE CHUNK.

POLICE OBTAINED THE HELP OF A STEEL EXPERT, KENNETH GEVERS OF TEN STEEL PRODUCTS OF CHICAGO, WHO WAS IN MANITOWOC. GEVERS SAID THE METAL APPEARED TO BE HIGH TEMPERATURE RESISTANCE STEEL, PROBABLY THE MAIN PORTION OF A SATELLITE'S NOSE CONE.

That Chunk of Sputnik

After a series of bright, meteorlike objects had shone in Middle Western skies, and cops picked up a 20-lb. piece of hot steel on a quiet Wisconsin street, word got out that a Soviet Sputnik had broken up above the U.S. The steel was rushed to the Smithsonian Astrophysical Observatory in Cambridge, Mass., where a 6-lb. piece was cut off. The rest went to Los Alamos Scientific Laboratory in New Mexico to be tested for radioactivity. Last

week, skeptics, who had all along suspected a hoax, got an official disappointment: the steel really came from a Sputnik.

First report was from Los Alamos. Radiation Expert Dr. Ernest C. Anderson reported that the object has the same sort of radioactivity that is shown by natural iron meteorites. Cosmic rays from distant space have turned some of its iron atoms to unstable manganese 54, which gives off radiation while it is decaying to stable chromium 54. This is good proof that the object was part of a spacecraft that had orbited for a long time above the atmosphere, which stops most cosmic rays. The piece that fell on Manitowoc, Wis., probably came from the breakup of Sputnik IV, the five-ton Russian satellite that was launched on May 15, 1960 and disintegrated Sept. 5, 1962.

No one was sure what part of the Sputnik the chunk of steel came from. It is roughly lens-shaped, with one face smooth and the other covered with very rough steel that looks as if it had melted and then hardened again. This could have happened if the chunk moved white-hot through the atmosphere with the smooth face forward, allowing molten steel to flow to the cooler rear side and solidify there.

Los Alamos experts do not want anyone to get the idea that metal which has been exposed to space is dangerously radioactive. The Sputnik chunk, they say is less radioactive than many kinds of granite and wholly harmless. Future satellite fragments can be safely gathered and sent to the proper authorities for analysis.

RUSSIANS REJECT CHUNK OF METAL OFFERED BY U.S.

American Delegate Cites Fragment As Evidence Of Need For Agreement

"DRAMATIC" MOVE IS HIT

Soviet Official Says Black- ened Steel Aimed At Wrong Target Here

(By The Associated Press)

UNITED NATIONS, Sept. 14.—The United States offered the Soviet Union today a 14-pound piece of blackened steel presumed by American scientists to have come down as part of Sputnik IV after more than two years in outer space. The Soviet Union rejected it, saying it was aimed at the wrong target here.

U. S. Delegate Francis T. P. Plimpton showed the fragment to the U. N. Committee on the Peaceful Uses of Outer Space and said it had fallen on a street in Manitowoc, Wis., early on Sept. 5.

He said it was tangible evidence of a need for an international agreement on paying for injury or damage from objects launched into space. The United States is promoting such an agreement.

Plimpton invited the Soviet Union to name experts to examine the fragment. He also said he would be glad to turn it over to Soviet Delegate Platon D. Morozov "now or at any time of his choosing."

Instead of accepting the object, Morozov said he did not know "whether it belongs to the United States or the Soviet Union." He accused Plimpton of using "dramatic means . . . to divert our attention from great, important issues" such as a declaration of general legal principles on space exploration. This is being promoted by the Soviet Union.

But, he declared, "This piece of metal which, figuratively speaking, is being thrown at me by Mr. Plimpton of the United States . . . won't hit the target."

"If it fell on my head or the head of my interlocutor," said Morozov, "the results would be the same." But he declared the consequences of a radiation belt in space, like that created by a U. S. high altitude nuclear shot last summer, were 100 times worse.

After the meeting, Soviet Space Expert Anatoly A. Blagonravov inspected the chunk of metal, smiled but said nothing. Morozov walked out of the room without looking it over. He told a reporter the exhibit was "a circus trick intended to strengthen the inhuman U. S. position" against the Soviet-proposed declaration.

Morozov declined to say whether he eventually would accept the fragment. But he said if the United States had a claim against the Soviet Union for reparation on its account, "there are international procedures for submitting such things."

Plimpton, talking with reporters crowded around the fragment, said lightly that the Manitowoc street department might have a claim against the Soviet Union for a hole in the street but no claim had come to the State Department. He wrapped the thing in cardboard and took it back to the U. S. mission.

The object is black, about 10 inches across and two inches thick and sharpened like a small, round cake resting on a cushion of foam.

Plimpton's aids explained that the foamlike substance is metal that had melted off the leading end, flowed around to the back end and congealed. The object had been cut across one edge to show that the inside is silvery metal.

Plimpton told the committee the fallen chunk had weighed 20 pounds but the Smithsonian Astrophysical Observatory in Cambridge, Mass., had cut off a six-pound piece for scientific analysis.

"Analysis by the Smithsonian Laboratory and four other laboratories showed that it was of alloy steel and that it had been in outer space for a considerable time . . ."

"Fortunately, the fragment here on this table caused no serious damage on impact, but the possibilities of harm are evident."

Kenneth Gevers holds scorched fragment of metal found on street

Metal Is Man-Made, But There's No Trademark

CAMBRIDGE, Mass. (AP)—The Smithsonian Astrophysical Observatory said today that a metal fragment found in Wisconsin on Wednesday was man-made, but it was unable to determine if it was from a Soviet satellite.

The 20½-pound piece of metal

could be a fragment of the 10,000-pound Soviet Sputnik IV that apparently broke up after 27 months in orbit and disintegrated.

The North American Air Defense Command reported the satellite broke up in the earth's atmosphere shortly after a fiery

show over Wisconsin's skies. The fragment was found in Manitowoc, Wis., and sent to Smithsonian.

The observatory here reported there were no markings on the metal that would give any clue as to what country it came from.

Soviet Rejects Offer Of Piece Of Sputnik 4

UNITED NATIONS, N. Y., Sept. 14. — (AP) — The United States offered to the Soviet Union today a 14-pound fragment it said came from Sputnik 4 and landed in Manitowoc, Wis., in the early morning hours of Sept. 5.

U.S. Delegate Francis T. P. Plimpton made the offer at a meeting of the U.N. committee on peaceful uses of outer space.

Plimpton said the offer was a concrete gesture of real cooperation in peaceful exploration of outer space.

The step caught Platon D. Morozov, the Soviet delegate, by surprise and he made no immediate move to accept the fragment for study by Soviet scientists. Morozov had just concluded an attack on U.S. policy in the outer space committee.

After the meeting was adjourned, Morozov walked out of the committee room without accepting the fragment.

He told a reporter he considered the offer "a circus trick intended to strengthen the U.S. position" against a Soviet-proposed declaration of legal principles on outer space exploration.

He declined to say whether he would accept the chunk of metal eventually but added "If they (the United States) want some reparations, there is an international procedure for submitting such things."

Informed of the Soviet comment, Plimpton said smiling to reporters that the Manitowoc street department might have a claim against the Soviet Union since the object had made a hole in the street.

a. Object was brought to this office, this date, by S/A Houle, OSI. No prior knowledge by this office. (U)

b. Object was brought to the Air Police, this base, 20 Sep 62. It was then turned over to the local OSI Detachment and forwarded to OSI District Headquarters at McChord AFB, Washington. McChord OSI officials returned it to the local detachment for local action. (U)

c. Relevant facts: On 3 Sep 62 Mr. [redacted], farmer, Box [redacted] Star Route, Quincy, Washington, plowed his field. On 4 Sep 62 Mr. [redacted] returned to his field and found the metal object on top of the newly plowed soil. According to S/A Houle, Mr. [redacted] farm is away from any roadways and the possibility of the object's having been thrown into the field is negligible. Further facts worthy of consideration: The coordinates of Quincy, Wash., are 47°41'N, 119°41'W. Date of finding was 4 Sep 62. Sputnik remnants found in Wisconsin were discovered 5 Sep 62 at approximately 45°N. (C)

d. Conjectures: This piece of metal may have come from a malfunctioning jet engine of US make. On the other hand, it is barely possible that it may have come from the Russian Sputnik mentioned in c. above. (C)

2. Request that your Directorate consider the problem and take such action as is considered advisable and adequate. Further suggest that consideration be given to analysis by AFIC. (C)


