But I am going to try to do my best to tell you about Objects that are landing in our woods. My husband and I were riding along West on Highway 8. The Objects two of them came down on top of trees next to the highway. The Objects stoped on top of the trees. My husband and I got out of our car to look at the Objects. The Objects then started moving away from us. The Objects look like stars when they go back up in the sky only brighter. When the Objects were on top of the trees they looked like a big balloon all lighted up. People have told me they have seen the Objects landing in the south and the east from here.

And dont write me.

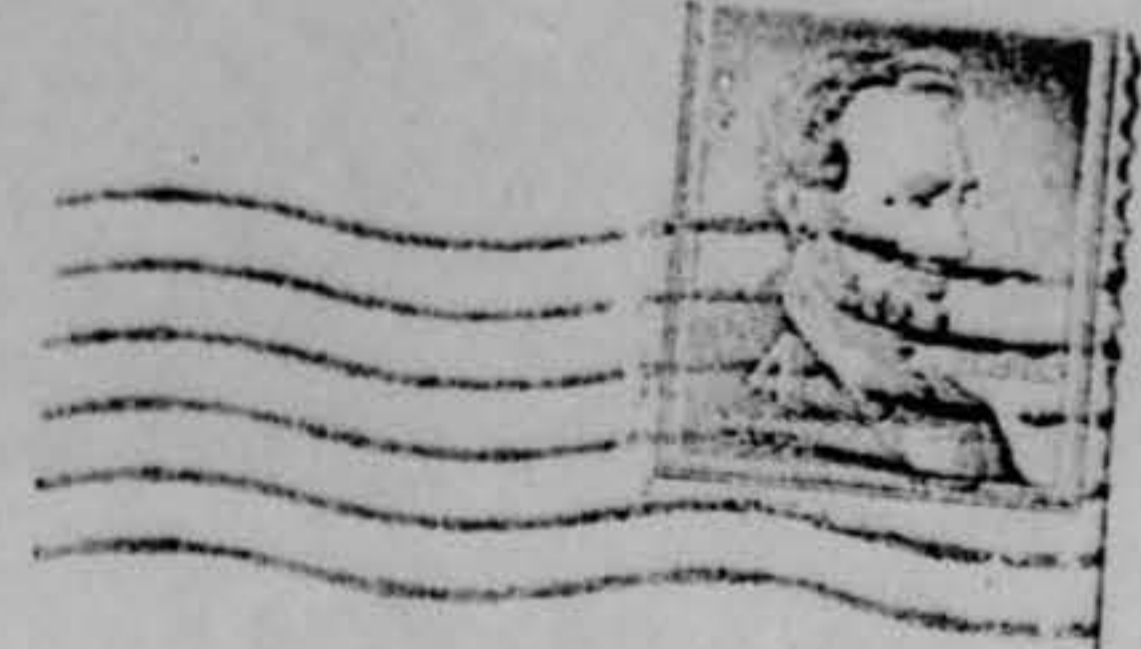
Because I dont want my
