Contact with Sgt. Jackmon, Westover AFB (ext 2316) provided the following additional information. Loring AFB, Maine was using the low level training route Clever Chap shortly before the observation. Aircraft from Loring AFB made 4 releases at 2230, 2300, 2330, and 0000Z. They should be completely out of the area approximately 30 minutes later. There were also high flying aircraft in the area at 0045Z, but Sgt. Jackmon did not feel that they could have been easily observed. He did not think that the policeman could have seen the aircraft that had a bomb release at 0000Z unless the time of observation was about 2350Z.
