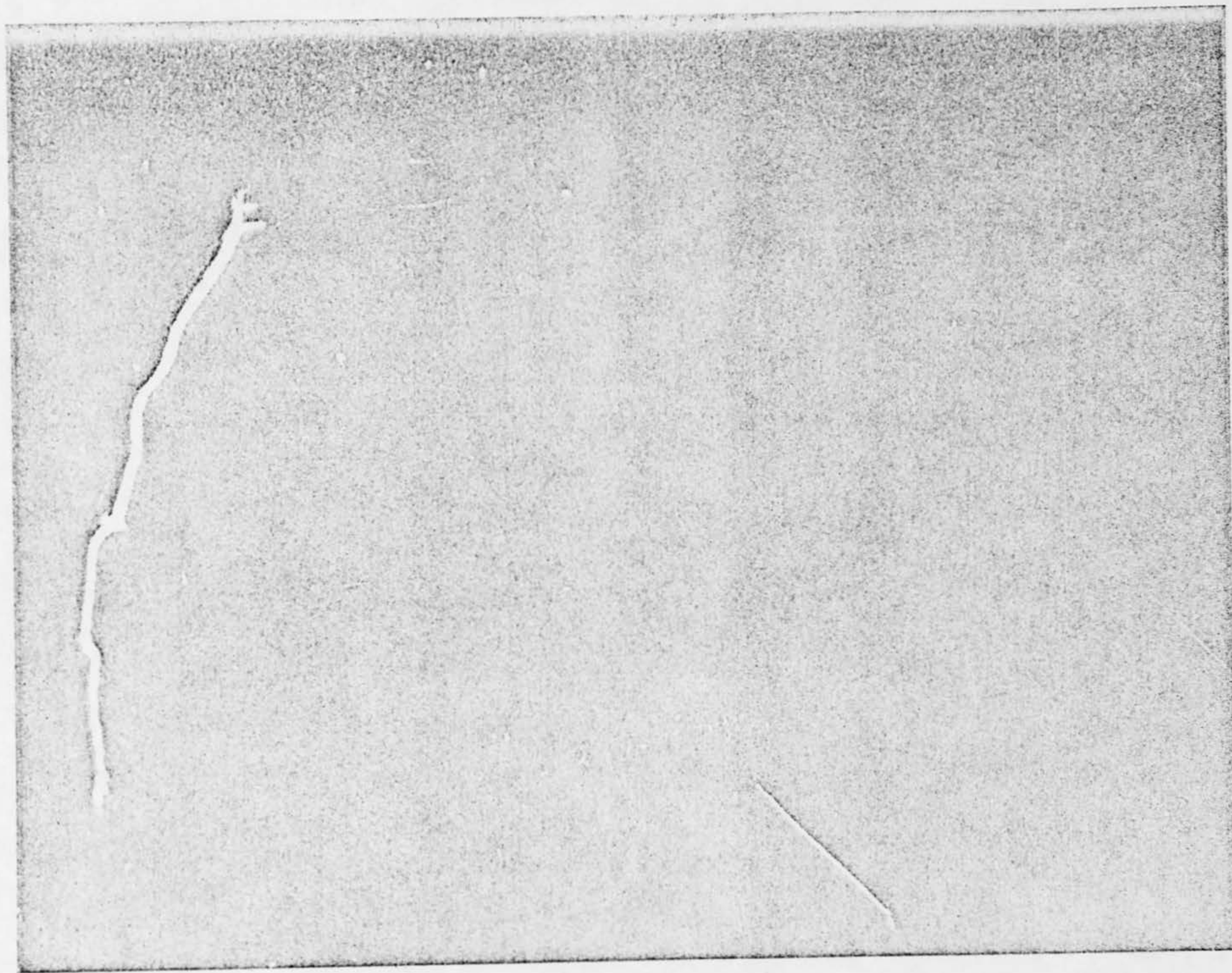


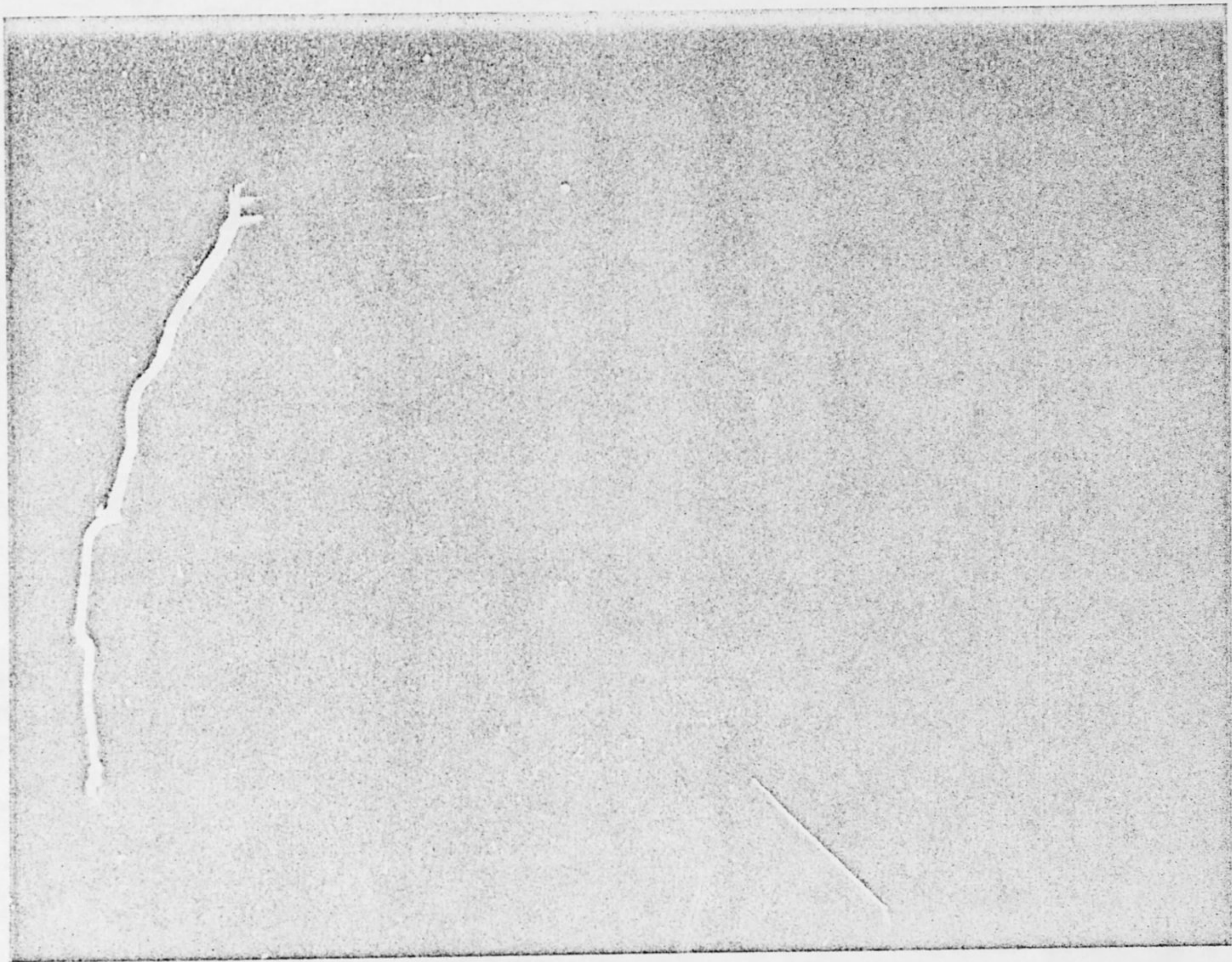

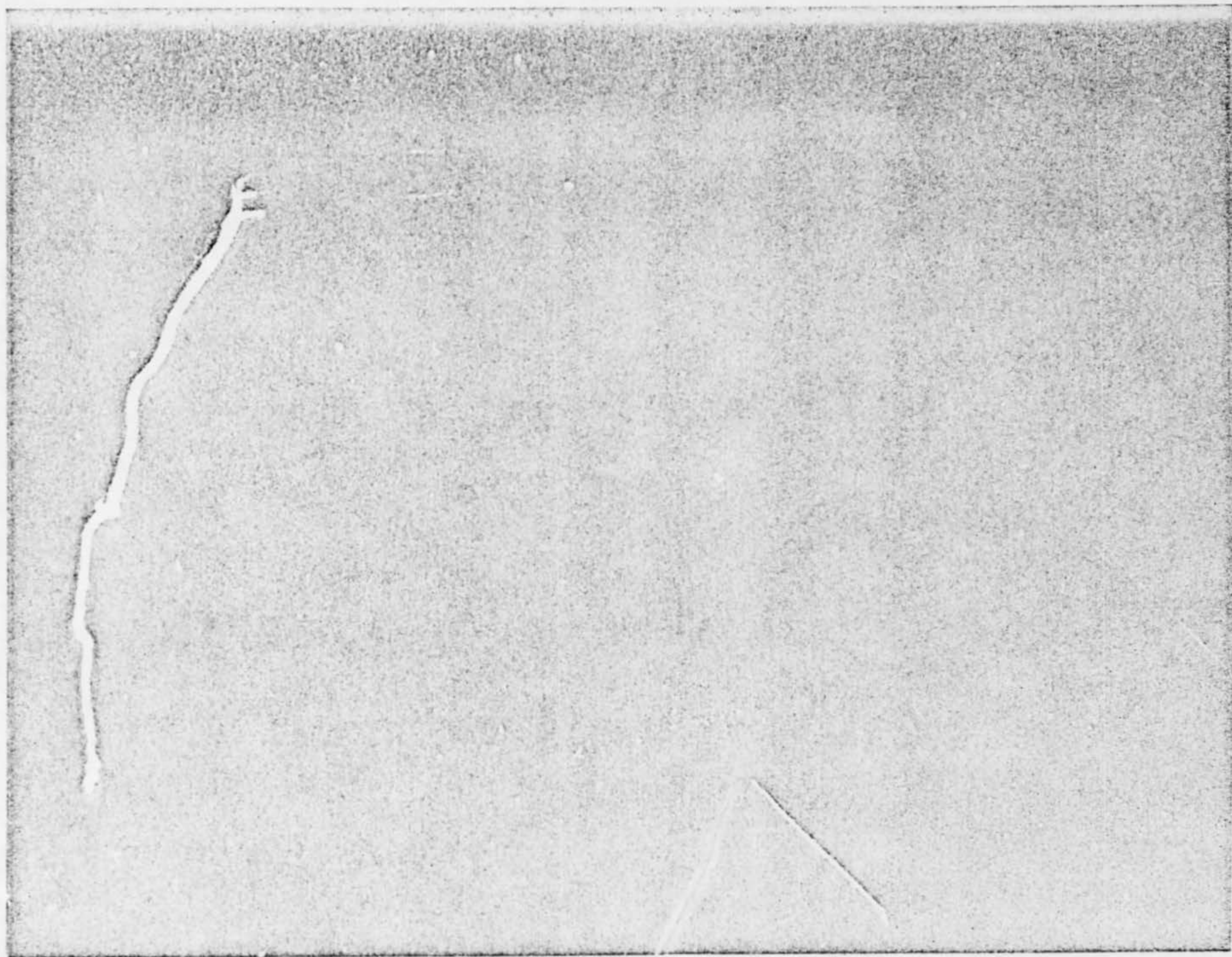

OBJECT: OBSERVER FIRST NOTICED THE OBJECT WHILE DRIVING HIS AUTOMOBILE APPROXIMATELY ONE CITY BLOCK TOWARD HIS HOME. THE OBJECT FIRST APPEARED TO BE A LIGHT SUSPENDED IN THE SKY. ANGLE OF ELEVATION WAS APPROXIMATELY 15 DEGREES ABOVE HORIZON ON A MAGNETIC BEARING OF 090 DEGREES FROM OBSERVER'S POSITION. THE OBJECT GRADUALLY ASCENDED TO APPROXIMATELY 30 DEGREES ABOVE THE HORIZON AND DRIFTED IN A SOUTHERLY DIRECTION. OBSERVATION OF THE OBJECT TERMINATED WHEN IT BURST INTO FLAME AND BURNING PARTICLES DROPPED TOWARD THE GROUND. THE OBSERVER STATES THAT THE OBJECT WAS DRIFTING WITH THE AIR CURRENTS AND THAT POWERED FLIGHT OR MANEUVERS DID NOT OCCUR. THE OBJECT WAS VISIBLE FOR THREE TO FIVE MINUTES BEFORE IT BURNED AND DISAPPEARED. DURING THE SIGHTING, THE OBSERVER SET A CAMERA ON TIME EXPOSURE ON A LOCKED TRIPOD AND PHOTOGRAPHED THE OBJECT UNTIL TERMINATION OF FLIGHT. OBSERVER IS A PROFESSIONAL NEWSPAPER PHOTOGRAPHER. THE OBSERVER AND A FRIEND ALSO OBSERVED THE OBJECT THROUGH SIX POWER AND EIGHT POWER BINOCULARS. TIME AND DATE: 1950L, 9 APRIL - 0250 GMT, 10 APRIL. LIGHT CONDITIONS: DUSK. RELIABLE. WEATHER CONDITIONS: SKY CONDITIONS CLEAR, VISIBILITY 15 MILES PLUS, TEMPERATURE 68 DEGREES F, SURFACE WIND 090, 5 KNOTS, WINDS AT 3,000 FEET MSL 300 DEGREES, 8 KNOTS, NO THUNDERSTORMS IN AREA. PHOTOGRAPHIC EVIDENCE: STILL PHOTOGRAPH TIME EXPOSURE OF OBJECTS FLIGHT PATH TO TERMINAL POINT. CAMERA TYPE: BRONICA, 250MM LENS, TIME EXPOSURE ON LOCKED TRIPOD, LENS OPENING F11, EASTMAN TRI-X FILM, NO FILTERS USED, CAMERA POINTING 090 DEGREES MAGNETIC.  
INVESTIGATING OFFICER'S COMMENTS: I BELIEVE MR. [REDACTED] TO BE A RELIABLE AND TRUTHFUL OBSERVER. FROM HIS ACCOUNT OF THE OBSERVATION AND THE PHOTOGRAPHIC EVIDENCE WHICH WAS DEVELOPED AND PRINTED IN MY PRESENCE, IT IS OBVIOUS THAT THE OBJECT SIGHTED WAS A PLASTIC SACK SUSTAINED BY HEATED AIR. THIS TYPE ACTIVITY HAS BEEN NOTED IN THIS AREA IN PAST MONTHS AND IS A FAD WITH CHILDREN. THE CHILDREN HAVE BEEN MAKING HOT AIR BALLOONS WITH CANDLES AND PLASTIC SACKS OBTAINED FROM DRY-CLEANING ESTABLISH-

MENTS. THEY SEAL THE TOP OF THE SACK AND FIX A BASE (NORMALLY OF CARDBOARD) FOR HOLDING CANDLES. THE BURNING CANDLES PROVIDE HEATED AIR WITHIN THE SACK AND IS SUFFICIENT TO SUSTAIN THE SACK AND CAUSE IT TO ASCEND. THE CANDLES BURN DOWN AND EVENTUALLY SET FIRE TO THE CARDBOARD BASE, THUS MELTING THE PLASTIC SACK.

THE TIME EXPOSURE PHOTOGRAPH TAKEN BY MR. ~~XXXX~~ IS CLASSIC EVIDENCE OF THIS TYPE ACTIVITY. THE TERMINATION PHASE AND BURNING PARTICLES FALLING EARTHWARD IS EASILY DISCERNIBLE IN THE PHOTOGRAPH. THE FIRE HAZARD TO DRY CROPS IN THE AREA IS SELF-EVIDENT.


