Dear Sirs of Bullock,

On March 30, 1968 between 7:10 & 8:45 P.M.  
I was watching a strange light that grew & grew  
brighter until it was disc shaped and a random  
color. At first I thought it was the moon shining  
through the clouds and thought nothing of it until  
a second ~~disappeared~~ and smaller one appeared  
lower and to the right. I realized that one was growing  
brighter, the first one was fading to a pale blue  
against the dark, night sky. I rushed home to get my  
camera and bulbs. When I got outside again my  
friends said another very small one appeared lower  
and to the left. The second one faded to a pale blue  
while the third one turned brown and disappeared  
while the other two kept fading. I took 3 pictures.  
One without the flash, all and two with the flash.  
Don not see at the time whether the they came out or  
not.

At 8:45 P.M. the U.F.O.'s finally packed completely away. The second one packed away before the first one packed away.

The whole thing happened in the Southwestern part of our office in Montezuma. Thank you.
