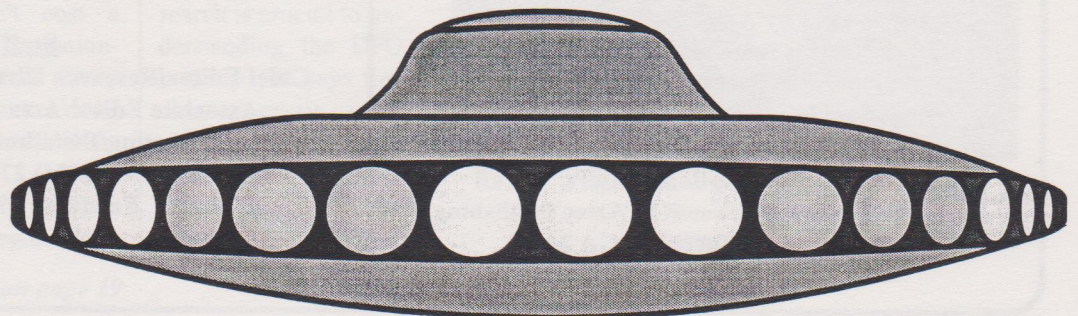
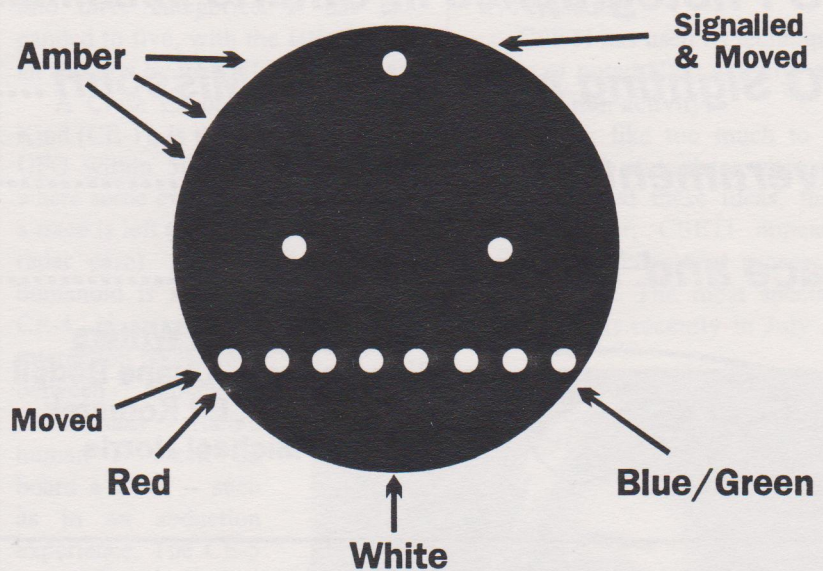

Light arrangement as seen. Shape estimated.

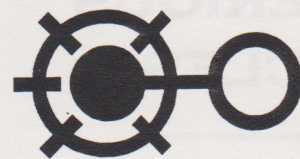

From the Editor:

During the past month, I have been searching for new avenues for gathering information and communicating with investigators. My idea was, to find a way to communicate inexpensively and easily.

This eventually led me to look at the computer bulletin board services that are presently available. I found that there are many, and some are even devoted to subjects such as the UFO phenomenon. However, most all these boards are located in one city, which means hefty long distance charges. Also, most of them limit your access time (usually 30 minutes) and only allow you to log on once a day. In addition, for the person who knows nothing about computers, the communication world using a modem can be very confusing -- ansi, baud rate, data bits, stop bits, parity, init string, Xon/Xoff flow control, local echo etc.

There is one bulletin board service that bypasses all of this confusion and doesn't cost a fortune to use. That service is the Prodigy Interactive Personal Service, or known simply as Prodigy.

First, what I like about Prodigy is its simplicity in use. It is a graphical environment, which means it's not just text on the screen. Secondly, Prodigy is very simple to set up, especially for the new computer user. One doesn't have to worry about the many parameters I just mentioned above. Thirdly, it doesn't cost a fortune to use Prodigy. The nationwide network has stations in every major city -- which eliminates long distance phone charges. The service is only \$15 a month.

The best feature is the private electronic mail. Since I began using

Close Encounters of the Fifth Kind

Steven M. Greer, M.D., is the International Director for CSETI -- the Center for the Study of Extraterrestrial Intelligence. Greer is also responsible for the creation of the CE-5 initiative, which is the organized attempt to initiate contact with UFOs and their occupants. Also known as a Close Encounter of the Fifth Kind, Greer hopes that this will become a research category.

"Close Encounters" is a phrase that originated from the late Dr. J. Allen Hynek. Broken down initially into three categories, it has expanded to five, with the latest being an addition by the CSETI group.

A Close Encounter of the First Kind (CE-1), is the observation of a UFO within 500 feet. A CE-2, is where some evidence is acquired or a trace is left (i.e. a landing site or a radar case). A CE-3, is when a humanoid is seen near a UFO. A CE-4, is an experience where an interaction takes place between humanoids and humans -- when a human is taken on board a UFO -- such as in an abduction experience. The CE-5 was defined earlier.

Greer feels strongly that real-time research is crucial to understanding the UFO mystery. He says that almost every other area of science requires real-time research, and so must UFOlogy. To do this,

Greer and CSETI have designed methods for attempting to "vector in a spacecraft," and then to communicate with the craft and its occupants.

Not only does Greer wish to communicate with these craft, he is continuously training people to be prepared to board a UFO that is "vectored in."

These individuals, called "working groups," use powerful lights, lasers, sound technology, and what CSETI calls "sequenced coherent thought projection to engage UFOs and/or their occupants in an interactive episode."

CSETI has used its techniques in areas of noted UFO activity, and in areas of non-activity.

Sounds like too much to swallow? Many ufologists, when Greer first proposed these ideas, thought so. However, CSETI appears to have had phenomenal success with their efforts. The most spectacular of these was recently in July 1992,

in southern England.

The following information is from a recent report prepared by Steven Greer, M.D., titled, "Close Encounters of the 5th Kind: Contact in southern England."

Crop Circles and Extraterrestrial Intelligence

On January 8, 1993, the popular TV show *Sightings* did a story about Greer's most successful attempt. But, the show only touched on the highlights of the whole event.

After conversing with crop circle researchers -- including Colin Andrews, Greer felt that crop circles are the result of an extraterrestrial intelligence interacting with our planet. He believes this because researchers are relating episodes where "there appears to be clear interaction between humans and the crop circle makers, whoever they may be."

Because of this belief, Greer could think of no better place to attempt a CE-5 than southern England, where the majority of crop circles have appeared over the past few years.

An interesting note about the southern England crop circles is they have appeared only two to three hundred miles due west of Belgium, where there was a large wave of UFO activity in the late 80's. This was the same time that southern England experienced a growth in both the number and complexity of crop circles. Both areas are just north of the 50th parallel, "and in the vicinity of the

alarmingly large ozone hole over Europe."

Greer says that no one is talking about the possible connection of the events in these two areas, even though millions of people around the world were witnesses to them via the media.

The crop circles in southern England, Greer believes, are evidence "of an extraordinary nonhuman involvement with the planet which has been asking for some type of response. It is our opinion that mere scientific measurements of the circles and the passive observation of the night sky are inadequate." And so, with these motivations in mind, the southern England CE-5 initiative was born.

After several discussions, it was decided that a team of CSETI working group members would conduct an initial research project from July 20th through July 30th. The team included Steven Greer, Shari Adamiak, Ron Russell -- a P.h.D. psychologist from Cincinnati, Maria Ward, and Peter Russell of London. Polly and Tim Carson allowed the use of their 1800 acre farm in Alton Barnes, England, to be used by the research team.

The CSETI team expressed that they could not have foreseen the events that were to follow after arriving at the research site. Greer writes in his report: "I believe it can be stated without exaggeration, that the lives of everyone involved was changed forever by what they saw, what they felt, and what they collectively experienced."

On the first night of the operation (July 21st), the team gathered at Woodborough Hill on the Carson farm. Although only Colin Andrews and Greer knew the precise location of the site, that night the team was met by some 30 people who were not members

of CSETI. They appeared from everywhere -- up through the fields, through the woods, literally from all directions. The people arrived, "as if expecting something."

Since these people were not part of the project, Greer decided to give them all a brief discussion of the purpose of the team. As he was showing and discussing the equipment the team was using, an unusual incident happened.

While Greer was showing the crowd an automobile radar detector, which he had hooked to a portable battery, the device went off on three separate occasions whenever he would hit a "key point." What that meant, or why that happened, Greer doesn't know, but he mentioned it because of the strangeness.

On that night, the team did a brief "coherent thought sequence" as an orientation project. This involved visualizing a double-ended crystal that was given to Greer by a Dorothy and Burl Ives. Reportedly, at East Meon the next day, the most complex crop circle of the year (up till that date) appeared which looked similar in configuration and shape to what they were visualizing. This was only the beginning.

The next night, the team gathered around 9:30 p.m. While performing their coherent sequencing process, a metallic noise was heard emanating from behind the group, yet nothing was seen.

During the evening, the team decided to concentrate on a specific

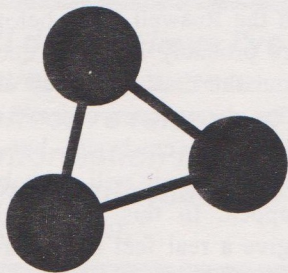
shape, and they painted that object in the sky using a high-powered light. They hoped the "crop circle makers" would receive this and possibly the result might be a crop circle CE-5. The pattern was of three circles joined by an equilateral triangle.

As the team was in this process, a large group on Woodborough Hill saw a faint, sparkling ball of light in a field below the team's location, near Milk Hill. Because of the oncoming darkness of evening, it was difficult to determine the exact location of the object. The described movement and scintillation of it was very similar to that of the unusual disk-shaped object videotaped in crop circle fields in 1990 and 1991.

Another sighting that evening, although minor, was a bright ball of orange light seen around 1:45a.m. The ball appeared in the southeastern horizon and remained still for about three minutes. No sound was heard, and no smoke trail was seen. When the light disappeared, a white object was spotted darting along the edge of a cloud. All this was still a small prelude to the events to follow.

On July 23rd, during the day, Maria Ward and Edward Sherwood reported hearing a trilling sound near the Towsmead Copse, located directly below Woodborough Hill. The sound was similar to others heard near crop circles in the last few years.

Late that night, around 12:45 a.m., a large amber and orange colored ball of light was seen spinning in the northwestern



horizon. This had been the largest object seen. It remained fixed in the sky for about five minutes. The object was videotaped by Gregg Pressley, an individual working with Colin Andrews.

Other individuals nearby, said they saw, through their night-scope binoculars, a military helicopter approaching the object. After the chopper appeared, the object moved away quickly to the north until witnesses lost sight of it.

Almost simultaneously, a red object emerged traveling above the northern edge of Woodborough Hill. It then split into two parts before disappearing.

Greer and individuals on top of Woodborough Hill said they saw a silvery white object that moved from the northwest to the zenith of the sky. This object was spotted right after the bright amber ball of light had disappeared. The objects, Greer states, "were definitely not aircraft, nor were they known natural phenomena such as meteorite or lightning activity."

On the 24th, Greer and the investigative team decided to look at some fresh crop circles that had appeared. They noticed that none of the stalks were broken. The plants looked as if they were carefully bent. Not until a stalk was picked up, did Greer realize just how fragile they were. One stalk broke in three places while just being held and carried to another field.

When evening came, the team decided to move the operation to one of two crop circle formations that were next to each other. One formation was a large ring and the other was a large circle.

That night, the group had problems with intruders entering the farm. The local police were called to remove trespassers who got too close to the area where the team was located.

Individuals nearby said they saw, through their night-scope binoculars, a military helicopter approaching the object. After the chopper appeared, the object moved away quickly to the north.

Multiple flashing, white and yellow lights, were noticed once the team had moved into the crop circles themselves. The flashes appeared from all directions surrounding the group, and looked like brilliant discharges of camera flash bulbs.

A Spectacular Sighting

Around 10:25 p.m., as the team was looking slightly southeast, a magnificent sight came into view -- "a structured, spinning spacecraft," describes Greer. "You could clearly see, in the dimming blue light of the sky, a spinning structure with blue-green, red and white lights, that were spinning around its periphery. This object traversed 20 to 30 degrees of arc in the sky, and lasted for only about five to ten seconds. As it moved across the sky, it was also spinning in a counterclockwise rotation. . . . It was at this point that I was convinced that we had a 'lock on' with a structured spacecraft of non-terrestrial origin."

Greer emphasized that the craft was in clear view, and its metallic structure could be seen. He says the craft traveled silently, and was too fast to be a conventional aircraft.

Two cameras brought along by Ron Russell would not operate while the team was in the crop circles. The malfunctions were observed by everyone present. The next day, the cameras worked fine.

CRASH AT CORONA

Authors Stanton T. Friedman and Don Berliner

Paragon House 1992

With more on the UFO crash at Roswell comes the much awaited *Crash at Corona*, which arrived at bookstores in July 1992.

Nuclear physicist Stanton Friedman and aviation writer Don Berliner have come together to compile the events and information that have become the "Mother of all UFO cases." Written in a neat chronological order and style, the book is excellent. However, it provides no new revelations.

As with many books on the UFO subject, *Crash at Corona* begins with a history of modern sightings in chapter one. Although somewhat dry for a longtime follower of UFOs, the first chapter is informative for a newcomer to the subject.

In the following chapter, the reader learns how the search for evidence began with Stanton Friedman finding "a man who was a major in the Army Air Force and handled the wreckage of one of those things."

Since the testimony of Jesse Marcel in 1978, the investigation has snowballed into the discovery and the following interviews of five hundred first-, second-, and third-hand witnesses to this event. One cannot read this book, nor any other on the Roswell incident without concluding that *something* crashed in the New Mexican desert.

Chapters three and four cover the history of the government's involvement with UFOs, citing government investigations and projects to find the truth behind them.

Dr. Robert Sarbacher's report fills chapter five, and chapter six is a discussion on the history and plausibility of MJ-12 (Majestic 12).

In chapter seven, we reach the meat of the subject -- the discovery of the wreckage by Mac Brazel and the events that followed. I felt this was the strongest part of the book. The authors included word-for-word testimony of witnesses. In the past, I've read nearly all of the literature available on this case, but I discovered that most of the in-depth testimony had never been published.

Chapters eight and nine

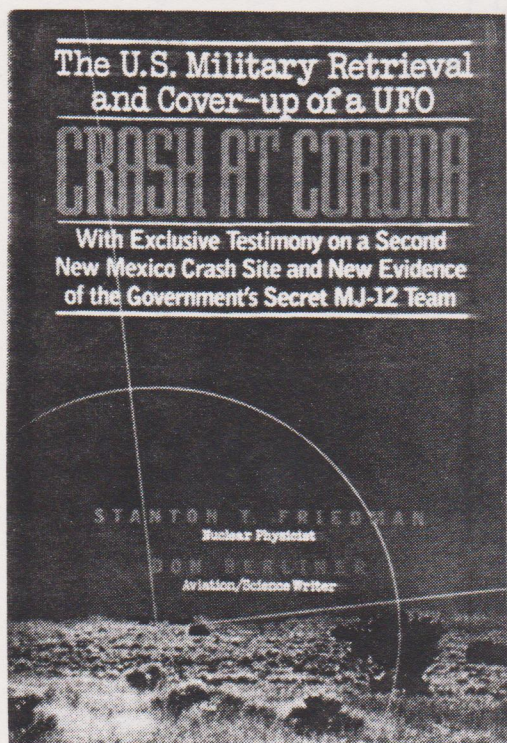
include the testimonies of Jesse Marcel, Bill Rickett, the controversial Gerald Anderson, and the most fascinating of all, that of former mortician Glenn Dennis. As Dennis unfolds the events that occurred at the base infirmary, you feel as if you are there reliving an incredible incident that took place forty-five years ago. In my mind, Dennis' testimony is the strongest spoken evidence that biological entities were indeed taken from a type of escape pod and examined by doctors.

Since the testimony of Jesse Marcel in 1978, the investigation has snowballed into the discovery and the following interviews of five hundred first-, second-, and third-hand witnesses to this event.

The UFO crash in New Mexico launched the U.S. government on a long term, elaborate and highly-sophisticated campaign of concealment and disinformation that extends to today. As readers enter chapters ten through thirteen, the book goes into the cover-up of the events at Corona. While reading what the government did, it leaves one in a turmoil of not knowing whether to laugh or cry.

The Crash Site Today is the title of chapter 14. I was glad the authors went to the trouble to include this information. If anyone has read books on the Roswell crash before, they were probably left with questions about the crash site then and now. It has always been a desire of mine to visit the crash site, but as with many of us, it will probably never happen. In this section the authors give a real feel of the area that may have been the landing site

Those Mysterious Circles

Colin Andrews and the Crop Circle Enigma

Last month's U.E. revisited Budd Hopkins -- as part of a report on the Atlanta Discovery Expo held last October in Atlanta. This month, U.E. brings Colin Andrews, another notable speaker from the expo.

Crop Circle Researcher, Colin Andrews

Colin Andrews became interested in crop circles ten years ago. The interest began with his first sighting of a crop circle. As he was driving to work in southern England, he saw five mysterious circles forming a Celtic cross in a field.

At the time, Andrews worked for the local government and was an electrical engineer by profession. Ten years later, after "putting up with quite a lot of flack," he is one of approximately seventy scientists and engineers in the world actively studying this phenomenon. Andrews claims that only about half a dozen people study crop circles full time.

Right from the beginning, investigators recognized that the phenomenon was not a random event. Andrews said it arrived in locations that are very well known. Since the launch of his book *Circu-*

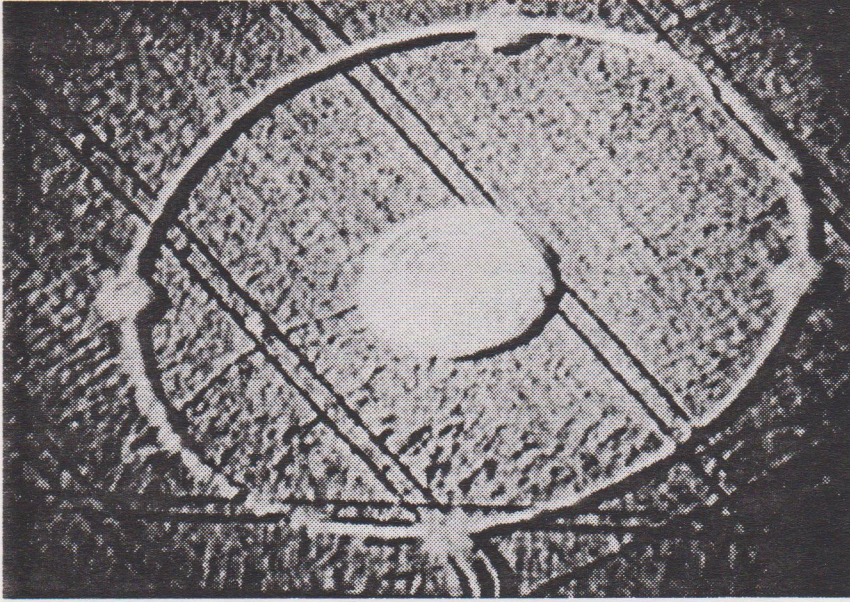
lar Evidence in 1988, Andrews and others have published many of the primary crop circle sites.

Expressing his deep passion for solving this intriguing mystery, Andrews said, "I resigned from my high salary government position back in England, because I am determined to convey this information to the public."

Andrews explained that crop circles are not exactly recent phenomena. He showed a letter he received from a farmer who lives in an area where crop circles have appeared for many years. In fact, this farmer wrote that he discovered crop circles in the same fields back in the early 1920's. This shows that the phenomenon doesn't appear in random areas, but in the same sites over and over again -- and, has been around for a long time.

Unfortunately, "hoaxing is now a major problem." So many people, thanks to the major media, believed the Doug and Dave scam -- to the point that with most people, it has resolved in their minds the question of where the circles came from. "It has put the subject to rest with most of the public worldwide. I don't believe I've ever seen a more effective release of information through the media-machine than that," Andrews said. The response he gets from people as he travels around the world is: "It was just a hoax, wasn't it?" Because of the ever increasing hoax problem, pre 1988 is proving to be very important. That was the period before the dreadful hoax situation existed.

In one crop circle (see photo next page), the plants in the outer ring of the formation were found laid in complex directions. The

famous Doug and Dave, who announced to the world that they hoaxed most of the crop circles in southern England, claimed to have also created this circle, until Andrews asked them one specific question.

Sketching the outer ring of the layout, and the direction in which the plants had laid, Andrews asked, while pointing to his drawing: "If you constructed this, how did you construct that [the outer ring]."

The two hoaxers stood in "dead silence." After about six to seven seconds, they looked at each other as if searching for an explanation, and immediately withdrew saying, "We didn't make that one." On that question alone, Andrews told the audience, "we can forget Doug and Dave."

That's not the only time Doug and Dave have backed away from Andrews. Central Television in England asked Andrews if he would participate in a live debate with the controversial duo. Andrews agreed, and arrangements were made -- except the network failed to mention

to Doug and Dave who they were going to debate. About twenty minutes before the show was to air, Doug and Dave learned who was to be their opponent. They then both withdrew from the scheduled show. This threw the network into a panic and they scrapped the whole program, forcing Andrews to withdraw as well. The show was obviously set up for

the two hoaxers.

Andrews gave more food for thought for those who believe the hoax theory. "These formations," he explained, "are appearing in locations that cannot be seen. That gives us good information. Who in the hell would want to hoax a formation one-sixth of a mile long in a location that cannot be seen or appreciated by the public? No hoaxer is going to do it. The energy required would be a total waste of effort."

To show that he has considered meteorological disturbances as a possible answer, Andrews explained that when the phenomenon began with simple circular formations, he spent three years working with Dr. Terence Meaden, who is the head of a tornado and research organization in Great Britain.

Dr. Meaden is an electrical engineer, a physicist, "and knows his meteorology inside out." Publicly, Dr. Meaden says to this day that there is no longer a mystery -- that the phenomenon is a meteorological one. The patterns he says, are caused/constructed by stationary whirlwinds.

This explanation also agrees nicely with the view of the British government. Andrews says that after

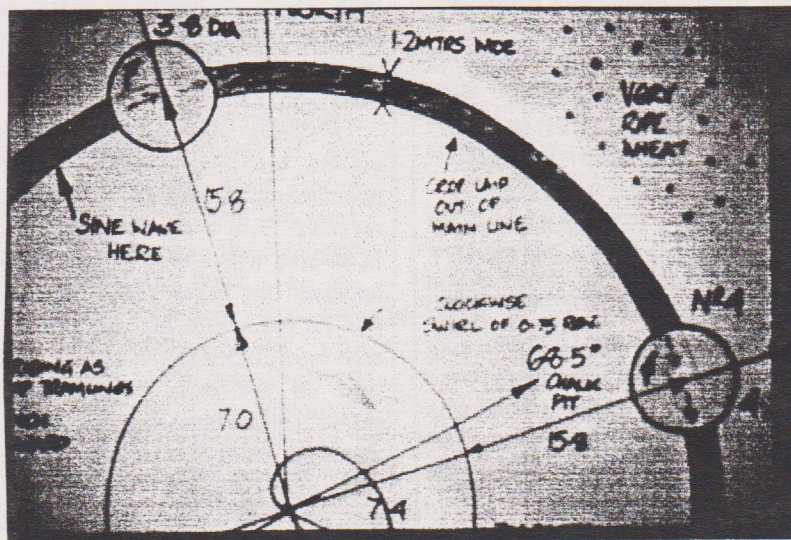


Diagram showing the complexity of the crop circle shown above.

he supplied three technical reports to the Thatcher government, the Chief Scientific Advisor informed the British parliament that indeed there is no mystery. The circles are formed by stationary whirlwinds -- exactly what Dr. Meaden had said.

What they have overlooked, Andrews says, "is the fact that most of the crop circles appear at night, and the thermally produced whirlwinds in southern England form only by day." Whirlwinds also rotate in only one direction. Half of the crop circle formations found are rotated in the wrong direction to be a stationary whirlwind effect.

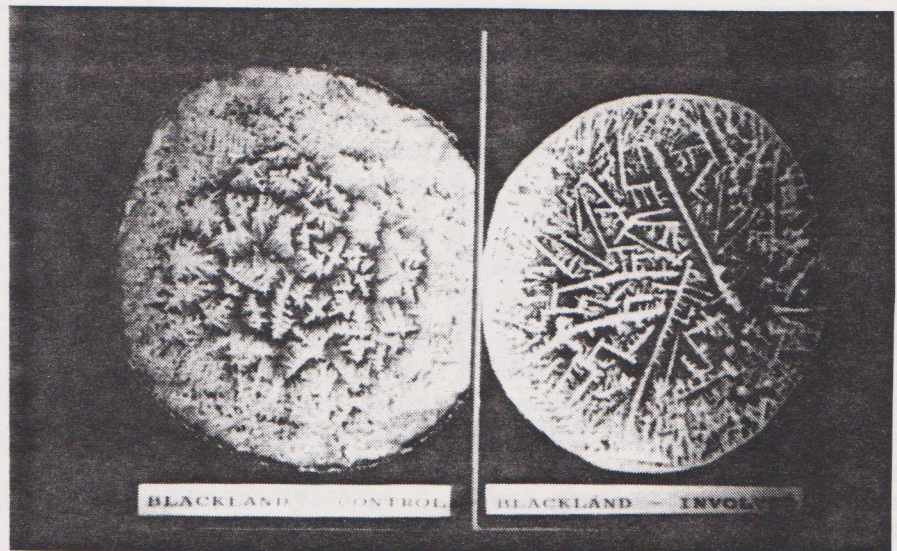
Andrews told that "many of these markings are counter-rotated in such a fashion that they don't even comply with the law of angular momentum -- a basic law of physics that they [crop circles] must comply with to be produced by stationary whirlwinds."

Furthermore, the skeptics don't include the fact that with the more complex patterns people have witnessed, many formations could not possibly have been created, for obvious reasons, by a meteorological event.

These crop circles are precise, Andrews stated. They are cut out as if a cosmic finger has carved them out of butter from above. The edges are so well defined; one hundred percent of the plants inside the circle are flat to the ground, while their neighbors, three millimeters away around the perimeter, are bolt upright, totally unaffected. None of these beautiful patterns are the results of stationary whirlwinds.

Changes in the Plants

Another argument that Andrews uses to battle skepticism, is the evidence of changes in plants found inside crop circles. Plant samples, taken from a field where a circle formation had appeared, were sent

to a laboratory owned by Rosemary and Kenneth Spelman in England.

A special process was performed, first on plant samples taken from inside the crop circle, then on plants taken from outside the crop circle. The results were astounding (see above).

Photographs were taken, through a microscope, of crystals from the plants created from a unique distillation process. The two different samples showed dramatic differences in their energy patterns, evidence that no hoaxer could produce, nor any whirlwind create!

"There was an effect here which could not be replicated by human feet, ropes, chains, and all the rubbish you have been reading about," Andrews explained. "The samples should look the same, but they don't." The test was performed nine times, and every time there was a dramatic pattern change.

A Michigan laboratory, to which plant samples from three continents were sent, has discovered major changes in the cell

structures of the plants.

In recent months, Andrews explained, the laboratory has found a rare condition in the plants taken from crop circles. "The plants, instead of producing -- from a single grain of wheat for example -- a single embryo, multiple embryos are now growing. So there is something very unusual occurring here."

Because of these changes, which he says are the result of exposure to some form of high energy, Andrews recommended on television that the crops from these circles be kept out of the food chain. However, he said, researchers later found that plants growing in crop circles have much more vitality and look and grow much healthier. Andrews joked that since that discovery, he has been

eating the grains from these circles ever since -- and is still here.

A point that weakens the hoax theory even further is the discovery of crop circles in areas where the public is not allowed. A large military firing range in Europe has had circles appearing in secure areas that are completely cut off from the public.

During a flight that Andrews made around this restricted area, he witnessed many crop circles that were within the secure zone. After landing, he turned to Busty Taylor who had flown with him and said, "If it's the last thing I do, we are going to have this matter raised at a very high level."

Shortly afterwards, Andrews had a discussion with a member of parliament -- whom he took to a crop circle site. The discussion led to the introduction of the matter into his country's House of Parliament.

Andrews was also able to verify with senior military personnel that the formations at the firing range actually existed in the secured areas. This, Andrews claimed, "pretty well eliminates the human element."

Crop Circles and UFOs

In 1982, an engineer walking his dog in southern England, saw a cylinder shaped object -- seen in the horizontal position, not in the vertical -- that came over into a wheat field in front of him. The man was looking down a hill and stood in awe as the object pivoted once. Underneath the object, he could see the cereal crop oscillating -- like the

opening of a woman's fan, the man described -- and there a crop circle formed.

Since that sighting, and even before, cylinder-shaped holes have appeared near Geneva, Switzerland, Andrews reported. Where these holes appear, there is not a crumb of anything in the surrounding area. Also, not a mark has been seen in the bordering soil. "It's a core that has simply been taken away. There have been over a dozen of them," explained Andrews.

In 1985, while examining a circle formation, Andrews discovered at the site a small amount of a strange substance that he had never seen before. It was a translucent jelly that changed color by the hour and was shaped like a candy bar. Even to this day, after having the substance analyzed by various laboratories, no one can identify the arcane material.

On one occasion, as Andrews was flying over Stonehenge -- an area where many crop circles have been found -- it dawned on him that perhaps many, if not all of the crop circles they were studying, fit in somehow geometrically with the layout of the ancient formation of giant stones. What has amazed Andrews after studying the floor-plan of Stonehenge, is that many similarities and relationships appear to exist between Stonehenge and the patterns of crop circles. What this means is something that Andrews is still pondering.

According to Andrews, the scientific community is very nervous about this whole phenomenon. A major problem, he says, is individuals in science worrying about their credibility if they become involved with the research.

Many scientists have worked in private with Andrews, and always

told him not to mention their names or their universities. Occasionally, when Andrews would slip and mention a name in a lecture or a radio interview, researchers would lose that contact. Recently though, the scientific community "has been on the move" to help in research, which is encouraging.

Film Crews are Startled

NTV of Japan, was filming in southern England when during an interview, the cameraman looked in the sky and saw a cylinder-shaped object. The cameraman then filmed the strange sight. "It's a beautiful, perfect cylinder rotating -- obviously rotating. You could see it spinning in the sky, stationary above the field," Andrews described. Unfortunately, Andrews was not equipped to show the video during his presentation.

A director for BBC was filming Andrews and Pat Delgado inside a crop circle in 1989 when an extraordinary sound, which has been heard occasionally, suddenly began during filming. They recorded the bizarre noise, but somehow the sound mysteriously destroyed \$65,000 in hi-tech television equipment. This incident convinced BBC that something weird was undoubtedly going on. Andrews said, "These were hard-nosed journalists, one of the many television crews that had arrived from around the world in southern England, filming all that was going on there. All of them [journalists] that had arrived thought it was just one of those rubbish UFO type stories. They think they know it

all and they've seen it all. There were few who left with that attitude."

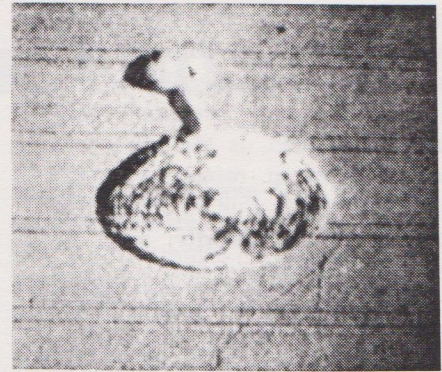
Field is surveilled

Andrews, during his lecture, told of a very interesting crop circle case. "It's a simple form, but this arrived in circumstances which once and for all, eliminated the word 'hoax' (see photo)." He explained that in 1991, two surveillance operations -- Operation Blue Hill, and Operation Chameleon -- were mounted on the sides of two hills that overlooked each other. The two operations were about 700 yards apart, and so were both in sight of one other.

One operation was monitoring with radar that had coverage of about 4 1/2 miles. They were also equipped with infrared cameras. The adjacent operation had infrared and low light cameras along with an intruder system set up by using infrared beams to secure the field from human interference. Dogs were even used during the operation.

In the early hours of the morning, a fog developed and covered the valley they were monitoring. While the fog hovered over the field, no wind or vortices were present. At 6:15 a.m., the fog began to melt away until all that was left was a single cell of fog in the center of the field. Around 6:30 a.m., the single cell of fog lifted, "and that [crop circle -- see photo] came out of the center of it," Andrews said. "For the first time we could positively say no man or woman entered that field."

Further discussions with scientists who entered the area that morning revealed that there was heavy dew accumulation in the field where the fresh crop circle appeared. "Nobody could possibly enter or leave that field without

leaving their footprints in such circumstances," Andrews explained.

A Meeting with United Nations' Delegates

Referring to a recent meeting between some twenty United Nations delegates and a group of ufologists, Andrews elaborated on a request from these ufologists to the U.N. to implement Decision GA 33/426, of December 18, 1978. This would establish an agency of the U.N. for undertaking, coordinating, and disseminating the results of research into unidentified flying objects and related phenomena. If put into operation, it could be a major step toward renewed official recognition of this legitimate and complex mystery.

New problems have developed that are making things difficult for researchers. Andrews explained, "The farming community, the police, and the systems of control are frankly at a loss to know which way to turn. The problem is, the research that has to go on to establish its reality is being denied simply because farmers have said, 'Enough is enough. We're not any longer having thousands of people trampling our fields and spoiling the crops.'"

Researchers are trying to overcome this, Andrews says, by becom-

ing actively involved in the farming unions. "Perhaps the answer will be from the sky, with surveillance."

"An alarming situation," Andrews explained, is the feeling of some prominent researchers, who have shared this with Andrews, that their personal security may be threatened because of their work. To those who think this sounds radical Andrews responded by saying, "Think about the profound implications of what is going on here. I do believe it is effectively tied in with the change in consciousness of humanity. It doesn't matter how much scientific work you put into it -- we have always felt, in our quiet moments, it's the signs that are

important -- the patterns -- we simply look at them to change our conscious thinking. Nature doesn't evolve like this. There is intelligence involved here. This phenomenon is for us all."

Andrews said that soon after the Expo, he was going to fly with others to Germany to address scientists from around the world who want to be updated on this phenomenon. Two hundred scientists, from the Commonwealth of Independent States, will be present.

A catalog of all the crop circle patterns will soon be available so that people can see the evolution of these mysterious formations.

Tissue samples were taken from the right ear (including its metal tag) and from the jaw/throat area. A smaller sample was taken from the left ear, which had been marked by a now absent plastic tag removable only by cutting the ear. This tag was recovered and included with the samples.

Mutilations in Marshfield, Missouri

On February 5, 1992, a ranch owner discovered two of his cows dead. One had apparently died instantly without a struggle, and had two patches of hide removed from its underbelly. The animal was found at the edge of a wooded area bordering the pasture. Its head was facing east.

Struggling dramatically, the other cow apparently crawled or dragged itself approximately 50 to 75 feet on its belly before dying. The path of the animal was over rocks, stumps and other obstacles common in a semi-wooded pasture area. The animal was not mutilated and was found facing downhill, leaning against a tree with its head to the east.

Autopsies were performed on both cows by a doctor from Marshfield. He did not discern any apparent cause of death or wounds other than the strips of missing hide. Both animals were pregnant (in the last trimester), and the fetuses were removed during the autopsies. The fetuses, both males, did not exhibit any unusual features and were intact.

During the autopsies, the doctor remarked that the wounds from which the hide was removed had been made with surgical precision, going through only the thickness of the hide and not beyond into the flesh. The edges of the wounds were discolored and smooth, reportedly with a somewhat rubbery consistency. The fore wound was oval shaped, approximately 1 and 1/2 inches wide by 4 inches long. The aft wound was triangular in shape and

Cattle Mutilations: A Midwest Report

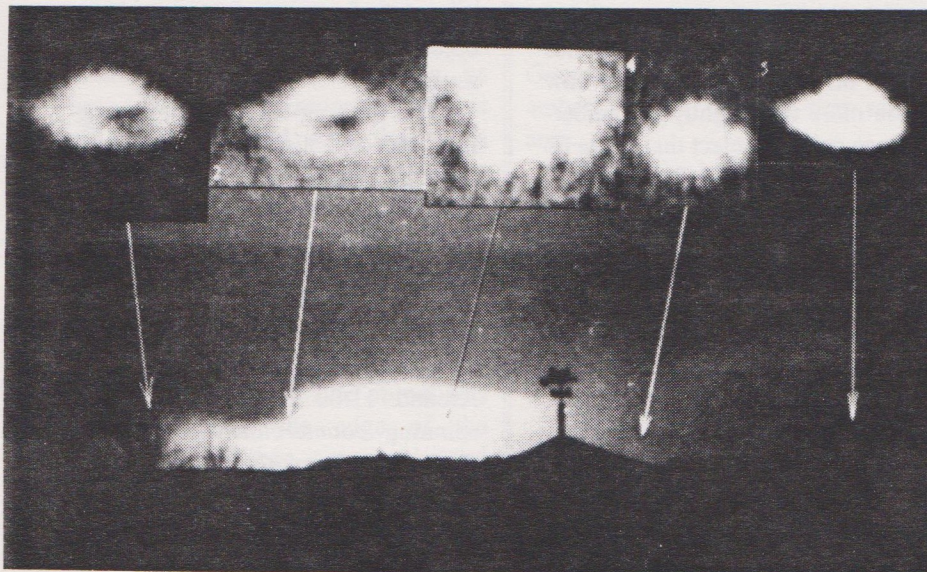
A dead and mutilated cow was discovered on February 4, 1992, by its owners in a pasture approximately a quarter mile from their home. The owners had observed the cow the day before in the same location, but they believed it was only asleep.

Upon inspection, they discovered the following: two of the teats were removed from the udder, the left jaw was stripped clean to the bone, an eight-inch strip of hide had been removed under the chin, the left ear was completely removed, the right ear was removed down to

the metal marking tag, the rectum was cored out, and the tongue was cut with the inside of the mouth appearing to have been burned black. Nothing suggested that a struggle had been involved in the animal's death.

An autopsy was performed by a doctor, who, in addition to the wounds and conditions noted above, found that the animal's spinal cord had been pulled approximately one foot up into the neck and skull, apparently with the vertebrae left intact and unaffected by the cord's position. "This is the spookiest thing I've ever seen," the doctor reportedly remarked. The cow was also in its first trimester of pregnancy. Its left foreleg had been pulled from the shoulder socket and was broken back underneath.

UFO photographed in Ontario

The above photo was submitted to *U.E.* by UFO photo analyst Jeff Sainio. It shows a series of five snapshots of a UFO taken in Ontario, Canada, on May 5, 1992.

The photographer of the UFO was with family and friends when the object was spotted traveling in the distant horizon. The first photo was taken through a wet pane of glass, and the other four were taken outside. It was about 9:00 p.m. when the photographs were shot.

The sunset can be seen in the distance. On the day that these photos were taken, there were thundershowers with heavy rain that extended into the evening.

Jeff figures, using estimated seconds between shots and the approximate distance of the object, that the UFO was traveling around 200 kilometers an hour. Jeff emphasizes though, that this is a very rough estimate.

The following is part of a report prepared by Jeff Sainio.

Photo Analysis by Jeff Sainio

Overall, these are a highly credible set of photographs. The UFO bears no resemblance to any terrestrial object I can think of. The clarity of the photos contraindicates that some earthly object is partially occluded, causing a misidentification. The possibility that the UFO being, say, some cone of light from a spotlight on a helicopter, is eliminated because this cone of light would not block skylight like a solid object. Multiple photos and witness testimony eliminate various mechanical or film defects from consideration. (The majority of submitted photos involve witnesses who saw nothing unusual.) Fakery is

doubtful, since home brew methods could not create these photos in any way I can think of. Sophisticated equipment and expertise, or incredible luck, would be required. Such touches as the branch in photo 1 are most useful in this regard, since a faker who managed to reproduce this feature, would be expected to brag about it.

Around 11:20 p.m., a spinning object amber in color and emitting a red and bluish hue was seen. This was proceeded by several lights that flashed through the sky in rapid succession.

AT 11:25 p.m., a UFO with a strobe on top was seen in the sky for five minutes. Witnesses say this object did not look like an airplane as seen through binoculars. Also, no sound was heard from the UFO. When the group agreed to signal to it, the UFO "became illuminated and emitted a much brighter gold and amber light with the strobes still flashing on top of it." The object circled the group, and then disappeared toward the south.

Over the span of the evening, Greer says, the team also saw four UFOs that appeared from different areas, but traveled in the same

direction.

Around 12:05 a.m., three amber-orange colored balls of light were seen moving rapidly over the Towsmead Copse. Those who were inside the crop circles heard no noise. Yet, Edward Sherwood, who was near the edge of the copse at the time of this sighting, heard a metallic ringing noise, but said that he never saw anything.

Amazing Discovery

On July 25th or 26th, a farmer discovered a very significant crop circle in his field. The CSETI team learned of the crop circle on the 27th. A prominent crop circle researcher by the name of Ralph Neyes was on-site to investigate and announced that the crop circle was most likely formed between the 23rd and 25th of July. (See photo below)

Amazed by Neyes' description of the formation, which was only a few miles away, the research team later went to see it for themselves.

The crop circle was the *exact* shape and form of the symbol the team had been "visualizing and conveying to the crop circle makers." Greer writes: "Since no one outside of our research group knew of the shape which we were projecting, the likelihood that this could be a hoax is thought to be nil."

Calling the results a "crop circle CE-5," the CSETI group says this evidence *clearly* establishes that the crop circles are under intelligent control, and that this intelligence can be interacted with by humans."

Gathering in the crop circles again on the 25th, the group saw once more the brightly lit, amber-orange colored object that made no sound.

Then at 1:10 a.m., while pointing high-powered lights up into a cloud bank, the team noticed bright lights shining straight down from *above* the cloud. They were mimicking the team's lights.

Near landing of a spacecraft

The project was to accomplish far more than what the research team could have imagined. What Greer states next challenges belief. However, there were multiple witnesses to the following events. Greer writes, "The night of July 26th and the wee hours of July 27th, proved to be of profound importance. It is on this date that the CSETI research team had a confirmed, close range lock-on with a structured spacecraft which came towards us in a near landing. The significance of this night's activities can hardly be overstated."

The group gathered on the 26th

at the research site in Alton Barnes around 10:00 p.m. The sky was cloudy that night. Staring into the heavens around 10:25 p.m., the group noticed two UFOs coming from the east. They were silent and bare of any aircraft lights. The object finally moved on toward the south.

The evening was just beginning for Greer and his crew. To summarize this night, Greer writes, "What follows next admittedly sounds like something out of a science fiction movie."

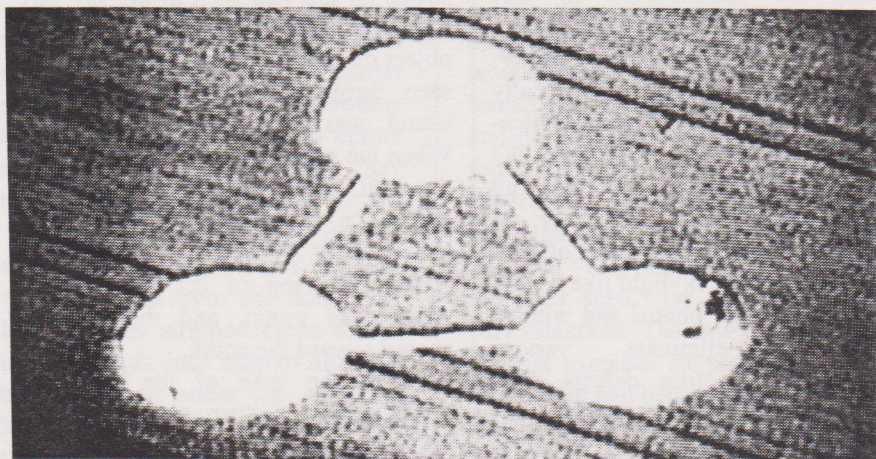
While waiting in the crop circles, the team noticed "strobe-like lights" appearing from all directions. Around 11:00 p.m., bright lights spinning *counterclockwise* seemed to emerge from *above the clouds*. This activity carried on for ten minutes directly over the group.

Looking northeast, they saw "four elliptical shapes" detaching themselves from the "edge of the cloud line" and then heading eastward. The objects traveled in a circular motion. While watching this light display, several members of the group felt an electrostatic effect on their skin.

Just as the evening was becoming interesting, it began to rain. Though falling lightly at first, the rain soon came down very hard. The group decided to break up at this point.

However, Greer along with three others chose to stay. They headed over to the "concrete farm road" on the Carson farm, a few hundred yards away. The rain washed nearly everyone away, including unwanted visitors who had been snooping around in the area.

While the four sat in vehicles, waiting for the rain to stop, Chris Mansel jumped out of one car and started beating on the window of the vehicle Greer was in. Greer describes what happens next: "I rolled the window down, and he



[Chris] exclaimed that there was a spaceship coming right through the field only a few hundred feet from our location!"

What the four men saw as they stood in amazement was "a large disk shaped craft, with brilliant lights rotating *counterclockwise* along its base." It hovered no more than 30 feet off the ground and stood 400 yards away. A metallic structure could be discerned. Shaped like a cone, the object had three amber lights on top of it. At the base of the craft, the spinning lights were blue-green, red, amber, and white in color. The lights seemed to "blend into each other in an unusual fashion." The object was first spotted at the edge of the wheatfield, and then it moved behind some trees, but could still be seen.

Greer noticed that the dial on a new compass that was brought along began to move slowly *counterclockwise*. Also, an electrical charge was felt by the four witnesses.

Unfortunately, the videocamera the team had was inoperable because of the rain. But they did record on audio tape the reaction of those present. Here is an excerpt from that live recording:

"We are observing a close range spacecraft that is conical shaped. Lord, it looks like a Christmas tree lit up! Chris mentions a Christmas tree lit up -- *exactly!* Mother of Mary Christ, look! Now it's rotated a bit. It is conical and looks just like a Christmas tree. It is floating down through the trees at this time. Do you hear humming? Yes. When it first approached you could see the lower part. It looked disk shaped. It was rotating and the lights were going back and forth. This thing is big, quite large, that came across here!"

The observers continued watching the craft. They noticed, through a clearing in the trees, that the object flipped until the bottom or another

side of it could be seen. Greer believes this craft was the same one seen the night of the 24th.

"An amber colored probe" detached from the craft and disappeared into the mist. Other nearby witnesses, unknown at the time to Greer and his group, also saw an amber colored light in that same area.

Taking the high-powered lights from the car, the group began signaling to the strange craft. They signaled two bright flashes followed by a pause. Amazingly, the UFO flashed back the same way. This

sequence was repeated many times to the astonishment of those present. The whole sighting spanned ten to fifteen minutes.

A few others who were close by, but unknown to Greer, reported seeing some bizarre events as well. Judy Young and Peter Davenport, both from England, had remained on Woodborough Hill during the rain. They say that during the time of Greer's sighting, they saw a "huge shaft of light" illuminating the crop circle area where the CSETI team had been before the rain. Young and Davenport's location was opposite that of Greer and the others.

Maria Ward was another eyewitness to the spectacular occurrences that night. She had parked her car and was walking toward Greer and his group when she saw and later described the same craft. Maria also saw the amber colored light that

separated from the main body. As she stared at the object hovering above the ground, she saw a light beam toward the craft (presumably from Greer), and witnessed the object flashing back. In addition, Maria felt a tingling sensation along her back and head during this time.

The last sighting for the evening was at 1:30 a.m. A large amber colored object, a mile or so away, appeared and wobbled as it hovered. Greer's group signaled to it twice, and then it signaled back before disappearing.

If all is as reported, then this may very well be the most important series of encounters to date. Greer feels that strong evidence has been brought forth which ties the crop circles to the UFO phenomenon. During an interview with Greer, I asked him if the incidents in southern England were CSETI's first encounters. "No," he told me, "we have had dozens." However, he said that the sightings in England were "a high level CE-5," better than any other attempts in the past.

Greer sums it up best: "This event constitutes a close range, close encounter of the fifth kind with a clear interactive component. It appears that the CSETI team was successful in vectoring in a spacecraft to its location, and then engaged it in signaling. It is my considered opinion, that had the team been adequately prepared for it, there would have been a full landing, and in all likelihood, an onboard experience."

UFO Sighted Near Elkland, Missouri

Date: August 15, 1992.

Time: Approximately 5:30 a.m.

Investigators: Duane Bedell, Susan Bedell, Lisa Dusenberry, and Tom Strand

Investigation Summary by Duane Bedell

This investigation was conducted on August 22, 1992, at the home of witness #1, followed by an inspection of the site where the overflight occurred. Both of the witnesses are considered credible, reliable and articulate.

The witnesses related that on August 15, 1992, at 5:30 a.m., they were driving to work (Marshfield, MO). They turned east onto Webster county road EE from farm road 615 (along which both witnesses live) and observed a bright white light in the distance at just above treetop level. The light appeared to be stationary over an open field on a hillside approximately three to four miles away. The witnesses remarked that it looked too big to be a star and that the light held their attention from the time they first saw it.

Shortly after the witnesses turned onto EE, they also observed what they at first took to be car headlights approaching them from the east. As the lights came closer, they were seen as two sets of two lights, one set atop the other, and were extremely bright. The witnesses noted that these lights were approaching at a speed considerably faster than was prudent for a car to be traveling along EE. The lights passed the witnesses without sound. Neither of the witnesses saw a vehicle and neither saw vehicle tail

lights, although both looked for them. Both witnesses considered this event odd.

The onlookers continued to watch the light ahead and soon noted that it appeared to be keeping pace with them at a uniform distance, despite several turns along the route. They turned onto Webster county road west from EE. About 100 feet after the turn, the witnesses saw to their left (east), a bank of five white lights in a boomerang-triangular shape.

As the lights passed over, five vertical beams of light shot down, illuminating the vehicle and its interior with brilliant white light.

The five white lights appeared to be preceded by a single white light, and followed by a red light on the formation's right, and a blue light on the formation's left. Eyewitness #2, who was driving, "slammed on the brakes" and put the car in park. Witness #1, the passenger, rolled down her window and slid out to sit on the car door with her feet inside the car.

They both could discern a craft outline as the lights moved very slow, almost a drifting fashion, from about fifty feet away directly over the car. As the lights passed over, five vertical beams of light shot down, illuminating the vehicle and its interior with brilliant white light.

The car was illuminated for perhaps one to two minutes as the

"craft" moved over them. Then, the vertical lights "switched off." The original bank of lights continued to move slowly out across a small field to the right (west), and disappeared over a small area of ground fog. The witnesses drove on, after the lights disappeared, to a hill a short distance away to try to find the lights, but were unsuccessful. The lights "had just disappeared."

During the sighting witness #1 noted that the area was absolutely quite -- completely without the usual early morning sounds of wildlife, insects, domestic pets, livestock, etc., that are usually present in the rural setting. (When investigators visited the site, dogs at three nearby houses barked loudly and horses in a corral over which the "craft" passed neighed in an equally noisome fashion.) The witnesses also noted that their windshield, after the passage of the lights, was completely dry. Whereas before, Witness #1 had to use the windshield wipers to remove condensation. Additionally, the vehicle sputtered as they tried to leave and "acted like it was out of gas." The duration of the entire sighting was about 15 minutes, with the close observation lasting perhaps 10 minutes.

Neither of the observers reported any physical effects, nor was the car damaged. And, there was no indication of missing time. The witnesses reported that they were not frightened by the experience itself, but did endure a moment of panic afterwards, when they met a car on the road and observed its headlights coming up over the top of a hill.

As a final note, witness #1 made

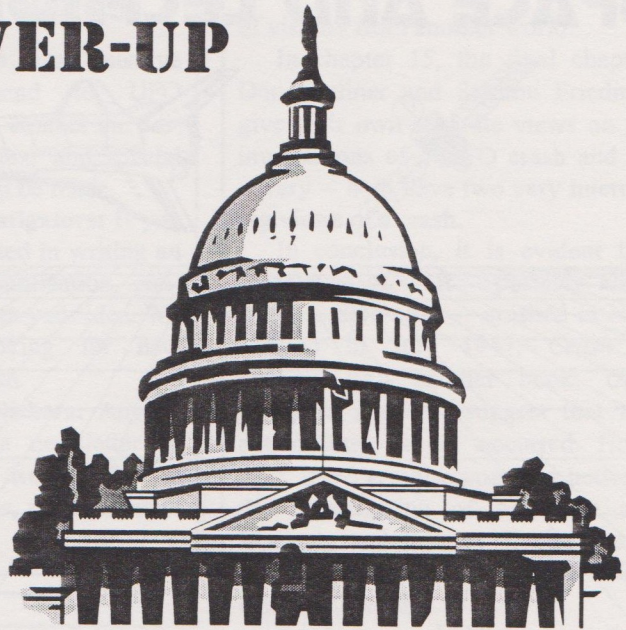
Those who wrap themselves in the American flag while subverting democracy, must be exposed and held responsible to the public.

contract. Cover stories for Special Access [also called "black" -- author's note] Programs must have the approval of the PSO (Program Security Officer) prior to dissemination."

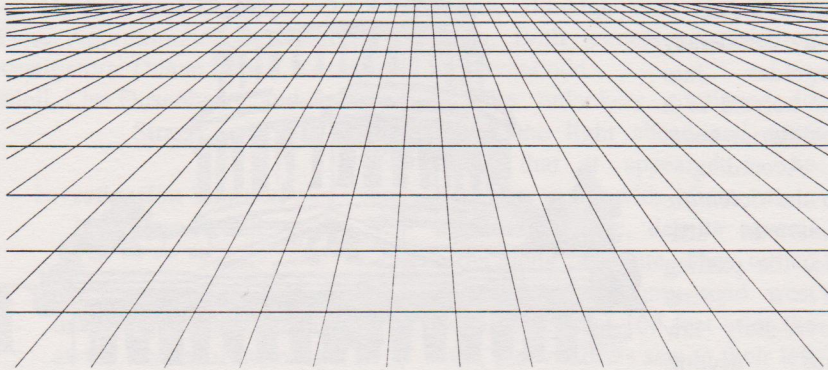
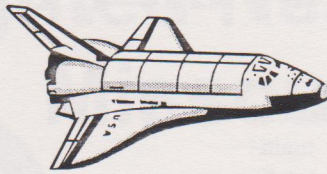
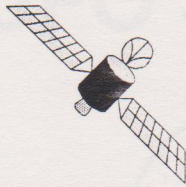

measured eight inches at the widest point. Body fluids were intact in both animals, and blood was found neither in the area nor in the wounds. The animal that had struggled had a small amount of blood coming from its nostrils.

Both carcasses exhibited no indications of predatory activity, and were not as decomposed as one might expect after three weeks of relatively warm weather (well above freezing). A very minor stench was present with one mutilated animal, and a somewhat stronger odor with the other. Neither of them though, had the degree of smell and decay that are characteristic of disemboweled animals three weeks after death.

Giant Asteroid Passes near Earth

On December 8, Toutatis, a large asteroid, passed within 2.2 million miles of Earth, a short distance in astronomical terms. "It's the most irregular shaped object in the solar system," claims Steven Ostro, of the NASA Jet Propulsion Laboratory.

The asteroid, originally thought to be about a mile wide, is actually made up of two objects held together by gravity. One object was found to be 2.5 miles wide; the other was measured at 1.6 miles wide.

Asteroids are huge chunks of rock in space that are normally found in a belt between Mars and Jupiter. However, some asteroids have orbits that bring them close to Earth -- and that can spell disaster.

Asteroids have struck the Earth before -- the Arizona Meteor Crater is an example of one. It is even theorized that a giant asteroid struck the Earth 65 million years ago, which darkened the skies and

chilled the planet, eliminating food plants and killing dinosaurs along with most other animals of that time.

NASA announced in a report last year that the Earth has a 1 in 10,000 chance of being struck by an asteroid at least a third of a mile wide in "our lifetime." This, according to the report, would destroy food crops and "possibly end civilization as we know it." If an asteroid wider than three miles strikes the earth, "the survival of the human species would be at risk," the report stated. Toutatis is among the 50 largest earth-approaching objects that scientists know exists.

This whole threat of doomsday rocks has started a heated debate between weapons physicists and concerned astronomers. Edward Teller and those with the "Star

Wars" defense plan are promoting an idea of designing orbital nuclear arsenals to shoot down asteroids. In fact, Teller, at a NASA workshop a year ago, had called for weapon stockpiles and asteroid target practice to begin in a few years. He also mentioned building a bomb *thousands* of times more powerful than any that exists today.

This idea infuriates many astronomers, who feel these individuals are looking for any reason to introduce weapons in space, even with the end of the cold war and the diminished need for a "star wars" type system. "They'll come up with any justification they can to do that," said Louis Friedman, executive director of the Planetary Society.

Clark Chapman, a planet scientist in Tucson, Arizona, says he feels these ideas are "outrageous." Chapman says this because of how expensive they would be to develop, and how much more dangerous they are than the modest threat they would address.

Whatever happens, many astronomers feel shaken by the new tiger they have released. Personally, I don't know what is more frightening -- the threat of an asteroid wiping out life on Earth, or Teller's idea of having orbiting nuclear weapons *thousands* of times more powerful than the weapons we now have. -M.N.

of visitors from another world.

In chapter 15, the final chapter, Don Berliner and Stanton Friedman give their own separate views on the implications of a UFO crash and recovery -- both have two very interesting views of a crash.

In conclusion, it is evident that some type of craft -- possibly alien, with an alien crew -- crashed in New Mexico in July 1947. *Crash at Corona*, and another book, *UFO Crash at Roswell*, suggest that this extraordinary event occurred. However, there are discrepancies between the investigation of Friedman and Berliner, and that of Kevin Randle and Donald Schmitt, authors of *UFO Crash at Roswell*.

Friedman and Berliner believe that there were two UFOs involved -- one that crashed at Corona, and another that crashed 150 miles away at the Plains of San Agustin.

Randle and Schmitt's investigation seems to indicate that there was only one craft and it touched down on the Mac Brazel ranch, leaving the vast amount of debris, while the main part of the craft crashed a couple of miles from the debris field.

Who's right? The reader will have to make his/her own conclusion. I can only say that the U.S. government continues to insist that nothing important happened at Corona or at San Agustin. The government's ability to maintain this position, in the face of a growing collection of testimony from those who were there, cannot survive forever. Just remember, a story that is weak and fraudulent will usually sink and die of its own useless weight in a very short time. On the contrary, a story that is strong and full of truth will keep afloat and remain around for a long time -- maybe even forever. The Roswell case is still afloat, and is getting stronger, even after 45 years.

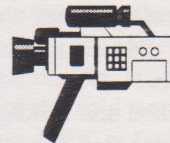
