Date of Interview: February 24, 1981
Date of Sighting: November 16, 1980
Time: 5:30 P.M.
Duration: 15-20 minutes
Location: Lawrendale Street, Waterloo

Witness was walking into kitchen when she noticed unusual lights out the kitchen window. She called her husband and he got the binoculars. They saw a large, elongated shaped object hovering in the north east portion of the sky. The object had orange, yellow, green, red and blue lights surrounding the middle. These lights were steady and did not flash. The object appeared as a dark color. The object was the size of a fifty cent piece held at arm's length. It was at about 50 feet above tree top level. It appeared to be hovering above the Grand River, $\frac{1}{4}$ mile away. The elevation was 45° . The object remained completely motionless. The sky was clear, no stars visible, temperature 30° F. They watched the object for 15 to 20 minutes and it simply vanished before their eyes. They called the Waterloo/Wellington Airport Weather Office. The Weather office reported nothing unusual in the sky, eg. weather balloon.

Comments: Nothing man-made nor astronomical fits the above description.

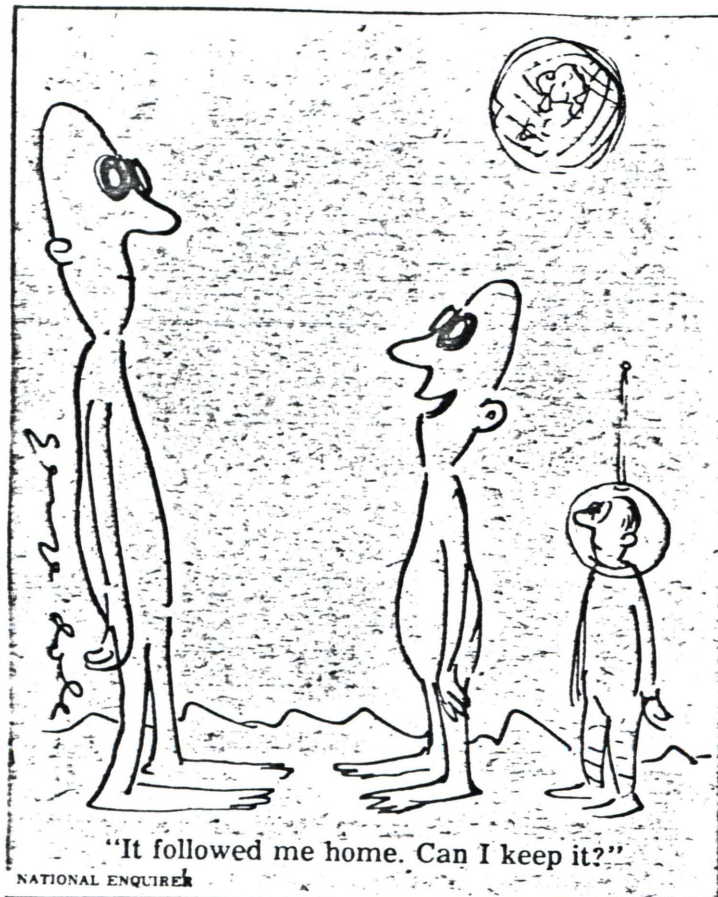

The following pages (many) concern a CE III case and possible MIB incident. This case was investigated by CUFORN in Toronto. I have attached this case in its' entirety.

To the directors of UFO organizations, this is repetitious reading, but the members of my group are not aware of this case and I felt it would be of interest to them to read the full report.



ABDUCTION AND MIB INCIDENT IN CANADA

The third and fourth reported abductions of humans by UFO entities in Canada occurred on August 4, 1979. The people abducted were a girl of 14 and a man of about 43 years of age. The girl was aboard for 15 minutes, the man for an unknown length of time.

The incidents were investigated by Canada's largest UFO investigation group, the Canadian UFO Research Network, or CUFORN. The evidence included matted-down grass, residual radiation, physical effects on one abductee, an MIB visit, and an independent observer who saw the UFO moving to the spot where the girl's abduction took place. To this day, the independent observer, a woman, does not know that there was an abduction involved.

The first of a series of UFO sightings which culminated in the abductions happened in the eastern part of Toronto, Ontario, on Thursday night, August 2.

That same night, one hour later, similarly-shaped UFOs were reported in Northwestern Kansas and Southwestern Nebraska, U.S.A., 1150 miles southwest of Toronto. Articles about the sightings in the Norton, Kansas Telegram and the McCook, Nebraska Gazette were sent to CUFORN headquarters by Edmonton, Alberta member John Musgrave. He sent them as part of his monthly UFO clipping service.

CUFORN, founded in December, 1977, is a group with 55 members in five countries. Its membership is restricted to persons with expertise in dozens of scientific fields. CUFORN's policy is to avoid contacting the media which distorts, ridicules, fabricates and exploits UFO events, especially in major cities. This leads to crank phone calls and harassment of UFO observers.

In order to avoid this, the names of three girls and one of their mothers have been changed in this article. The three girls are

Sarah Hines, 14, Cathy R., 14, and Jackie B., 11. They and Jackie's mother filled out the appropriate CUFORN sighting report forms, CE2's and one CE3 form.

The incidents involved seven teenagers, 13 parents, and one young boy.

They saw six UFOs, two of them arrowhead in shape. At 9.50 p.m., August 2, Sarah saw something in the sky nearby and told her two girlfriends to follow her to the field nearby which is owned by Ontario Hydro. Two lights were hovering low near high tension power lines. The two objects rose when they arrived, one heading south, the other north. From his house window, Cathy's father saw one of the objects at 9.50 p.m. He later refused to fill out a sighting report form. When the two objects had left, Cathy sighted two arrowhead-shaped objects which appeared to be moving backwards from the northwest at 9.52 p.m.

A minute later, Sarah and Jackie observed a cigar-shaped object. It was black with white lights around the periphery and a green light at one end. The cigar was following an arrowhead-shaped UFO at about 500 feet elevation. The cigar emitted a sound like a generator operating at low power.

An oval-shaped object appeared at 9.55 p.m. It had a green haze around it and had four curved legs longer than the body of the object. There was a dull red light on top, red lights along the bottom and yellow lights around the circumference. It appeared to hover over the senior public school roof, two blocks northwest of Sarah's home. This object was 12-15 feet in diameter and about six feet in height, excluding the legs. Another girl, Jodi, saw the object over the roof. When she approached the wall of the school, she felt paralyzed and began to cry.

The seven teenagers on the school grounds were soon joined by their parents. The parents said they did not see the oval object, only the arrowhead and cigar objects. The teenagers said the crickets in the vicinity stopped chirping during the incident.

The oval object lifted off the roof about 30 feet, hovered again and then disappeared from sight when its lights went out at 10.05 p.m. Immediately, the sound of the crickets was heard again.

Sarah normally sleeps four to five hours a night, but this night she slept 12 hours with no dreams.

On Friday the 3rd at 9.50 p.m., the same observers plus Cathy's mother, a friend Bill MacMillan and Jackie's brother Ernie went to the field which is adjacent and to the east of the school grounds. Again, the sounds of life in the field seemed to stop. No cars were seen or heard on the normally busy street, which led to Buttonville Airport, three miles to the north.

They saw an oval object the size of a football field at a 300 foot elevation. It was flat, dark and solid-appearing, with large checkered patterns and three large "fans" of 50 foot diameter beneath. The entire object turned over slowly, rose, and headed south very slowly.

At 10 p.m., Bill and Ernie observed two large arrowhead objects at about a 500 foot elevation north of the field. The angle of elevation to the observers was 50 degrees. One object seemed to explode silently. The pieces separated as if a jigsaw puzzle was being taken apart. The object's total size was now doubled by the separation of the pieces. This object and the intact object were now separated by 200 feet.

Sarah had an urge to go alone to another field $3/4$ mile northeast of the Hydro field. Sarah walked, as if in a trance, to the other field. There she saw four bright lights hovering at about 500 feet

elevation at 10.10 p.m. Sarah returned home and again slept 12 hours with no recall of dreams.

At 10.30 p.m. that night, Cathy dialed the telephone operator and asked her whom to call to report a UFO sighting. The operator suggested she call the Ontario Provincial Police. She spoke to David Craig, an O.P.P. public relations officer. He called an acquaintance of his who knew Joe Muskat, CUFORN Co-Director and President. Muskat phoned Sarah on the 5th. That night he visited and interviewed Sarah and her mother Alice, after notifying Co-Director and Secretary Lawrence J. (Larry) Fenwick.

Events began once more at 9.50 p.m. on Saturday, August 4. The same teenagers, along with Jackie's father, went to the Hydro field. Jackie's mother, at this time, was walking a few blocks away and saw an arrowhead object heading north at about 20 miles an hour about two feet above street level.

Just after her observation, the people in the field watched two hovering arrowhead objects for about two minutes. Then, at 500 foot elevation, the objects all headed eastward "like a flash".

Also at 9.50 p.m., Sarah felt compelled to walk away from her friends to the field northeast of the Hydro field. All sounds of life seemed to stop. Sarah crossed the road to the field without looking out for cars. She said she had the feeling that there would be no cars and there were none. There usually is some traffic on the street even late at night since it is a main north-south street.

Upon reaching the field at 10.05 p.m., she saw an arrowhead object move off the street to the field and in front of her. It settled slowly to a height of two to three feet above the foot-high grass. She walked to within two feet of the object. Suddenly she saw four shadow-like figures emerge from the object and hover in a semi-circle two feet above the ground. The figures were four feet tall, football-shaped, one and a half feet wide and less than an inch thick, like wafers.

She looked at them for one to two minutes and passed out. She recalled being on the UFO and observing the general area. She also saw a man in a blue suit walking a dog. She remembers waking up in the field 15 minutes later at 10.20 p.m., stretched out on the ground about 15 feet south of where the object had been.

Again, upon her return home, she slept 12 dreamless hours. Muskat asked her why her face was orange-red. She said, "You won't believe this". He asked her if she had any other marks on her body. She said "Yes". She showed Muskat her right hand. One pin-prick mark was clearly visible on the inside of her index finger and a one-eighth inch diameter elongated red scrape mark with a pin prick inside it was on the base of the thumb. These marks healed in five days' time with no medical attention.

Her mother said Sarah's eye pupils were dilated and that she had washed off some of the redness on her face the next morning. She had done this out of curiosity and fear. By the morning of the 5th, the dilation was gone, her mother said.

Muskat asked Sarah "What was the thing you said I wouldn't believe?" She replied: "I was on board a UFO".

Muskat, Sarah and her brother Jay went to the site, where they saw a triangular area of depressed grass which had a grey pallor as if the chlorophyll had gone from it. The measurements that Muskat took there corresponded very closely to the description by Sarah. Muskat photographed her hand, the matted-down area, and called Larry Fenwick and Harry Tokarz.

All three went to Sarah's house to ask for further details. Following this they proceeded to the field. There, she showed them approximately where she had awakened. During the search for the exact location, Sarah noticed a nickel and a penny lying in the grass. She searched her pockets, telling them she had eleven cents the previous day. She only found a nickel in her pocket. This money was found at the location at which she had awoken, 15 feet from where the grass was matted down and dried out.

On August 7th, Claude Freeman, CUFORN member and pilot, was asked to get a Geiger counter to check for radiation. That night very heavy rain fell, preventing use of the Geiger counter. On the 8th, Freeman and Henning Jorgensen, CUFORN radar and electronics expert, took radiation readings, while Muskat obtained soil samples.

The readings were 1.6 to 1.7 higher than the normal background - radioactive scintillations. Geiger readings were taken in areas as far as five feet away from the depressed area. The readings ranged from 14 to 19 at that distance. Inside the depressed area, they ranged from 23 to 34 scintillations per minute.

Muskat interviewed Cathy on August 9th. Cathy described her observations of August 2nd. She said the arrowhead object had a red mist around it. It was silent and, inside the red mist, the surface appeared white and smooth. It hovered and moved up and down slowly. She said that at arm's length the object would have been the size of an automobile.

On all three nights, the weather was clear and warm. There were many stars in view and the moonlight ranged in intensity from dull to bright. There were a few fluffy white clouds on the night of August 2. Cathy said the arrowhead object came from the north-west on August 2. She said there were six objects in view that night. She also noted that the wind was almost non-existent, and was from the south-east. The edges of the arrowhead object appeared sharp. "The bottom looked like pipes on the bottom of a car."

Sarah said that on the sightings of the 2nd, she began to cry while she watched the oval object and could not believe what she was seeing. Cathy also said that on the 2nd, she saw an "orange-red ball of fire". Cathy said that on the afternoon of the 4th some friends helped her get up on the school roof, where she saw oil and half-square marks. These were no longer visible a day later, when investigators arrived.

CUFORN contacted a doctor who specializes in hypnosis in Toronto,

Regressive hypnosis sessions took place on October 10, 18 and 24 with Sarah's mother present. The doctor's name is omitted here as he does not want to be bombarded by phone calls from persons who wish to have regressive hypnosis. He prefers to be contacted by CUFORN.

The following is a summary of the tape recorded regressive hypnosis sessions. For coherence, a few statements made in the second session are included with those of the first session.

Oct.10, 1979: Sarah said she was taken on foot through the UFO's wall. The interior was brightly and uniformly lit throughout and sharper than regular lighting. Sarah detected the odor of chicken. Her hands went through everything she touched, except for an ordinary cat from Earth. She was told they had been "growing it" on board and it was to be released eventually. The creatures had not done any tests on the cat, which roamed around freely in the UFO.

She said there were seven shadowy creatures on the UFO and that she could see right through them. They were long and oval, like large American-style footballs and were four feet tall. They appeared crystalline. Each was of a different, but strange colour.

They told her telepathically that they had taken her for tests to see what humans are made of.

They said they had been on Earth before and
- would return when she was 25. She felt she was on board for
"what seemed like a year."

Dr. "Did you stay here on Earth and just look at it from the air?"

Sarah: "Yes. I saw the whole world."

Dr. "Did they take you to any other world?"

Sarah: "Well, they showed me this place. It's red and it's there,
but it's not."

Dr.: "Was it another planet or star?"

Sarah: "Yes."

Dr.: "Do you remember what they did to you that made your skin
become tanned, sort of like a sunburn?"

Sarah: "The bright lights. They've got to stay on. They have to
have light."

Dr.: "Why?"

Sarah: "To keep them alive."

Dr. "Why did the bright lights only cause sort of a sunburn on
your face and neck and not on your hands?"

Sarah. "'Cause my hands were glowing."

Dr.: "Do you know why they were glowing?"

Sarah: "No."

October 18, 1979 (Second Session)

Sarah described the physical examination administered to her.
They put an instrument in her mouth. A "light" was put on her thumb
and index finger which painlessly burned holes in each of them.
Blood was extracted from the holes. A machine was placed on her
head "to find out what I know." She asked the creatures where they
were from, but she said she did not know what their answer was.

Sarah saw an ordinary English-speaking human man on the UFO. He said he was there for the same tests. He told her his first name only, but she recalled merely that it began with an 'A'. He was "from here", Sarah said, but not from her neighborhood. The man said that he was taken aboard after she arrived on the UFO. He stayed on board after she was let go. The creatures told her that they were going to let him go after they had released her. This man may or may not be a Canadian.

'A' told her he did not mind being on the UFO. He asked the creatures questions when Sarah was present, but Sarah could not recall them. 'A' had dark hair, which was "going a bit grey. He looked about 43". He was "not very tall" and wore casual clothing. He told Sarah he was a store owner.

Sarah said there were a lot of plants and computers on board, although most of the computers were in another room which she got a glimpse of.

Dr.: "How did you get off the UFO?"

Sarah: "They took me out the door. It wasn't a different color door. It was just a little hole in the wall. I went through a little hole. And then they put me back to sleep and then I was on the ground."

Dr.: "Do you remember how they put you to sleep?"

Sarah: "Yes."

Dr.: "How?"

Sarah: "They told me to go to sleep."

Dr.: "Does it still seem very real to you or does it seem like a distant dream?"

Sarah: "I'd say 'real'."

Dr.: "Were you frightened at all?"

Sarah: "No."

Dr.: Did you feel they were good people, good beings?"

Sarah: "Yes."

October 24, 1979 (Third Session)

NOTE: The incident referred to here occurred on October 11, 1979, one day after the first session.

Dr.: "What are you seeing?"

Sarah: "A funny man. He's tall, skinny and he's got funny-looking shoes on."

Dr.: "How are the shoes funny-looking?"

Sarah: "I don't know. They're just funny."

Sarah told the doctor she was in the school courtyard at lunchtime along with her friends. He had followed her to the courtyard from the cafeteria. The MIB came over to her and told her to move away from where her friends were. Then he started asking questions. She said he wanted desperately to find out who her friends were.

Dr.: "He gave you no reason why he wanted to know?"

Sarah: "I think he wanted to kill them."

Dr.: "Why? Did he think they were dangerous?"

Sarah: "Yes, I guess."

The Man in Black said he had a lot of partners everywhere. He warned her that if she did not tell him about everything on board the UFO that he and his friends would get after her. And if she went away from him while he was talking to her, he would scare her again. She thought about calling for help, but could not because the man's "mind was stronger" than hers.

Sarah told him exactly what she had seen and heard on the UFO. He seemed pleased with her information, only showing surprise when she mentioned the computers. He said he knew there was a man on the UFO. He told her that he had spoken to the human man since that time.

Dr.: "How did your conversation end?"

Sarah: "He just went."

Dr.: "You mean just walked away?"

Sarah: "No. He just disappeared."

Dr.: "Right in front of you?"

Sarah: "Yes."

Dr.: "Do you think he was human?"

Sarah: "No."

Sarah had told Muskat about the Man in Black on October 12. She said he stood six feet tall and looked like a dead person. He had a dull grey toned face, slanted eyes and wore a black suit. Sarah could not remember the shape of the lips, but recalled that his grin was sinister. He had a very pointed nose and long fingernails on tapering fingers. His feet were pointing outward at 90 degrees. His shoes had 3-4 inch heels.

In a summary of the sessions, the doctor noted that Sarah had been taken to a psychiatrist several months before her experience as a result of school problems, the strains of adolescent adjustment and sibling rivalry. He said she had a vivid imagination and had claimed to have seen some bizarre-looking ghosts. She had a very strong interest in the occult for the past few years, but, according to her mother, not much interest in UFOs. She had not read books or magazines on the UFO subject.

The doctor said the UFO incidents began on July 23; whereas the 3-night sequence of sightings started on August 2. He mentioned that Sarah "claimed" to have seen some UFOs on that night and the two succeeding evenings. He used the word "claimed", although he admitted that he did not investigate the sightings by other people in the area at the time.

The doctor commented that Sarah was remarkably nonchalant about the entire experience both before and after the hypnosis. This was her attitude toward her father's death, he added. Her nonchalance concerning his demise was understandable due to a reason which must remain confidential. Her casual attitude toward the UFO incidents is partly explained by the absence of serious side-effects on her. An important point to note is that she told CUFORN's investigators that the experience inside the UFO was moderately pleasant.

He said the Hines girl seemed candidly surprised to hear what she had said under hypnosis when the tapes were played back to her. He said her casual attitude returned after her initial surprise.

What he does not know is that, from the moment CUFORN was in touch with her and up to a week after the hypnosis was complete, CUFORN's investigators repeatedly told her to be calm about the incident. She was told that abductions are not as unusual as most people think and that any side effects on her would disappear very shortly. In other words, the investigators conditioned her to a casual attitude.

This attitude conditioning was referred to by CUFORN member John Musgrave in his article, "The UFO Investigator as Counsellor and Healer", Proceedings of the 1976 CUFOS Conference, pp. 198-200.

The hypnotherapist said that "subjects do not have to relate the truth while questioned under hypnosis". If Sarah was lying, the doctor would not have said that she experienced genuine surprise at hearing a playback of the tapes of the hypnotic sessions. Others with years of experience in the UFO field have stated that subjects cannot lie under deep hypnosis. These include Dr. R. Leo Sprinkle, U. of Wyoming, and Dr. James A. Harder.

Dr. Alvin Lawson, in "What Can We Learn from Hypnosis of Imaginary Abductees?", 1977 MUFON UFO Symposium Proceedings, pp.107-131, stated that it is possible to lie under deep hypnosis only when subjects are

deliberately told to imagine an event and are fed leading questions and outright suggestions.

After the first session, CUFORN's Larry Fenwick asked the doctor if he would monitor Sarah's bodily direct current electrical field in subsequent sessions. This technique was suggested by Dr. Harold A. Cahn, a clinical hypnotist, in his article, "Use of Hypnosis To Discriminate 'True' and 'False' UFO Experiences", The A.P.R.O. Bulletin, March, 1979, pp.4-5. Cahn said when a subject is faking there is either "no great DC potential change (no trance) or whatever verbal account they present is obviously derivative". The doctor declined Fenwick's suggestion, saying that the device is unreliable, despite the fact that he has never used the instrument.

The hypnotist said that the sessions should stop because of the death of Sarah's father and her recent depressed state. However, the threat by the Man in Black at the school may have been his real reason for discontinuing the hypnotic regression.

Possibly, deeper hypnosis could elicit much information from Sarah. Although they are omitted in this article, five times during the hypnosis she said "I don't remember", indicating that mental blocks may have been implanted in her subconscious by the alien entities. It is ironic that the doctor stated that he hoped his summary "will be of use to you and your colleagues in attempting to get a better understanding of the UFO phenomena" (sic).

The doctor's written summary made no reference to the taped session describing the Man in Black. He did not mention that Sarah saw a cat inside the UFO. He did not refer to the photos Muskat showed him of the marks on her thumb and finger and that her mother noted that the pupils of Sarah's eyes were dilated for 12 hours.

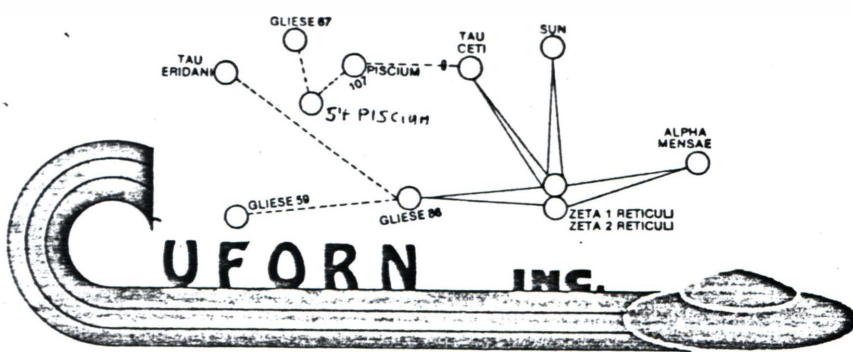
In the summary and in a conversation with Harry Tokarz, Joe Muskat and Larry Fenwick, the doctor said that Sarah told him under hypnosis that she heard buzzing and beeping sounds when she was aboard the UFO. Her account of this was not on the tapes.

CUFORN's Joe Muskat arranged for soil analysis which was done on August 17, at the Radiation Protection Laboratory, Special Studies and Services Branch, Ministry of Labour, at Ontario government offices in Toronto.

ROI readout time was 2000 seconds for gross counts inside the area where the depressed grass was found. Naturally occurring Radon daughters ranged from 123 to 178, with a naturally occurring annihilation peak of 256. Cesium 137, a long lived fallout nuclide reached a peak of 331. Potassium 40, naturally occurring, was also noted. Radiation counts for the soil ranged from 3 to 83, with an average count of 44.

The counts for the background or normal soil outside the site ranged from 1 to 23, averaging out to 6.743. Thus, the affected soil was more than six times as high in radiation as the soil outside the site, even after a heavy rainstorm.

In the light of the doctor's lack of involvement with this and the other facets of the investigation, it is not surprising to CUFORN that he made the following statement: "I do not believe that any conclusive judgement can be made at this time regarding the validity of her account". In contrast and in conclusion, CUFORN judges that this was a genuine double abduction incident.

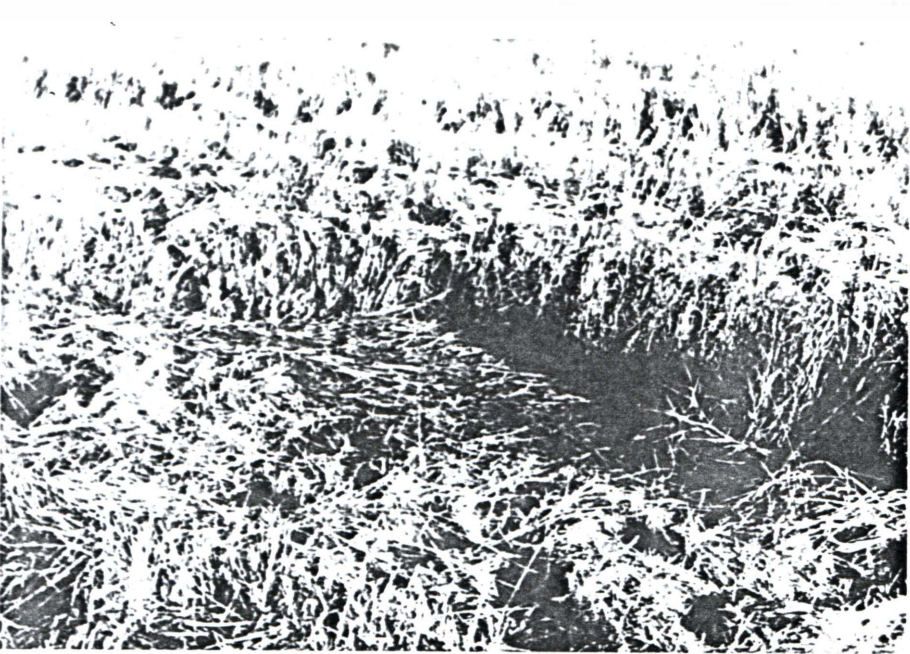
PHOTO CUTLINES FOR ENCLOSED PHOTOGRAPHS AND LINE DRAWINGS

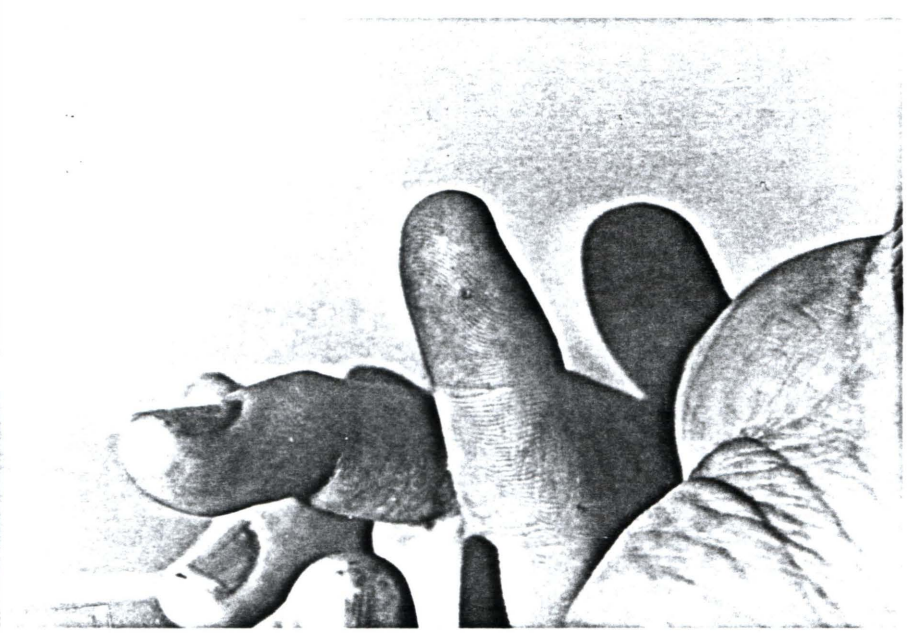
NOTE TO PUBLISHERS-The photos, not the line drawings were taken by Joseph Muskat and credit should be given to him for these if they are published.

- #5 - A line drawing of one of the crystalline creatures and the horizon Sarah saw when looking right through the creatures. This drawing was done by Sarah.

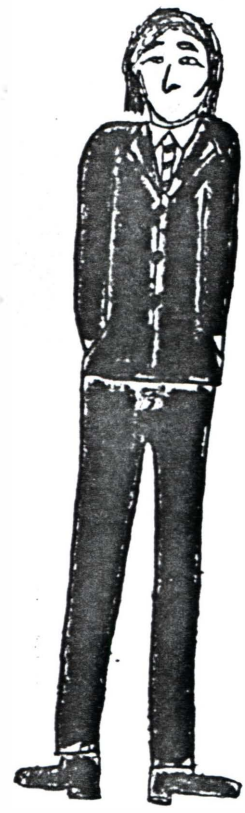

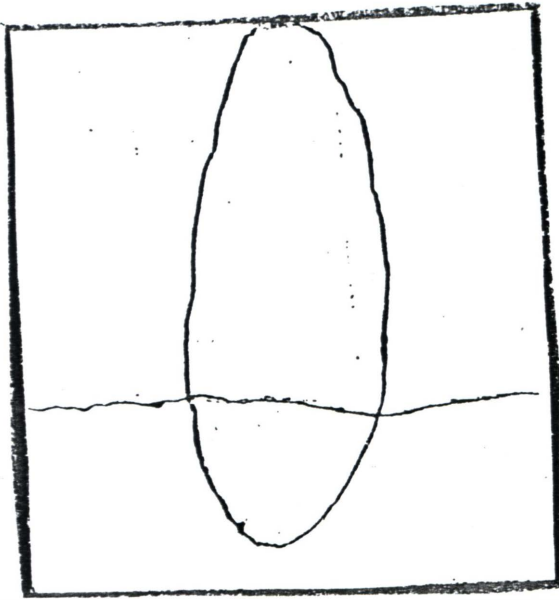

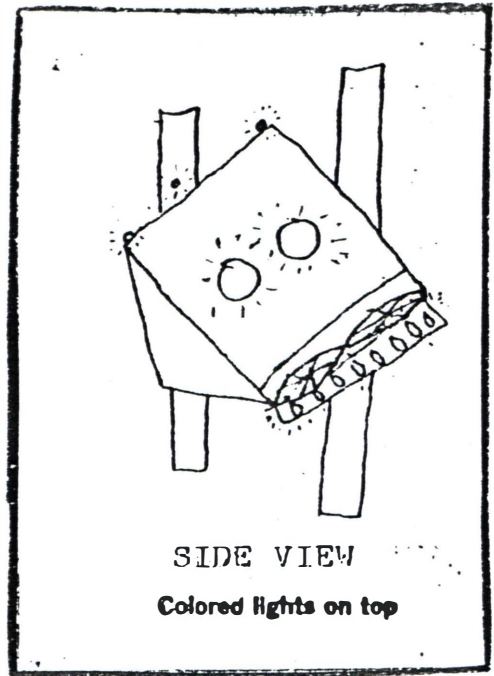

ADDENDUM TO ARTICLE-please read carefully

There are some details not included in the accompanying article which should be mentioned.

First, CUFORN has on file the full names, addresses and telephone numbers of the three girls and their parents as well as the name and credentials of the hypnotherapist we used. David Craig, Sarah's brother Jay, Jackie's brother Ernie and Bill MacMillan are real first or full names.

Secondly, the "mutual acquaintance" of Craig and Muskat is a reporter for a Toronto newspaper. He calls Muskat when he gets a UFO report and before it appears in the newspaper. Even if it is not used by the paper, he phones Muskat. The reporter's story about the Thursday sightings appeared as a C32 story. He does not know about the abductions and we do not intend to tell him. We do not inform the media about reports we receive from individuals.

Third, Jackie's father refused to let her give us her completed sighting report form. He also refused to fill out a sighting report form, and forbade his wife from doing so. We got Jackie's testimony from the newspaper article and from notes taken by Joe Muskat when he interviewed Jackie. Jackie's mother's testimony-- that she saw the UFO heading up the street-- was also taken down in note form by Muskat. Jackie's father and mother were born in Italy. The strong father-dominated family tradition is retained by Italian immigrants to Canada. He father implied a threat to Muskat if the family's names get any further publicity. He said: "I'll make sure you don't tell any more about us and the UFOs." Muskat tried for four months to get these other sighting report forms, but was rebuffed by their saying that they would be away from home every night and week-end.

Fortunately, Muskat had two weeks' holidays from work in the first half of August and was able to work almost full-time on it. Most of the credit goes to him, although I wrote the article since I'm an experienced magazine editor and reporter.

It also took nearly four months to get Sarah to send us a properly completed sighting report form. First, she lost the form. We had to mail her another form. Twice, she sent a form, but forgot to sign it, put her complete address on it and the date she filled it out. She also forgot to include a drawing of the Man in Black.

CUFORN's Claude Freeman, who has some legal training, drew up a legal release form for all rights, evidence and information relating to medical records, psychological testing, assessments, tape recordings and consultations.

In it, CUFORN acquired the right to use all materials and evidence for research, including the giving of the materials, etc. to UFO research organizations recognized as legitimate and responsible. Copies were signed by Sarah, her mother, Muskat, Tokarz and myself,, and witnessed by Freeman and Sarah's brother Jay.

We have copies of the doctor's written assessment of the regressive hypnosis, the tape recordings, the complete 16-page transcription of the tapes, printouts of the soil sample analysis, sighting report forms from Sarah and Cathy, xeroxes of the two newspaper articles from Kansas and Nebraska, the original Toronto newspaper article and photo of the three girls, original colour photos of the school,

the matted-down grass, Sarah showing where she woke up, and the marks on her right hand, Muskat's original notes, Sarah's drawing of one of the aliens, a drawing of the Man in Black, and three drawings of the arrowhead UFO.

There was no need to check local airports since controllers at Toronto International Airport do not comment on radar blips of unscheduled traffic, and there is no flight path over the area where the incidents took place, according to pilot Claude Freeman. Buttonville Airport only handles light aircraft, has no radar, and no flights are made to or from it at night. No aircraft are allowed to land or hover near high tension power lines, especially in a city of 2 million people and on Ontario Government property. For those members from outside Canada, Ontario Hydro is owned by the Ontario Government.

The abduction site is less than a mile from the city's northern limits. Some new housing projects, including high rise apartment buildings, are situated in the area, but there are still several areas of open fields there, either privately-owned or government-owned.

Another point related to the doctor's description of Sarah as nonchalant: her mother also impressed us as being concerned, but not overly excited about the events. She seemed to be controlling her emotions quite well and was most helpful to us. She is a public school English teacher. Her husband had died as a result of a heart attack.

The UFOs seen could not have been night-time advertising airplanes because there are none used in Canada at present.

The regressive hypnosis was paid for by the Ontario Government's Ontario Health Insurance Plan. A 50-minute talk with the doctor by myself, Muskat and Tokarz, costing \$60, was paid for out of our own pockets.

One additional item which may or may not be important: One day after I touched the matted-down grass during our investigation, I noticed that my wristwatch's calendar feature was malfunctioning. The date section would not change automatically at the end of a day. I had to take it in for repairs twice, since the first time I did, the repair department at Eaton's could not fix it properly. It now works properly. No one else touched the grass in the area for any length of time. Sarah was not wearing a watch on August 4.

Another point: The reason Sarah and the other two girls knew what time it was each evening was that they used to meet regularly at 9.50 p.m. in front of Sarah's house on hot summer evenings. One of the other girls was wearing a watch each evening. We did not ask her if her watch was affected, unfortunately.

Still no explanation for UFO sighted on August 2

Military sources continue to deny that the object seen in the skies of Northwestern Kansas and Southwestern Nebraska the night of Aug. 2 was one of their planes but reports of the sighting continue.

A spokesman for the Strategic Air Command headquarters at Offutt Air Force Base in Omaha said a check of operations showed no planes from that base were flying in this area at 11:30 p.m. or midnight, the time of most of the sightings.

The SAC spokesman also indicated they were not doing any low level practice bombing runs at that time.

The spokesman said the description resembled a fighter plane and suggested checking with air national guard units.

However, Capt. Robert Bailey of the Nebraska Air National Guard in Lincoln said a check of operations records showed no national guard planes were in that area at that time.

Capt. Bailey pointed out that air guardsmen seldom fly at that time of night during the week for two reasons: 1. they all have jobs they have to go to the next day, and 2. SAC has priority over them when it comes to air routes.

At Bailey's suggestion a check was made of the Kansas Air National Guard unit at Ft. Riley and this also brought forth a negative response.

Bailey also noted that reports that the object hovered sounds to him like a helicopter.

When asked why he thought there was no sound when it was hovering, Bailey said he had no idea unless the object was further away than people thought.

Several officials commented that the humming sound when the object started up again could indicate that it was a jet helicopter.

One area law enforcement officer, who asked not to be identified, added. "If it was some type of secret maneuver by the military, you don't really think they would admit it, do you?"

Meanwhile the reports of the sighting of the object, described by most as appearing from the lights to be in a triangular shape, continue to come in.

Among the latest is a report from Norman Stastny and his wife, Linda, 808 East H.

Stastny, who is an instructor at the McCook High School and his wife, who is a secretary at East Ward School, said they were sitting on the balcony of their house when they spotted the object.

Stastny said he has never seen anything quite like the object and noted it was about 11:30 p.m. or midnight.

Stastny said the object was going from the south to the north and estimated it was around Culbertson or Trenton.

Previous sightings have put the object in a corridor from southwest of Oberlin to north of Culbertson.

Mrs. Stastny said she couldn't really make out a shape from the lights but Norm said it appeared to be in the shape of a triangle and looked like it had lights all around it.

He said they watched it for a couple of minutes while "it seemed not to move at all and then suddenly took off."

"It couldn't have been an airplane but it was so plain anyone looking in the sky at

that time couldn't have missed it," he said.

The other sightings came from a group of seven youngsters, according to a letter from Dan Miller of Route 1, Bartley.

Dan, who is 12, said the object also was seen by Kendra Morris, 11; Doug Miller, 10; Berdena Morris, 8; Dustin Miller 8; Chad Pew, 7, and Shawn Pew, 5.

Dan said it was about 11 or 11:10 p.m. when they saw the strange lights.

He said there were three red lights and one middle green light "very high in the air."

The group was at Eric Pew's farmhouse about 2 1/2 miles northeast of Lebanon and 3 miles north of the Kansas border.

He said Berdena Morris saw the lights first and called the rest of them out of the house.

"We all thought it was an airplane at first but it was stranger than an airplane would move so slowly and stop to hover. The lights were blinking slowly and sometimes they would blink from a red to a dark orange."

Apparently the strange object which some 21 persons have now reported seeing in the skies of Southwest Nebraska and Northwest Kansas the night of Aug. 2 is not a Strategic Air Command vehicle.

An Associated Press check with the Public Information Office of SAC headquarters in Omaha turned up little information.

According to the Associated Press, a SAC spokesman said the command has no aircraft resembling the triangular shape which has been described.

The SAC spokesman said to his knowledge the command had no vehicles flying in the Oberlin to Culbertson area that night. However, the spokesman said he had not checked all the flight records for that night.

The Associated Press also reported that it has unsuccessfully tried to contact a member of the Mutual UFO Network that keeps track of such sightings.

The latest reports of the sighting have come from Jim Armagost of McCook and Lindsey Cooper, an Atwood city policeman.

Cooper said he had no idea what the object could be and said the only thing he could think of was that it was a low altitude practice bombing flight by the Air Force.

However, Cooper said it was his understanding that such practice flights, which have been made all summer, were further west, more in the area of Bird City and Benkelman.

Armagost said he spotted the object about 11:35 p.m. the night of Aug. 2 as he was giving one of his children a ride on his moped.

He described the object as "a big plane with landing lights."

Armagost said though neither he nor his wife, who also saw the object, could figure out what a large plane would be doing in the area with landing lights on.

As others who have reported the sighting, Armagost also said there was no sound and added there was no wind to blow any sound away.

He said the object was not moving fast but he could not tell how fast.

Armagost was in the west part of McCook when he spotted the object southwest of the city. He said it was not too high and was moving from the south to the north.

Most of the others who have spotted the object said it hovered over their property but Armagost said it continued to move, "but not very fast."

He said the shape of the object was not discernible from the lights but pointed out he was looking at it from the side.

Armagost said beside what appeared to be landing lights he also noticed a red light on top and one on the bottom of the object.

Cooper said he was not sure of the time he saw the object "probably about 11:00 or so" but said it was east of Atwood and was headed south.

The two-year member of the Atwood police department said the object was "quite a ways from town, probably 15 to 20 miles."

He said he could see only two lights so could not distinguish any shape but added the lights were fairly far apart and seemed to stay even with each other indicating they were both attached to the same object.

Cooper said the thing he found strange about the object is that one minute he was watching it and the next minute it seemed to disappear.

He said he had a perfectly clear view of the object with no obstructions in his line of sight and the night was clear.

Cooper said there was no sound but added this could be because the object was so far away.

Earlier the Federal Aeronautics Administration at North Platte said they had no reports of any aircraft in what apparently was the corridor used by the object; that is, from southwest of Oberlin to north of Culbertson.

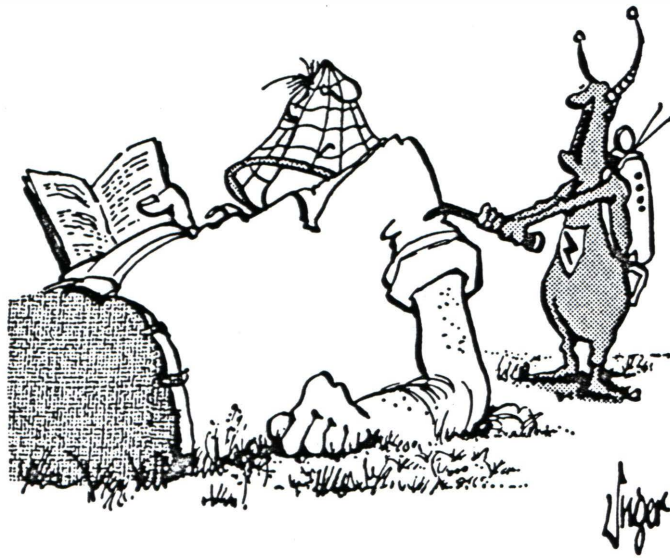

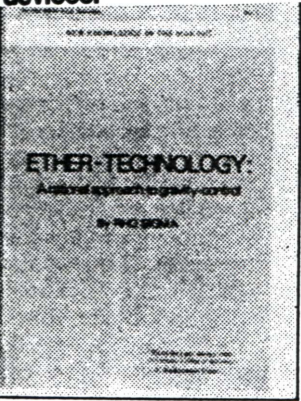

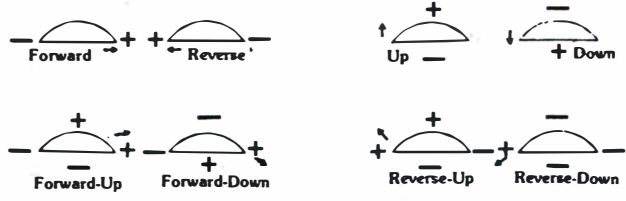

and the engine. Here it stayed for a while, still speeding up and surrounded itself with a pink halo (air ionization). Finally and perhaps thankfully, the whole generator accelerated at a fantastic rate and is thought to have gone into space."

The disk had become weightless or as Sigma puts it "free from inertia." Gravity was totally overcome. Once the disk reached that point, the laws of physics did not apply anymore and incredible acceleration was indeed possible. Since then, Searl has produced a number of small crafts, up to 30 ft. in diameter.

John Searl's work is continuing and he should have an anti-gravity craft in operation soon. Meanwhile conventional science is becoming more and more interested in the new technology. The French Center for Space Studies, (NASA's equivalent), has produced a small model of a UFO propulsion unit. About one square meter in size, it reportedly utilizes electromagnetic and nuclear energy. "This engine is supposedly capable of moving spacecraft at a simulated speed of three times the speed of sound without producing a sonic boom," reports Sigma.

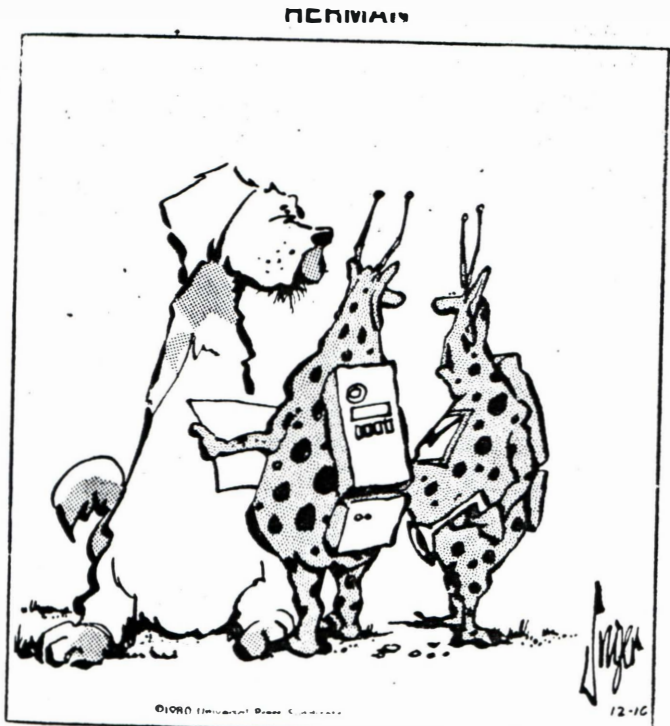
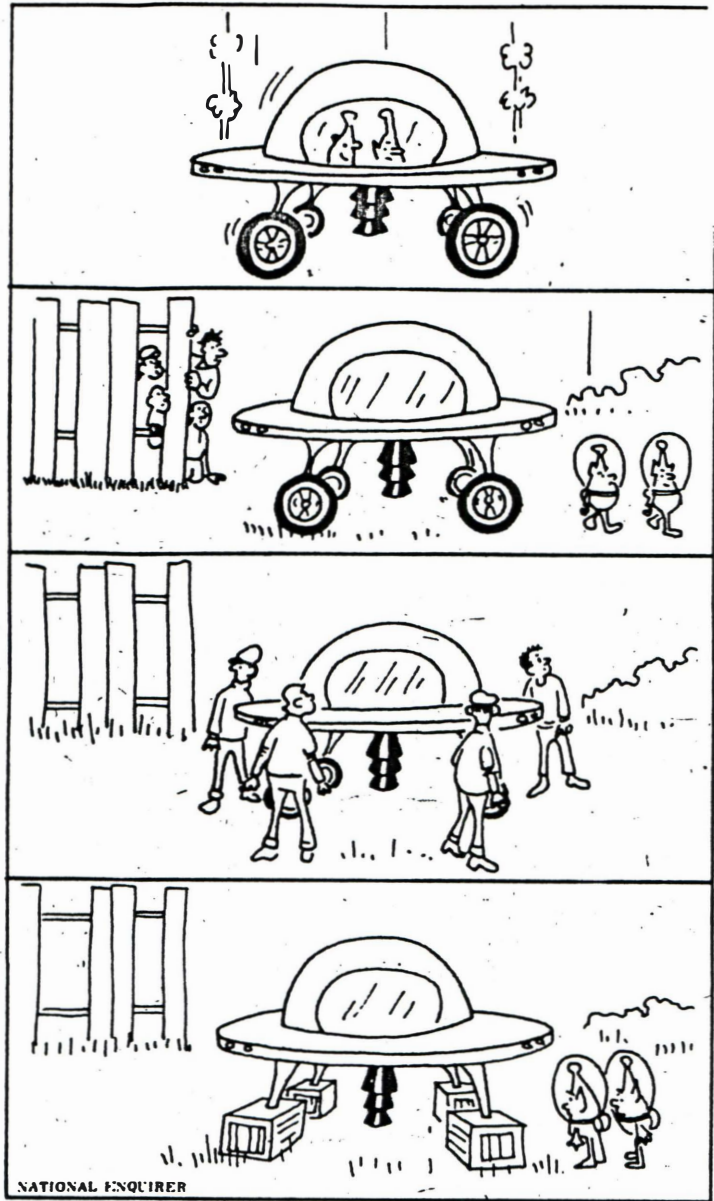
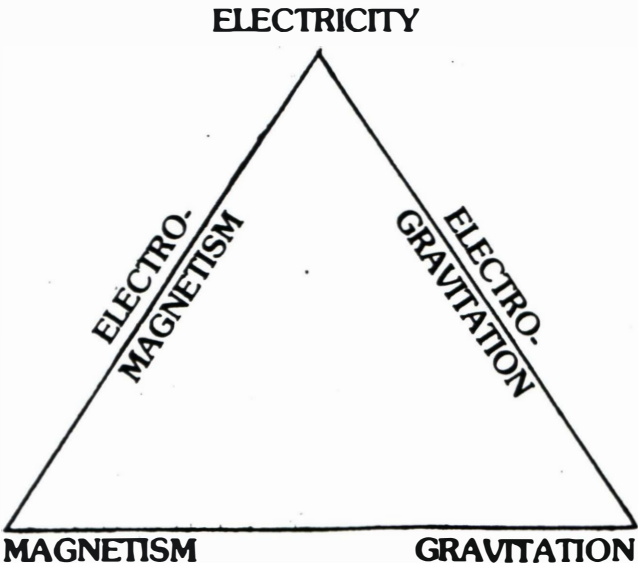

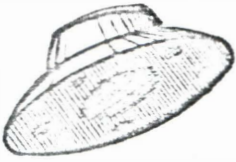
This technology, when it comes out, will put into our hands more power than mankind ever hoped for.

THE PREMISE

Christ & Co. is alive in a chariot of the gods

by Russ Reardon

This is no put-on: this may be the only new physical discovery about Jesus Christ in 2000 years, thanks to Einstein's theorem of Relativity which enables me to re-think myself out of the sticky cobwebs of a centuries old religious cocoon. Which itself, just may be the world's longest put-on!

My proposition (first widely distributed to various friends on 5 May '78) argues that with scientific insights available only since the seventh decade of this century, certain statements in the Bible newly serve as grounds for my syllogism from which, their truth being granted, my premise that Jesus Christ is alive, only 61 years older his time, in a "chariot of the gods."

That Enoch, Elijah, Moses, Isaiah, and Mary, are still alive too. And astonishingly, anytime during the next 8000 years, they can re-appear on Earth (as they already have) again and again, no more than thirty-five years older than they were 2500 years ago when they "were carried up", or "ascended into heaven in a cloud." Even some non-biblical personages who were absorbed into the two-way stretch of elastic Time continue physically alive today--in a spaceship traveling close to the speed of light.

In 1971 Einstein's theory of relativity as concerns time dilation was proved a valid physical law and accepted as a scientific theorem, otherwise any random disclosure that folks "missing and presumed dead" more than 2500 years ago are still alive today, would be met with disbelief and consternation.

What has to be grasped is basically so simple: Time is manipulated by speed; Time is not a constant quantity. Here's Albert Einstein's Theorem of Relativity as concerns time dilation: TIME ON A SPACESHIP TRAVELING JUST UNDER THE SPEED OF LIGHT PASSES MUCH MORE SLOWLY FOR THE OCCUPANTS THAN FOR PEOPLE ON THE LAUNCHING PLANET. And Meyers Handbook On Space (as compiled from the Lorenz Transformation formula) computes the time dilations,

*although one thousand nine hundred eighty years have passed on Earth, only twenty-seven years have elapsed for occupants in a spaceship.

Man only recently demonstrated the relative shortening of time. Four atomic clocks were twice flown around the world to test Einstein's theory of time dilation. Scientists Hafele

and Keating (Univ. of Washington) set four cesium beam clocks to billionths of a second with an atomic clock at the Naval Observatory, then boarded a commercial airline in 1971 with their battery operated clocks. After two round-the-world trips, one in each direction, the moving clocks registered a significant loss of time (actually of $59 \pm 273 \pm 7$ nanoseconds) as compared with their Observatory stationary duplicate on Earth. Incidentally, astronaut John Glenn launched off Earth into many orbits at a slow 17,000 m.p.h., landed in the Pacific two and one-half seconds younger than the rest of us. So, the slowing down of Time occurs to objects and people moving at high speeds. But whereas Glenn was in a horse and buggy, by comparison one of the oldest prayers in the Book of the Dead reveals ultimate conquest of time and velocity, "O world egg hear me! I am Horus of millions of years! I traverse the ages and spaces that are endless!

First, let's examine the biblical description of Enoch's departure off Earth--it strongly suggests time dilation at work, "Enoch was carried away to another life without passing through death."¹ Note "carried away" as in a vehicle. And, what would be "another life"? Well more of the same just like another apple in a barrel--which is implicit in the phrase "without passing through death." Although his 'another life' is passing much more slowly as, "That one day with the lord is as a thousand years and a thousand years as one day."² Now in summing up, since he did not pass through death he's still alive. Inside something out there. Even the narrator of the Pentateuch (the five Mosaic books) confirms this, "the initiate Enoch lived to be 365 years old and did not die, but was carried up to heaven in a fiery chariot (sic)." Also in a section called "The Translation of Enoch" (and we'll see that word 'translation' again) the last paragraph is especially interesting to all viewers of a Cape Canaveral rocket launch, "To the right of him sparkled flames of fire, to the left of him burnt torches of fire, and on all sides he was engirdled by storm and whirlwind, hurricane and thundering."³ Thus did a commentator in biblical days unknowingly but with 20th century space-age accuracy describe the take-off of Enoch in a spaceship.

Indeed that our biblical personages are alive right now is implicit in the very wording of Einstein's theorem. The cloud-plume hiding the vehicle was all biblical eye-witnesses understood ergo, he was "carried up in a cloud." The total absence of technical knowledge of a mighty unknown like an extraterrestrial vehicle landing and taking off was turned into the psychologically familiar, into a deity. The event was transposed into mysticism and religion, "the spirit of the Lord lifted them up." Since no made-on-Earth spaceships existed, they came from elsewhere in the cosmos. I agree with Brinsley LePoer Trench's deduction, "Exceptional individuals capable of understanding and existing in a galactic culture have been taken to other places than the Earth."⁴

Christ. "While they beheld, He was taken up; and a cloud received Him out of their sight."⁵ In other words when the smoke cleared he was gone--but only temporarily as we shall see!

Elijah. "And behold there appeared a chariot of fire (sic) and Elijah went up by a whirlwind into heaven."⁶ And the only reason this promise in Malachi 4:5 could be kept, "behold I will send you Elijah" was because Time passed much more slowly

for him while in a 'chariot of fire' SOL spaceship. And, re-appear Elijah did back on Earth, in the company of Moses himself last seen on Earth 1500 years before! "and behold there appeared unto them Moses and Elijah, behold there was a bright cloud overshadowing them."⁷ A glance at Meyers Handbook shows Moses to be only twenty-five years older, his time.

(Too many "Beholds" for me: not enough "Beauses", which the spaceship crew pointedly neglected to explain). Why?

Moses. Apocryphal writings of the Old Testament, book three, speak of the assumption of Moses into heaven as does the Universal Jewish Encyclopedia pseudepigraphics, and includes the ascension of Isaiah.

Mary. By Papal decree, Mary's ascension into heaven, bodily, was declared fact by Pope Pius XII on November 1, 1950 in Dogma Munificentis Simus Deus.⁸ But, not her subsequent round-trips to Earth! Pius XII MUST have known the "rest-of-the-story..."

Others of lesser stature are alive in time dilation too. This is how the fourth book of Ezra ends, "Then I, Ezra, was carried off and taken up to the place of my peers." The Moslems affirm that their leader Muhammed ascended into heaven from the rock on which Issac offered his son as sacrifice to God. A 4th century priest, Berossus, describes yet another spaceship departure of humans, "Him (King Xisuthrus) they saw no more; but they could distinguish his voice in the air, and could hear him admonish them...that he was translated (that word again meaning carried into the warp of time dilation?) to live with the gods; that his wife and daughter, with the Pilot (!) had obtained the same honour."

Look, there have been many other ascensions and re-appearances noted in all religions and civilizations. Obviously the founders and purveyors of religions WHO KNOW that these happenings are not what they represent them to be, either twist reality into its exact opposite, or continue to conceal it right up to today--we are the first generation entitled to hear this from the pulpit, i.e., "OK, the Israelites & Apostles confused GOD with visiting spacemen."

Perhaps a word or two on the spacehips "crew" is in order. Sometimes called "Lord" in the Bible, "angels", "messengers", "gods," "Yahweh," "Jehovah", these are only humans in their space vehicles, themselves a product of a natural evolution whose only real difference from ours comes from the fact that it took place thousands of years earlier, elsewhere in the cosmos. Ezekiel in 1:26 describes them as "a likeness as the appearance of a man." Those two men in white apparel (Acts 1:11) were not different in body shape or movement from humans as they were known to those Apostles else they would have noted dissimilarities. Even the brother of Jarad in The Book Of Mormon was amazed to find the 'Lord' just a human, "And he saw the finger of the Lord, and it was the finger of a man, like unto flesh and blood. For I knew not that the Lord has flesh and blood."⁹ Words from a perceptive eye-witness ready to believe other than what his senses told him, and not afraid to report something entirely new to him, 'for I knew not that the Lord has flesh and blood.'

May, I repeat that it's evident the ancients confused astronauts (human beings) with God. And regrettably for all of

us who came after them, some knew, some today MUST know--but they say nothing! Evident also the ETI's didn't bother to correct their image, themselves enjoying the EGO-trip no doubt. Or, what I like to call the world's longest put-on. What else?

A psychological profile of these extraterrestrials was offered by George Sasoon, holder of an Honours Degree from Cambridge University in Natural Sciences. In lecture before the Sixth World Conference of the Ancient Astronaut Society in Munich Germany, June 1979¹⁰ he said,

In fact, the Lord described in the books of Moses is clearly not identical with God. Many aspects of his behavior are very human. He is clearly neither omniscient nor omnipotent, he has fits of temper, he haggles with Moses like some bazaar trader, and Moses often gets the better of him. No, the Lord of the Bible is certainly not identical with God himself; he is merely a living being, who possesses immense technical resources, but who intellectually and emotionally is not greatly superior to ourselves.

Josef¹¹ F. Blumrich, NASA designer engineer of Saturn V and author confirms their awesome technology in estimating it will take us twenty years before we've developed fuel duplicating the thrust of the "Lords" 2,500 year old spaceship!

May I report that they were most certainly NOT amphibious half-fish, half-man creatures so naively described by various ancients quoted in The Sirius Mystery.¹² Author Temple's unswerving conviction of this error seems all the more strange for, on his pg. 257 he quotes one Photius (circa 840AD) as catching on, "...and that he was actually a man, but only SEEMED a fish because he was clothed in the 'skin of a sea-creature'. Read your book, Mr. Temple!

Remember I said "but only temporarily" regards Christs' ascension? Well, author Louis Pauwels explains the "how" of Christs's several returns to Earth, and author Eric von Daniken provides the "when" and "where",

Traveling at close to the speed of light a space ship will be bombarded with significantly more cosmic rays and particles. The radiation dose would be fatal to the occupants. Some kind of equipment is therefore necessary to protect the occupants. The answer is an artificially generated magnetic protective wall. Occupants would notice nothing unusual; daily food and water and other amenities would be provided, gravity simulated, and Time as passing normally. But, traveling at velocities close to the speed of light is a conquest not only of space, but also of Time. The future becomes accessible to those aboard which allows for the real PHYSICAL POSSIBILITY OF COMMUNICATING WITH POSTERITY.¹³

Christ and Mary and, as we've seen, Moses and Elijah have been just so indulging themselves by frequently re-visiting Earth albeit enigmatically,

Recall those two men in white apparel, Acts 1:11? They positively guaranteed re-appearances like the above will occur, "This Jesus who was taken up from you into heaven, will come in the same way as you saw him go into heaven."¹⁵ That is as explicit as "Fly PAN-AM Round-trip!" And behold, come in the same way He has throughout 655 years--so far, that is. ...ah, of the above ten comings, which one was the much heralded as the "still-in-the-future" "Second Coming"? So please, author Hal Lindsey,¹⁶ the "second coming" has already come and gone. Ten times over. And--without Armageddon. So quit putting-on the people? (note to the reader: if you really want to know what the gods are up to, read Marc Dem's book, THE LOST TRIBES FROM OUTER SPACE, Bantam NY, 1977.)

While I'm at it, so much for religion correspondent to ROLLING STONE Michael Thomas: he thought he had quite an avant-garde idea that a US team of bio-chemists in contemplating the DNA allegedly imbedded in "The Shroud Of Turin"¹⁷ might give them a capability to clone Him. No need to boys, the Original's very much alive, visiting Earth regularly.

Notice the similarity to other UFO sightings,

So, there they are. Rather HERE THEY ARE! Our time-dilated cosmos-commuters who have been identified by others, or have identified themselves to us down through the centuries thus far as living, breathing, flesh and blood folk. A bit older, about 27 years, yet still alive nonetheless.

But don't hold me naive that I can't dismiss the re-appearances above as only visions of fanatics. However I do believe those ascensions I referred to herein were not an act of God: they were an act of Man, therefore, we (Man) can deal with it. And can deal with any "therefore's" or "Now What?" based on my premise that Jesus Christ is only 61 years old today.

Though this beats me, with the crew(s) access to all that super-technology going for them, why do they persist in putting us on?

Finally may I register a frustration with other researchers? None of them did it so I had to do it for them: author Eric von Daniken only put Enoch IN a spaceship,¹⁹ author the Rev. Barry H. Downing only extrapolated Christ as IN a spaceship.²⁰ "IN", and where? Still parked in the middle east desert? Sadly none of the writers in the ETI/UFO field reached this point:-- since Einstein's theorem regarding occupants in a spaceship says they're not limited to the 55 m.p.h. speed limit, Meyers time dilation table applies. They could have reported the biblical personages particularly Jesus Christ as alive and well, thank you, literally right on our doorstep--but didn't.

I say that they are living because, future time is the Past being funny in that in any present time it can co-exist with the future. So, like a flat stone skipped over water, they will dip in and out of our Earth-time.

But then nobody including me sat down and put it all together in one go,

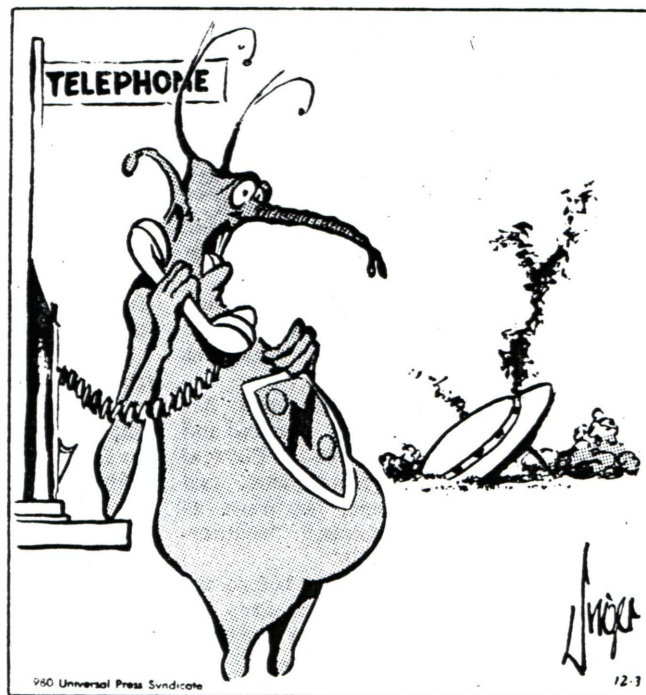

In his research into the FBI files Barry Greenwood was able to uncover the in-closed materials relating to a mysterious photo received by the FBI on May 24, 1950.

Inclousures to the FBI Bureau included a copy of the report by Intelligence Branch, New Orleans Port of Embarkation, one negative copy and one positive copy of photographs of flying saucers and a man from Mars in the custody of two MP's.

When Barry received these files he did not receive a copy of the actual photo nor the negative, as it was stated the photos had long ago been thrown away! All that was received was a bad xerox copy.

The story says that in May of 1950 the photo was turned over to an agent of the CID, New Orleans Port of Embarkation. The person who turned over this photo said he had purchased the photo from (this persons name is CENSORED from the file record), for the sum of 1.00. The person who had purchased the photo said he thought this material should be placed into the hands of the Government, as it was supposed to be pictures of flying saucers and a man from Mars in the custody of two military policemen.

Comments at the end of one FBI memo (inclosed) state " a literal translation of the captiones under the alleged photos stated that a special infra-red machine was used to take these photos because the flying saucers were invisible to the human eye. Also, the sound emitted by the pictured saucers was of such high frequency as to be above the hearing of the human ear. An accident had occurred to one of the saucers and the individual shown in custody of United States Military Police in the right hand photo was a Mr. X a member of the crew of one of the saucers. The location of both the photos was said to be Weisbaden, Germany.

Written across the May 31, 1950 memo (inclosed) at the bottom is an interesting comment by one of the officers. He said " matter discussed with Col. Bordon, OSI. He advised that hundreds of such matters are received by A.F. They do not consider them worthy of investigation." It is dated 6-21-50.

In the Governmental file research done by UFOIN members, there have never been uncovered "hundreds" of such reports. According to historical ufological files, as a matter of fact, "alien" photos are rare, and only a few are currently part of the ufo movement. It is also sad that we were not able to obtain an actual copy of the photo, the subject matter of this report.

To take care of that situation, I had Larry Blazey, a UFOIN staff artist, do a professional breakdown of the bad xerox copy and re-draw it. In this way he was able to reproduce a 99.9% accurate image in the form of a drawing.

The results are inclosed in this report. I feel he did a good job.

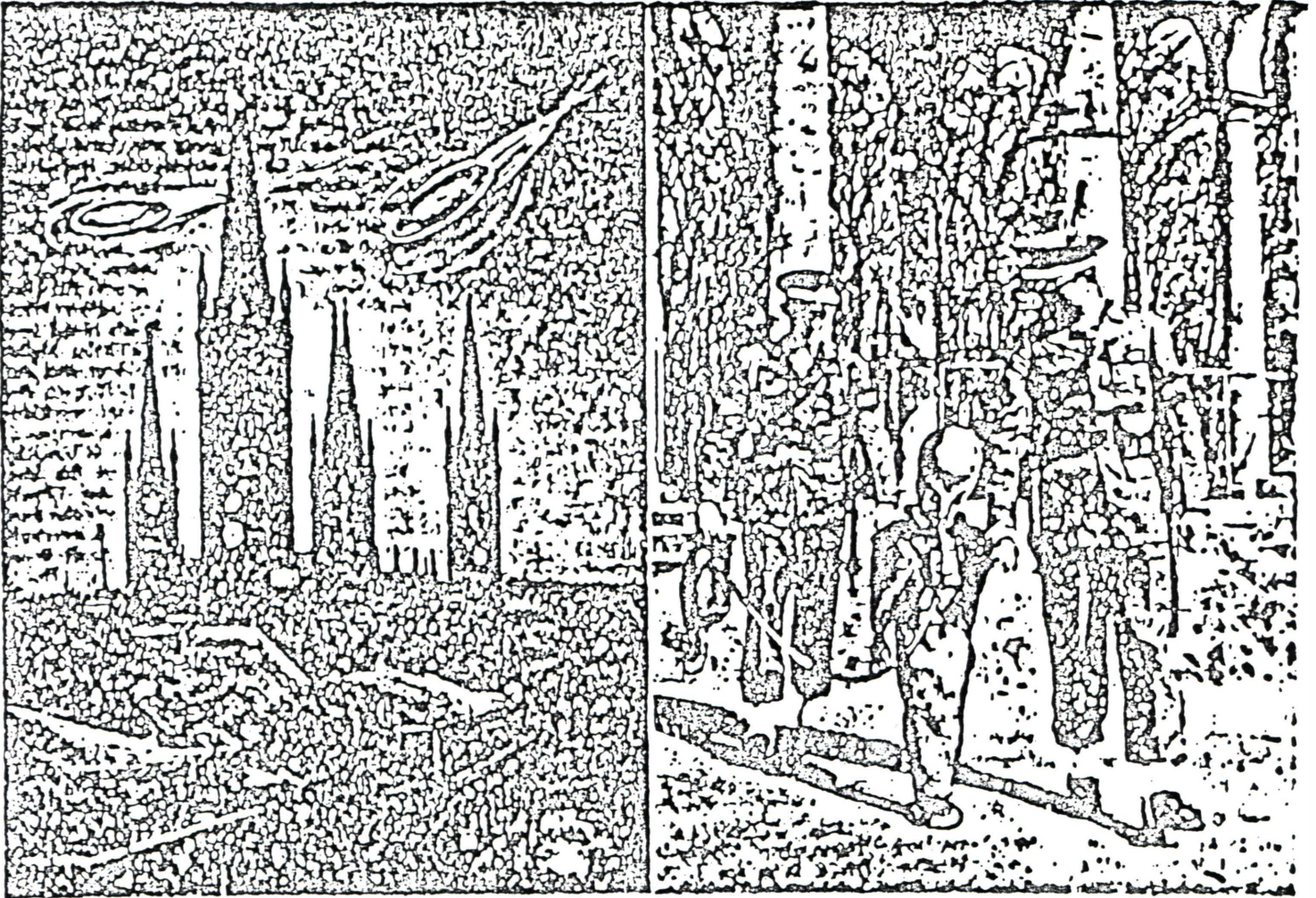

The UFO media and researchers may feel free to qoute or reproduce this report as they see fit, as long as proper credits and address is given.

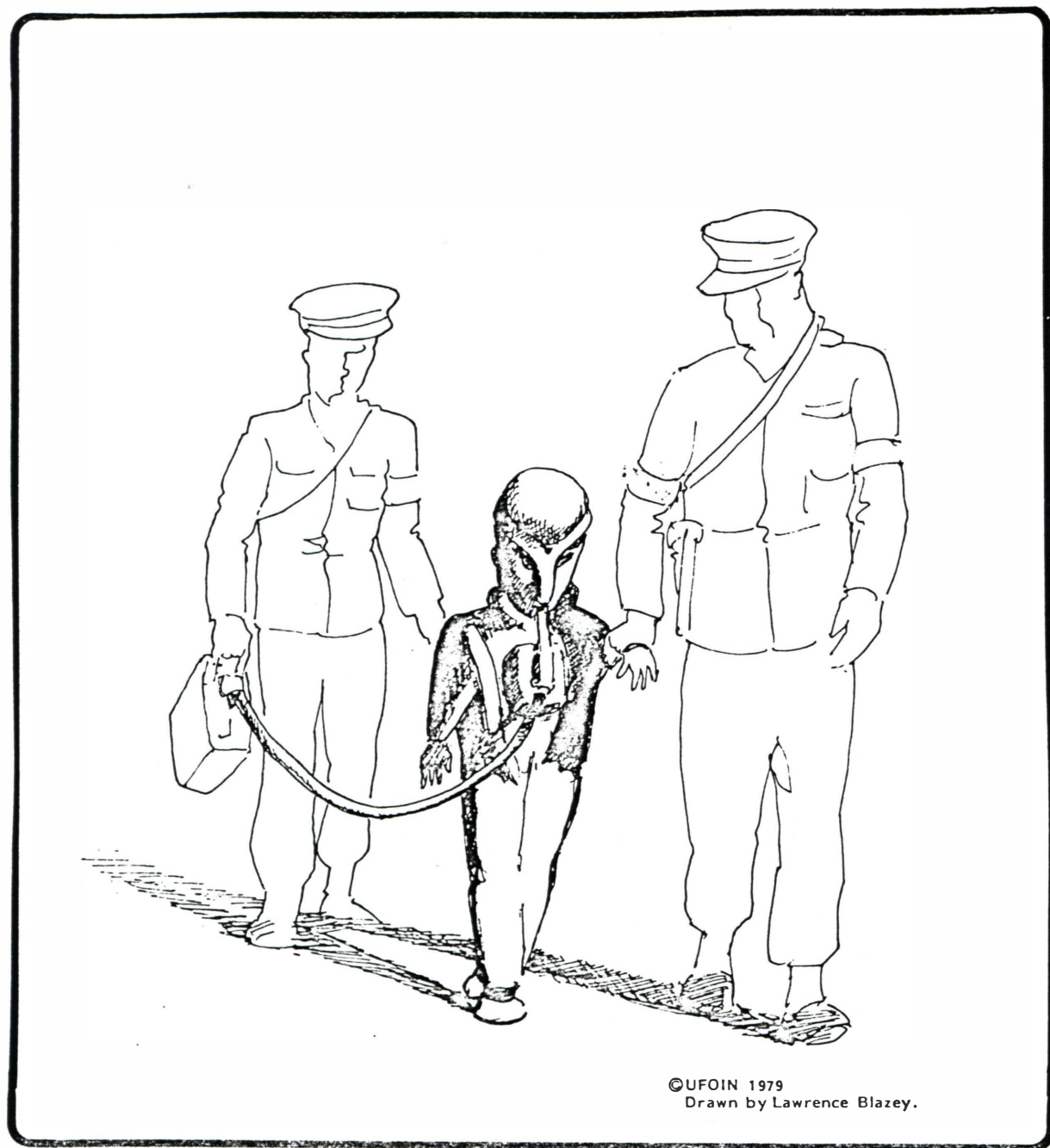

At about 1400 hours, 22 May 1950, the attached (See Enclosure 1) "photographs" was turned over to Agent John V. Quinn, CID, New Orleans Post of Information. The individual who turned this material over to Quinn told him that he had purchased the "photograph" from one [redacted] for the sum of \$1.00. He stated that he thought this material "should be placed in the hands of the Government", as it was supposed to be pictures of "flying saucers" and "a man from Mars in the United States". The "man from Mars" was pictured as being in the custody of two military policemen. (P-2)

The individual turning this material over to Quinn gave his name as [redacted] (P-2)

According to [redacted] he alleged to have served five (5) years in the Federal penitentiary at Leavenworth, Kansas. (P-2)

An interrogation of [redacted] was conducted by Agent Quinn. (P-2)

Comments: A literal translation of the caption under the alleged photographs stated that a special infra-red machine was used to take these photographs because the "flying saucers" were invisible to the human eye. Also, the sound emitted by the two pictured "saucers" was of such high frequency as to be above frequency or audible to the human ear. The caption continues by stating that an accident occurred to one of the "saucers" and the individual shown in custody of United States Military Police in the right hand photograph was a "Mr. E", a member of the crew of one of these "flying saucers". The location of both photographs was stated to be Weisbaden, Germany.

The first encyclopedia of its kind, *The Encyclopedia of UFOs* is accurately described as "a comprehensive and objective A to Z of sightings, personalities, theories, and feature articles," yet it is more than that. It contains one hundred UFO sighting and contact cases as well as some rather convincing photographs and illustrations. Unfortunately, the encyclopedia does not contain the clearest or best UFO photographs in existence today and, being general in outlook, is limited to only 100 of the thousands of fascinating UFO stories around. It is, however, a useful tool for both the sincere UFOlogist and the curious layman who prefers to browse through factual experiences than to read science fiction.

The book includes information on such well-known figures as George Adamski, author of *Inside the Spaceships* and *Flying*

Saucers Have Landed, as well as people in all walks of life who have had an unusual experience with those lights from the sky.

Editor Ronald Story does not make it easy for the reader to decide whom or what to believe since the researchers and scientists questioned seem vague about the cause of the UFO phenomena. There is only the general consensus that something is flying up there, be it ball lightning, weather balloon, psychic manifestation, new weather manifestation or genuine extraterrestrial spaceship. There are too many instances of UFO sightings for the phenomena to be dismissed as world-wide mass hysteria.

People are seeing something and so far scientists do not have enough tangible physical evidence of extraterrestrial spaceships to prove their existence without a shadow of a doubt. Once the scientists have physical proof of the UFO phenomena, however, and can categorically prove what those strange lights in the sky really are, how will they manage to inform the public without causing a general panic? Indeed, if scientists told the general public today that UFOs do exist and that they are extraterrestrial in origin, how would people brought up on science-fiction horror movies like *Alien* react? Would they remember the joyful little "people" from *Close Encounters of the Third Kind* and the delightful characters from "long, long ago in a galaxy far, far away" (*Star Wars*)? Only time will tell. Meanwhile, *Encyclopedia of UFOs* can open the doors of your mind.

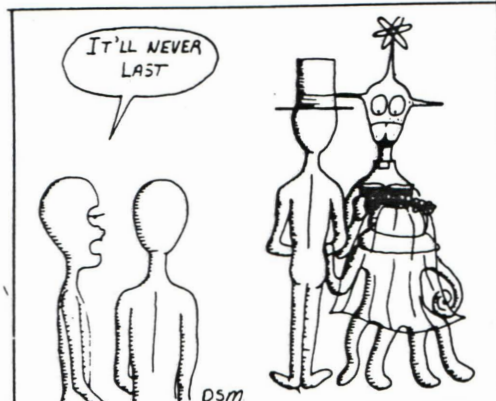

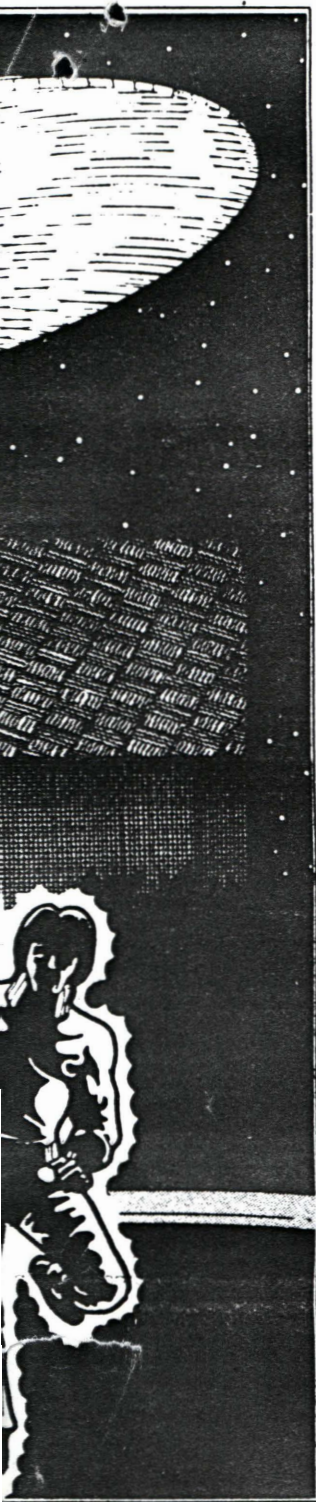

UFO SIGHTINGS, LANDINGS AND ABDUCTIONS THE DOCUMENTED EVIDENCE

Canadian author-broadcaster Yurko Bondarchuk has compiled the most comprehensive book ever written on Canadian UFO sightings, landings and abductions. After two years of exhaustive research, Bondarchuk has documented over 60 factual and evidence-packed cases of UFO sightings, including 100 photographs and line drawings, concluding that UFO's exist, they are involved in data-gathering activities and that the Canadian government recognizes the situation.

Mr. Bondarchuk, a member of MUFON, combines fact and possibilities in explaining what UFOs are, where they originate and in answering the most intriguing of questions, why they are here. He also devotes space to the possible reasons behind the government cover-up of any UFO-related material.

Some of the examples he furnishes of UFO experiences are highly intriguing. One of the most amazing is the story of Stephen Michalak, an industrial mechanic from Winnipeg, Manitoba, who actually touched a UFO. "It tilted, expelling a blast of hot air from a grid-like vent underneath, Stephen Michalak's shirt caught fire (and) he tore off his shirt, revealing an ugly grid-like burn on his skin." Mr. Michalak was plagued by bouts of nausea, headaches, blackouts, skin rashes and body swellings at three month intervals from that time on. Twenty-seven different doctors were unable to pinpoint the nature of his ailments until specialists at the Mayo Clinic treated him. When the soil at the landing spot was checked, "a significant level of radiation in the form of Radium 226, for which radiologists could provide no explanation" was found and, though "the results of the Clinic's diagnosis remain confidential, it was reported by various ufological publications that a chemical impurity had been detected in Michalak's blood."

The Non-Meteoritic Sightings File DND 222 reads in part, "Neither the DND, nor the RCMP investigation team were able to provide evidence which could dispute Mr. Michalak's story." Yurko Bondarchuk goes on to explain that vegetation and soil are often damaged by "ex-

posure to heat, believed to be microwave radiation" emanating from UFOs.

Bondarchuk notes that when Barry Mather, (NDP-Surrey, B.C.), a Member of the Canadian Parliament, was finally allowed to see the documents pertaining to Michalak's encounter 15 months and a good deal of lobbying later, "several pages were missing" and Yves Forest, parliamentary secretary to the president of the Privy Council said the deletions were "interdepartmental reports, the publication of which would not be in the public interest."

One of Bondarchuk's examples could well be considered one of the rare cases of space beings landing in a city. After Mrs. Florida Malboeuf of Casgrain St. in Montreal, Canada, saw a UFO land on the apartment building across the street and watched two tall, thin beings appear, unusual footprints "unlike any seen before" were found there. They measured only 6 inches long and 1.7 inches wide and curved toward the inside. There was no stairwell leading to the almost inaccessible roof. What had caused the imprints? Bondarchuk obviously is rooting for space beings.

Yurko Bondarchuk has done an excellent job of categorizing all aspects of the UFOs in an objective fashion, but one of the most thought-provoking parts of the book is the foreword by nuclear physicist Stanton T. Friedman who lists the reasons behind the government cover-up on UFOs. One of them indeed shows how limited man can be: "Any announcements confirming that some UFOs are intelligently controlled extra-terrestrial craft inevitably would result in a push by youth of the world for an Earthling rather than a nationalistic orientation. Clearly, no government on this planet would want its people to owe primary allegiance to the planet rather than to the country, in view of the fact that in the name of nationalism, governments spend about four hundred thousand million dollars each year for military purposes."

Friedman goes on to say: "To the 'aliens' we are all Earthlings, and there is no better way to see ourselves than through their eyes. We must appear to them like a primitive society, spending most of its energies actively engaged in tribal warfare. It is time to begin the long and difficult task of establishing an Earthling orientation."

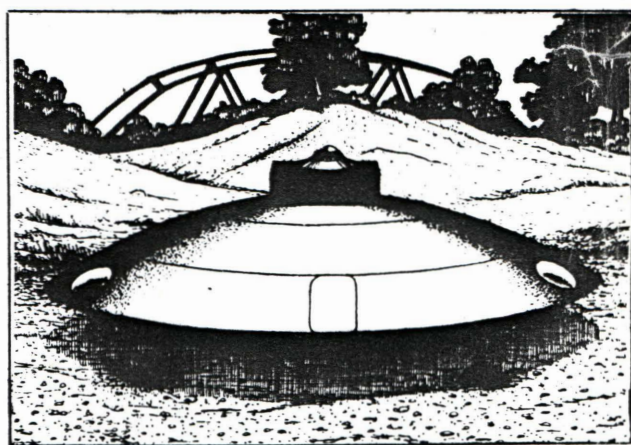
"In less than one hundred years, we shall be travelling to
