Was taken up astrally by the Hamilton Bay into a ship, did nothing but checked his circulation.


All started 30 years ago, saw a holographic image of M.I.B.

Tom Theofanous gave us updates on the Carp, Ontario, UFO case, which was highlighted on "Sightings" TV show, on May 21st. Tom visited the area recently and talked to several people. Tom found out from the townspeople who the "Guardian" supposedly is and talked to him. He refused to admit to being one and the same. The "Guardian" is considered to be flaky, eccentric by the townspeople. He is protected by his friends, who won't talk about him. In October, 1991, "The Guardian" sent out a video of a craft landed in a field and a polaroid shot. This was sent to Tom Exeter and Timothy Good from England. Tom received a video with audio, Exeter received it without. Timothy received more detail than Tom or Exeter. Lady who owns the property where the craft landed, claims it came down. She is married to a dentist, and both husband and wife are friends of the guardian. There is a kennel on the property, with many dogs. How was the guardian able to video tape the craft, with audio, and no dogs are barking? Exeter tried to flush out the guardian. He made money out of the sighting and was on Unsolved Mysteries. He plans to write a book and to have a movie made. Tom could not find any evidence of landing at Carp, no circular evidence found. Dear Bonnie:

I am writing to you in regard to our phone conversation on March 18, 1993.

We were discussing the topic of U.F.O.s, my son and I have had 27 sightings of the crafts and since close sighting of the small spheres in which the U.F.O. lets out to search the area, these are known as probes.

I am only going to describe three of the most exciting sightings as it will be too many sheets to cover all that we have seen.

First I must explain that when I refer to the sightings as crafts, I am very sure that is what they were. However my son wants me to be very clear to you, what we saw were moving lights in the sky, my son has been giving me a hard time as I am writing this letter, he keeps insisting we do not know what they were so we cannot call them crafts. SIGHTING No. 1

I told him to write his own letter and leave me alone.

We had two lights follow us three years ago at night as we were leaving London Ontario heading for Wingham.

It was late at night the sky was very clear, as I was doing the driving he was enjoying the scenery for what you can see at night, anyway he spotted these two white lights low to the ground, possibly tree top level. on his side of the car

He immediately told me, so I took a look as I was driving and being there was hardly any traffic.

As we drove these two lights moved right along with us, we drove until I began to realize I was coming to the outskirts of Exeter, at that moment I decided to pull over and I remember mentioning to my son of my intentions.

As I did this and stopped the car, the two lights stopped and immediately went from white to orange, and one of the lights raced upward into the sky leaving the other light behind. As it went up it suddenly came back down to join its friend.

While all this is going on I noticed an intersection ahead of us so I decided to drive down the gravel road toward the lights. All this while we were still observing the lights.

As we drove we came to a farm house near the road all lit up. I suggested to my son we stop and get the people in the house to come out and see this unusual event with us, my son said forget it lets enjoy this ourselves. I wish to mention as we were trying to decide for the farm house we were parked

and as we were sitting there debating on the farm house we saw a car approaching us, and we are very confident it ~~crashed~~ ^{stalled} out, we saw its lights go out and saw it stall, we immediately said to each other the U.F.O. must be close. After a few minutes the car started again and finally drove past us.

We continued down the road hoping for a personal encounter. the road came to a dead end, there was bush all around us and we felt very ~~un~~ uncomfortable to be there, we stayed maybe 10 minutes and decided to get back to the main highway.

As we reached the main road we looked back and realized the lights were gone, so we proceeded for Wingham.

SIGHTING NO. 2
~~Another~~ interesting sighting occurred at night behind the Wingham high school in the night sky, I would say the distance of an air liner. The object was moving very slow, I believe it was triangle in shape and was black as all we could see were three white lights in a triangle. What drew our special attention was while it was proceeding across the sky it suddenly stopped and stayed motionless in the sky, we watched it for two hours and it did not move, we finally had to go home, as I had work the next day.

Our other and final experience occurred on a paved highway where I drive to pick up

my wife at her job, she works up until dark each night.

SIGHTING NO. 3

~~One particular~~ night as we were driving, my son noticed a red ball of light coming over the fields the distance of a low flying *cesna*.

It flew along with us but it stayed ahead I tried to catch up by driving up to 70 mi. per hour, it still remained ahead.

We kept up with it for a good two miles or more, when it suddenly came over the high voltage wires along the highway, we thought it was going to cross the road so I drove faster, I managed to almost get up to it, I stopped the car got out it stopped for a brief moment than backed off and headed across the fields and out of sight.

According to the U.S.O. documentaries we recording off the T.V., these red balls of light are known as probes.

We saw this type of light 9 times complete I have drawn three brief drawings to try and help you to understand our sightings.

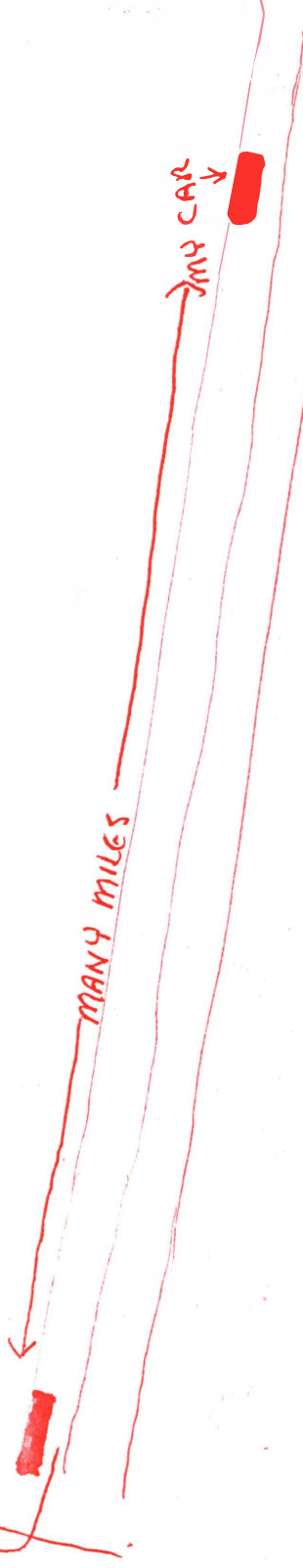

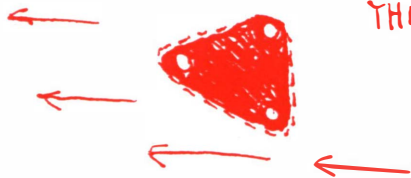

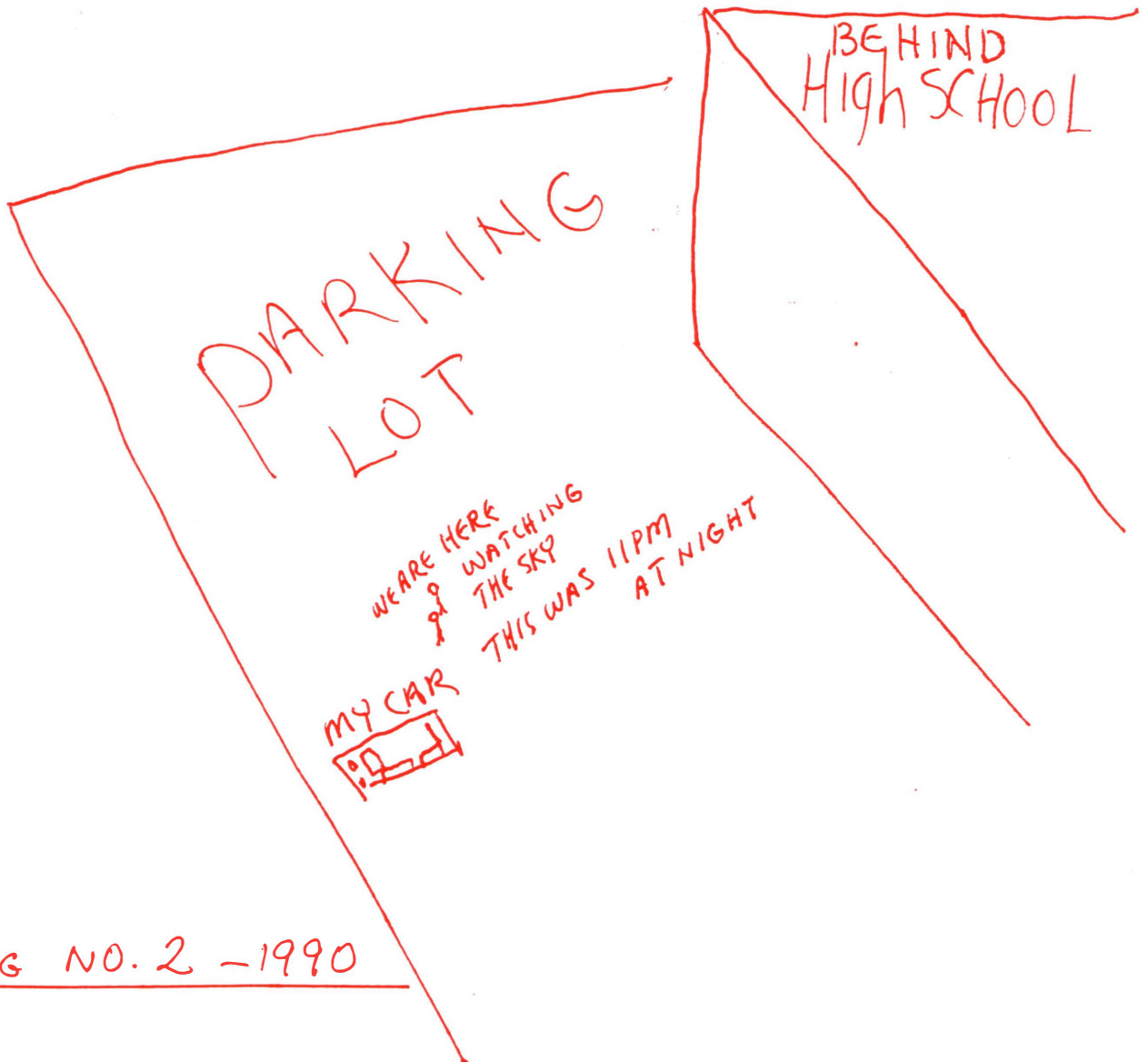


ARROW SHOWS



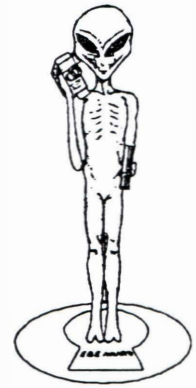

NBC has been corresponding with me and others involved in the case for about three years, and has at last set a production schedule. I will be flown to the shoot to be interviewed in June, along with the

Michalak family and Ed Barker. This would be the equivalent of Bill Moore and Kevin Randle, or Stanton Friedman and Jenny Randles, working together in harmony on a UFO project. However, since I believe that the airing of a segment on the Michalak case might jog someone's memory and help in uncovering details (or even SOLVE!) the case, I have no qualms about working with others with whom I do not agree.

For those of you who do not know about the case, in 1967, Stefan Michalak had a CE2 experience while prospecting in eastern Manitoba. One of two saucer-shaped craft landed near him, and he was burned by its exhaust; radioactive soil and unusual silver fragments were later found at the site. Apparently the special effects for the TV show will be quite spectacular, involving "stunt men" and "pyrotechnics". I would assume that it will be broadcast this fall.

FOREWORD

When I was approached by Stephen Michalak to write the English version of his story, I was sceptical. I did not believe in the existence of extra-terrestrial life, and the phenomena called UFOs.

After helping with the English translation of the original Polish manuscript by Mr. Michalak I began to wonder if I had been wrong. I wondered if perhaps there could have been a landing at Falcon Lake on May 20, 1967.

But I still wasn't convinced.

I talked to several people mentioned in the book. I read accounts of the sighting which appeared in the press and in magazines. And after weighing all the facts, I felt sure that Stephen Michalak did indeed witness the landing of an alien craft.

A word on the original text. Mr. Michalak has made notes on his observations, and events that followed. Recently he compiled these into chronological account of what happened in Polish, his native language. His only purpose in doing so was to inform the public of this uncanny occurrence and the strange effects it had upon him.

Through talking with him, I have found that he is not a man who would exaggerate or distort or fabricate such a tale. The events described in this book are true.

It is interesting to note that the Canadian Press carried a report on November 6th, 1967 saying that the Government of Canada refused to disclose any information they had discovered during investigation of the claims by Mr. Michalak.

In the words of Defence Minister Cadieux, "it is not the intention of the department of national defence to make public the report of the alleged sighting."

If the investigation had shown that the "alleged sighting" was pure fabrication, is it not conceivable that the government would have made it known, and cleared up any doubts or fears the public may have. But instead, the federal government chose to remain silent. This can mean only two things: either they have definite proof, unknown to Mr. Michalak and myself, or they know something extraordinary happened but can not or dare not explain it.

It is up to you, the reader, to make your own decision.

INTRODUCTION

My name is Stephen Michalak. I was born 51 years ago in Poland. After the turbulent years of the Second World War that started in my homeland, and due to the events that followed, I was forced to leave my country and go abroad.

In 1949 I came to Canada, and some years later, settled in Winnipeg, Manitoba. I live with my wife, two sons and a daughter in a modest home. I have a steady income from my job as a mechanic at the Inland Cement Company. Two of my children attend the University of Manitoba. We live a happy, satisfied life of average Canadians, fully enjoying all the blessings this country is offering us.

Up until the time and the events I am about to describe I had no special interest in "flying saucers" and other strange phenomena one hears about time and again. I heard and read about them, but they meant to me about as much as the Loch Ness monster. Maybe they are real, maybe not, but I had never been seriously concerned about them.

Not until May 20, 1967, when I, perhaps as nobody else - or at least very few - came in such a close contact with one of those strange objects commonly called UFOs.

How it all began, how I happened to be in the vicinity of the actual landing of the UFO and my strange encounter with it - will be explained hereinafter.

I am what one may call an amateur prospector. For

many years, mostly early in the Spring, this being the most favourable time for prospecting in the wooded and rocky terrain of eastern Manitoba, I go and look for minerals. I have even made a few claims.

When the Spring of 1967 came I decided to spend the first long weekend in the Whiteshell area - lying about 80 miles east of Winnipeg.

So, early in the evening on Friday, May 19th, I took the Greyhound bus to Falcon Lake and settled down for the night in a motel with the idea of getting up early in the morning and "trying my luck", as I said to myself.

Little did I know then what kind of "luck" I was to find the next day.

THE LANDING

It was 5.30 A.M. when I left the motel and started out on my geological trek. I took with me a hammer, a map, a compass, paper and pencil and a little food to see me through the day, - wearing a light jacket against the morning chill.

The day was bright, sunny - not a cloud in the sky. It seemed like just another ordinary day, but events which were to take place within the next six hours were to change my entire life more than anyone could ever imagine. I will never forget May 20, 1967.

Crossing the Trans-Canada Highway from the motel on the south side, I made my way into the bush and the pine forest on the north side. After travelling some distance I got out my map and compass and orientated myself.

By 9 o'clock I had found an area that particularly fascinated me because of the rock formation near a bog along a stream flowing in the southward direction. I was searching for some special specimens that I had found on my earlier expedition.

My approach had startled a flock of geese, but before long they became accustomed to my presence, quieted down and went about their business.

At 11 o'clock I began to feel the effects of the breakfast I did not eat that morning. I sat down and took out the lunch I had brought with me. Following a simple meal of smoked sausage, cheese and bread, an apple and two oranges washed down with a couple of cups of coffee, and after a short rest, I returned to the quartz vein I was examining. It was 12.15, the sun was high in

the sky and a few clouds were gathering in the west.

While chipping at the quartz I was startled by the most uncanny cackle of the geese that were still in the area. Something had obviously frightened them far more than my presence earlier in the morning when they gave out with a mild protest.

Then I saw it. Two cigar-shaped objects with humps on them about half-way down from the sky. They appeared to be descending and glowing with an intense scarlet glare. As these "objects" came closer to the earth they became more oval-shaped.

They came down at the same speed keeping a constant distance between them, appearing to be as one inseparable unit, yet each one completely separate from the other.

Suddenly the farthest of the two objects – farthest from my point of vision – stopped dead in the air while its companion slipped down closer and closer to the ground and landed squarely on the flat top of a rock about 159 feet away from me.

The 'object' that had remained in the air hovered approximately fifteen feet above me for about three minutes, then lifted up skyward again.

As it ascended its color began to change from bright red to an orange shade, then to a grey tone. Finally, when it was just about to disappear behind the gathering clouds, it again turned bright orange.

The "craft", if I may be allowed to call it a craft, had appeared and disappeared in such a short time that it was impossible to estimate the length of the time it remained visible. My astonishment at and fear of unusual sight that I had just witnessed dulled my senses and made me lose all realization of time.

I cannot describe or estimate the speed of the ascent because I have seen nothing in the world that moved so swiftly, noiselessly, without a sound.

THE CRAFT

Then my attention was drawn back to the craft that had landed on the rock. It too was changing in color, turning from red to grey-red to light grey and then to the color of hot stainless steel, with a golden glow around it.



The type of goggles I was wearing to protect my eyes from the rock chippings proved to be beneficial also when encountering UFO.

I realized that I was still kneeling on the rock with my small pick hammer in my hand. I was still wearing goggles which I used to protect my eyes from the rock chips.

After recovering my composure and regaining my senses to some degree I began watching the craft intently, ready to record in my mind everything that happened.

I noticed an opening near the top of the craft and a brilliant purple light pouring out of aperture. The light was so intense that it hurt my eyes when I looked at it directly. Gripped with fear and excitement, I was unable to move from the rock. I decided to wait and watch.

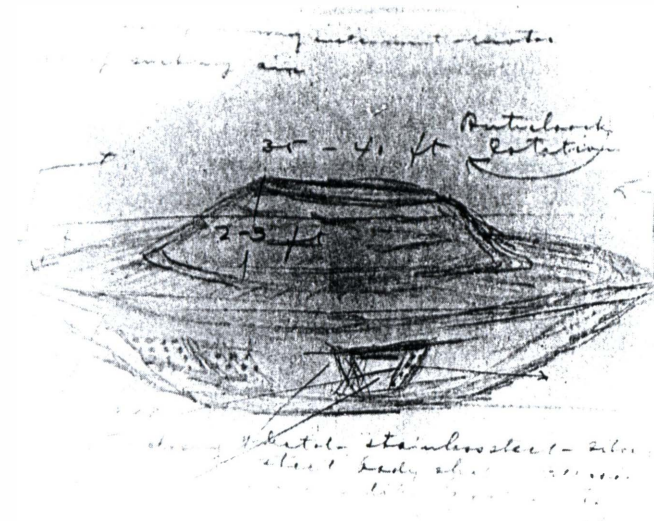
Soon I became aware of wafts of warm air that seemed to come out in waves from the craft, accompanied by pungent odour of sulphur. I heard a soft murmur, like the whirl of a tiny electric motor running very fast. I also heard a hissing sound as if the air had been sucked into the interior of the craft.

It was now that I wanted a camera more than anything else, but, of course, there is no need for one on a geological expedition. Then I remembered the paper and pencil that I had brought with me. I made a sketch of what I saw.

By now some of the initial fear had left me and I managed to gather enough courage to get closer to the craft and to investigate. I fully expected someone to get out at any moment and survey the landing site.

Because I had never seen anything like this before, I thought it may have been an American space project of some sort. I checked for the markings of the United States Air Force on the hull of the craft, but found nothing.

I was most interested in the flood of lights that poured out of the upper reaches of the craft. The light, distinctly purple, also cast out various other shades. In spite of the bright mid-day sun in the sky, the light

cast a purple hue on the ground and eclipsed the sunlight in the immediate area.

I was forced to continually turn my eyes away from the light which made red dots to appear before my eyes every time I looked away.

I approached the object closer, coming to within 60 feet of the glowing mass of metal. Then I heard voices. They sounded like humans, although somewhat muffled by the sounds of the motor and the rush of air that was continuously coming out from somewhere inside. I was able to make out two distinct voices, one with a higher pitch than the other.

This latest discovery added to my excitement and I was sure that the craft was of an earthly origin. I came even closer and beckoned to those inside:

“Okay, Yankee boys, having trouble? Come on out and we’ll see what we can do about it”.

There was no answer and no sign from within. I had prepared myself for some response and was taken aback when none came. I was at a loss, perplexed. I didn't know what to do next.

But then, more to encourage myself than anything else, I addressed the voices in Russian, asking them if they spoke Russian. No answer. I tried again in German, Italian, French and Ukrainian. Still no answer.

Then I spoke again in English and walked closer to the craft.

By now I found myself directly in front of it and decided to take a look inside. However, standing within the beam of light was too much for my eyes to bear. I was forced to turn away. Then, placing green lenses over my goggles, I stuck my head inside the opening.

The inside was a maze of lights. Direct beams running in horizontal and diagonal paths and a series of flashing lights, it seemed to me, were working in a random fashion, with no particular order or sequence.

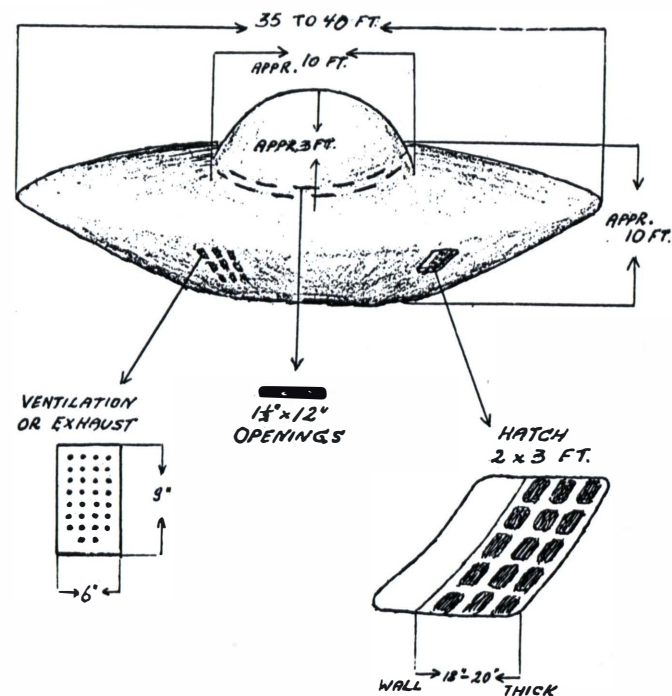
Again I stepped back and awaited some reaction from the craft. As I did this I took note of the thickness of the walls of the craft. They were about 20 inches thick at the cross-section.

Then came the first sign of motion since the craft touched down.

Two panels slid over the opening and a third piece dropped over them from above. This completely closed off the opening in the side of the craft.

Then I noticed a small screen pattern on the side of the craft. It seemed to be some sort of ventilation system. The screen openings appeared to be about 3/16 of an inch in diameter.

I approached the craft once again and touched its side. It was hot to the touch. It appeared to be made of a stainless steel-like substance. There were no signs of welding or joints to be seen anywhere. The outer surface was highly polished and looked like colored

glass with light reflecting off it. It formed a spectrum with a silver background as the sunlight hit the sides.

I noticed that I had burned my glove I was wearing at the time, when I touched the side of the craft.

These most recent events occurred in less time than it takes to describe them.

All of a sudden the craft tilted slightly leftward. I turned and felt a scorching pain around my chest; my shirt and my undershirt were afire. A sharp beam of heat had shot from the craft.

I tore off my shirt and undershirt and threw them to the ground. My chest was severely burned.

When I looked back at the ship I felt a sudden rush of air around me. The craft was rising above the tree-tops. It began to change color and shape, following much the same pattern as its sister ship when it had returned to the sky. Soon the craft had disappeared, gone without a trace.

AFTERMATH

As I stood there with a thousand thoughts racing through my mind, I was unable to move or to act. I was taken aback by fear and bewilderment. It was hard to believe that these things actually happened to me.

Reason told me, that it had to be some earthly thing, but evidence pointed out to something else. I recalled, as I stood gazing at the rock where only seconds ago the craft had sat, an article I once read in Life magazine. It told of other civilizations on other planets, other worlds. At the time I took it with a grain of salt, believing it to be the result of someone's fertile imagination. Now I began to wonder whether there was not some foundation for it after all.

The odour, that reminded me of an odour of burning electric motor mixed with a strong smell of sulphur, still hung in the air. Looking down, I noticed some dry moss burning near my discarded shirts. Automatically, I stamped out the fire with my feet. The woods were extremely dry and a fire now could possibly trap me.

Again I turned my thoughts to the events and scenes I had just witnessed. Walking over to the rock where I had left my bag and compass, I began to pick up my things.

When I looked at the compass I saw the needle whirling around, completely out of control, as if some strange magnetic force had been controlling it. Seconds later it became still, working normally.

Somehow my desire for prospecting had vanished. I decided to go over to the landing site and make a thorough inspection of the place where the craft had touched down.

As I approached the site I felt nauseate and my head began to ache. The spot where the craft had come to rest looked as if it had been swept clean with a broom. There was no debris of any kind on the rock. No twigs, bits of stone – nothing. It had all been piled up in a six inches deep circular mound about 15 feet in diameter.

As I stood there examining the spot, the pain in my head became more severe. Waves of nausea increased and I broke out in a cold sweat.

I knew that something totally unnatural had happened to me and, apparently, it was having adverse effect on my physiology.

I might add that up to this time I had been as healthy as any man could expect to be. My weight was a constant 180 pounds, and I had not been sick a day in the last 25 years. The only times I went to a doctor was for the regular insurance company check-ups.

Now it was obvious that something was wrong. Very wrong. I vomitted. A feeling of weakness was coming over me and I became really alarmed. I knew that I must get back to civilization as soon as possible.

I returned to the place where I was when all this happened and gathered up my equipment. Then I started walking back towards the highway and Falcon Lake.

THE ORDEAL

I had not gone far when I was forced to stop and vomit. Again and again my stomach heaved and swayed. My mouth was hot and dry. The pain in my head got worse. All the food I consumed was gone from my stomach, but I continued to vomit – green bile.

The same kind of pink dots that appeared in front of my eyes when I looked at the light in the craft – returned.

I came upon the brook I had passed on my way into the area. Bending down, I slopped water all over my face and head. I had to remain conscious. To stop now would be fatal.

Using the compass was impossible. I couldn't make out the direction of the needle because I was unable to see straight. Instead, I searched for some familiar land-marks. With great effort in every step I made my way in what I hoped was the right direction, praying that every step would bring me closer to safety.

I had to continue stopping every so often to vomit. The ever worsening splitting headache added to my misery. Now I felt a burning on my chest. Red marks had appeared where the hot blast from the craft touched me and burnt my shirt. Some spots were as large as silver dollars. I removed my jacket because it irritated the sores when the cloth touched them. I kept on walking naked from the waist up.

Before long I was to experience another chilling fright. I saw an unfamiliar path which I had not seen

before. I thought that I became lost. But, I reasoned, the path may lead me to the highway. I prayed that it would. I began following it and soon heard cars passing by on the road.

I was desperately in need of medical attention. Sweat ran into my eyes and I could hardly see where I was going as I stumbled along the path and finally got onto the highway.

As I stood there catching my breath I began wondering how I could ever explain the thing I had just seen and experienced. My wife and children would never believe me. And what about my neighbours and friends? It was so unearthly, so unbelievable – like an apparition. How could I defend myself, should people say I was crazy? Hundreds of thoughts flashed through and puzzled my mind. It was impossible to decide there and then what to do. I knew that I must get help fast. That was my first concern at the moment.

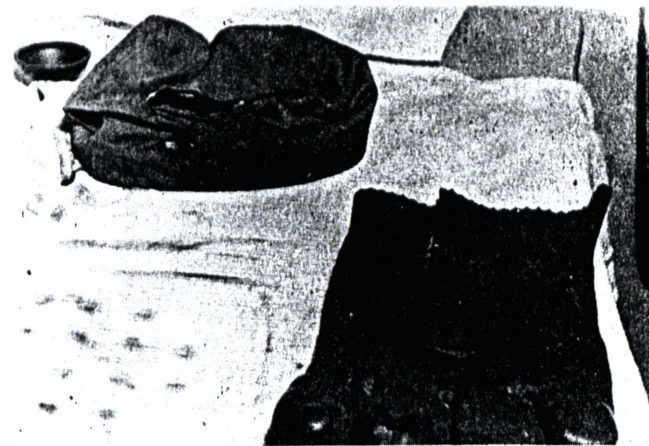
I knew there was an RCMP detachment at Falcon Lake. There, I hoped, I could at least get some medical aid and care. Besides, it was my duty to report to the authorities what I had just witnessed.

I walked out onto the highway and discovered that I was about a mile west of the point where I had entered the woods that morning. I directed my steps eastward, hardly able to move my feet. I made some small progress growing weaker with every step.

My heart-beat quickened when I saw an RCMP car approaching. I raised and waved my hand frantically, but the car passed by without stopping. I was amazed at their apparent indifference to my signalling.

The only thing to do was to continue walking. I made very slow progress; my stomach was still churning and my head was pounding like a drum. My only thought was to get to Falcon Lake as soon as possible.

The odour of “burning electric motor” and sulphur

lingered about me, constantly bringing back to my mind the things I had seen.

As I staggered along the roadside I heard a voice calling me. Turning, I saw an RCMP constable. Briefly I gave him an account of what had happened – warning him not to come too close to me because I feared the possibility of spreading radiation. I asked about medical aid.

“Sorry, but I have duties to perform here”, he said.

I stared at him, unbelieving what I had just heard. He, apparently, did not believe a word I told him. Otherwise he would have acted differently.

The constable left me with my sickness and disappointment. Yet I thought: every human being, no matter how small or how great, has at one time or another found within himself great ambition to accomplish what seems to be impossible. I knew that for me such a time had come now.

At long last I was within the sight of my motel at Falcon Lake. My journey took every ounce of strength I had left in me. By the time I reached the motel I was totally exhausted. I did not go inside the motel for fear of contaminating people around me. I remained outside in the woods nearby.

I felt detached from the rest of the world. All my strength was gone and the pain in my head reached the limits of human endurance. My eyes felt as if they were bulging out from my head, and the pain was unbearable when I turned my head to look around.

With every breath, the stench of the sulphur returned. I took a deep breath trying to rid myself of the foul smell and the nausea it brought about, but it didn't help. The odour seemed to come from within me and I could not escape it.

I was afraid that I had ruined my health and visualized the resulting hell should I have become disabled. To the exclusion of everything else my mind centered upon the possible consequences flowing out of what had just happened. The pains continued and became more severe than ever.

By four o'clock that afternoon I could stand it no longer. I got out and went to the motel's restaurant, asking a waitress if a doctor was available. She said that the resident physician would not arrive until July and that the nearest doctor was in Kenora, Ontario, 45 miles east of Falcon Lake.

With this latest setback I had no alternative but to go to my room and rest. There had to be some way of getting medical aid and attention.

I thought of the press. Things that happened to me were definitely news, if nothing else. So I contacted the Winnipeg Tribune – only to find that I had again drawn a blank. It was Saturday afternoon and there was no one in the office who could have helped me.

I did not want to alarm my wife, or cause a panic in the family. I phoned her as a last resort, telling her that I had been in an accident and that I had suffered some burns to my chest. We arranged to have my son Mark meet me at the bus depot in Winnipeg later that evening. Now at least I seemed to be getting a little closer to safety.

Returning to my room, I packed and checked out – only to find that I had four hours to wait for the bus! I felt sick, very sick, all cold, and hot, and cold again. I put on a sweater and an overcoat, but the chills kept recurring.

I left for the bus stop long before the bus was due to arrive. Not wanting to mix with people because of the possibility of my spreading radiation, I waited in the background.

As I sat on a tree stump on the boulevard, suffering pain and the stench and the colored spots all around me. I began to reflect upon my life. Flashing through my mind were horrors of the war with its total disregard of human life, its valour and its cowardice. I recalled instances when I had closer brushes with death – and survived. This thought comforted me and I felt that somehow I'll pull through my present harrowing experience.

After what seemed an eternity, the bus arrived. I boarded it and gave my ticket to the driver. He looked at me the way one looks at a drunk. I could almost feel what went on in his mind, but he had no idea how utterly wrong he was.

I moved to the rear of the bus, hoping to separate myself from the other passengers by the greatest possible distance. I wanted no contact with people now. It was a relief to know that I would be home soon.

My eldest son, Mark, met me at the Winnipeg bus depot at 10.15 that evening and took me directly to the Misericordia Hospital.

THE SCRUTINY

A doctor examined the burns on my chest and gave me a sedative. He asked me how I got burnt. Excuses flashed through my mind, and I told him that I had been hit by exhaust coming out of an aeroplane.

At this point I must explain the reason for contradicting the recent events, and avoid confusing the reader. The doctor who treated me was of Chinese origin and, while being a fine and competent physician, I am sure, he was not too well versed in the English language... and neither am I. I felt that there could be some misunderstanding and what's more: I did not feel up to relating the whole story just then. I was thinking how to get home as soon as possible, without any delay that my true revelation might have caused. Besides, the pain I was suffering was too much for me to go through it all again.

My son took me home. After a bath I took a sedative and went to bed – hoping that morning will bring a brighter day.

The following day proved to be no better. The pain was just as bad, the awful stench still lingered in my lungs and the dots still danced in front of my eyes. The vomiting has stopped. It was quite a relief. Strangely, I was not hungry. I realized that I had not eaten since I had seen the craft in the woods the day before.

Efforts to drink a little tea proved useless. No sooner had I swallowed it when I began to vomit again.

I weighed myself and found that I had lost six pounds since yesterday – more cause for concern.

The throbbing pain in my head persisted no matter how I sat, turned or laid down. Only the loyal support and understanding of my family sustained my strength and lifted my spirit.

In the evening Miss Heather Chisvin, Winnipeg Tribune reporter, together with a photographer came to the house. I didn't realize, as I recounted the events of the previous day, that this was a beginning of a long series of questions and harassment by the press, radio, television, Air Force and various authorities.

I did not sleep that night, nevertheless I felt a little better the next morning. I had never taken any medicines before, but now I decided to try some 292s. I took two of them, but they did not seem to do much good.

My wife called our family doctor, Dr. R.D. Oatway. I repeated to him the whole story. He looked at me with what one may call a professional discretion and told me to eat some sugar and salt. He also prescribed some sea-sickness tablets, and more 292s.

He said the burns were only first degree and not too serious, except for one that was more severe and would require a little more care.

The sea-sickness tablets seemed to do the most good; they relieved my headache somewhat.

Later Dr. Oatway left me in care of his colleague, Dr. B. C. Shaw. He also said that I should go to Medical Arts Centre in Winnipeg for blood tests. After Dr. Shaw had become acquainted with my case and after studying my burns he gave me an anti-bacterial skin cleanser and an ointment.

Meanwhile the news of my encounter with the unknown object has spread throughout the city.

One of the people who took a special interest in the

case was Barry Thompson of the APRO*). After hearing my story he stated his belief that the craft was not an earthly creation. He persuaded me to take blood and radiation tests. I was grateful to Mr. Thompson because he was the first person who took my story seriously. He showed me that he knew quite a lot about such matters.

Other people I talked to were sceptical, but I don't blame them for I would have had doubts myself if someone else told me the same story.

Soon the telephone calls began. It seemed that everyone in Winnipeg wanted information about the UFO that I had seen. In my state of health I could not answer all the calls, so my son Mark took up the task.

Many calls were from people who were sympathetic to my situation and I was grateful to them. I only regret that I could not remember all their names.

However, a number of names do linger in my memory. There was Mary Lou Armstrong of the University of Colorado, officials of the BBC and CBC, Prof. James McDonald of the University of Tucson, representatives of the Winnipeg Free Press and the Winnipeg Tribune and many others.

During this time my health made little progress. The most interesting thing was that I did not feel hungry. I had no desire to eat, and I continued to lose weight. I started making a chart and kept a record of the state of my health.

The news of what I had seen was spreading rapidly around the world. Articles appeared in newspapers and other publications throughout the world. Some accounts gave validity to my story, others were quite sceptical.

I was afraid, I think, of ridicule more than anything else.

Press investigations did not stop at my own home.

Reporters went out to my friends and neighbors asking if they thought I was a stable person, whether I drank a lot, and whether I was the type who bragged and boasted a lot.

Then came the official investigations. The RCMP

and the RCAF. Men whom I did not know and never expected to meet came to my door. They too had many questions to ask. What was my domestic life like? Why was I in the woods at the time? Somehow people seemed to have a genuine interest in my experience, and I enjoyed talking to them.

I was amused by some people who came to quiz me. One could read their characters clearly just by the type of questions they asked. Some would say: "Why didn't you run?", or "Why didn't you enter the craft?", or "Weren't you afraid? I would have been!"

By Tuesday evening following the incident, I was totally exhausted. I could talk to people no longer. I refused to answer the phone. I tried to break off contact with the outside world.

This action only succeeded in creating discontent amongst the public. I began to be regarded as an ignorant anti-social creature. My detractors and critics could not know how I felt, could not appreciate what I was going through. They just couldn't know...

A soldier who has taken part in a battle, who has seen death and suffering can tell his story, and no matter how true it may be or how much emotion he may put into it, there will still be an element of disbelief in the listener. The mass cannot understand an individual. They listen, pass it on and forget it. This is how it was in my case. No one knew what I was going through.

During the next few days I saw Dr. Oatway and Dr. Shaw, a radiologist, Dr. T.D. Cradduck, and a skin specialist, Dr. S. S. Berger.

On May 22 Mr. Thompson, in consultation with Dr. Cradduck sent me to the national atomic research centre at Pinawa, Manitoba. I was examined for radiation. After

the examination I was told that I was not suffering from radiation and was in no danger. Slowly my health improved.

THE SEARCH AND THE FIND

On June 4th Dr. Ray Craig of the University of Colorado and John Fried of Life magazine called upon me. Together with Mr. B. Thompson, we went to Falcon Lake to try and find the site where the craft had landed.

Nature changes quickly at that time of the year and the forest was very much different now than it had been when I was there before. We searched and searched in vain.

I was sorry that our trip was unsuccessful, but there was nothing we could have done about it.

The same thing happened later when the members of

the RCAF under Sqd.-Ld. P. Bissky and the RCMP went with me to search for the spot.

We even used a helicopter, but it was no use. It seemed as if the place had disappeared from the face of the earth. The men who came with me were disenchanted. I made up my mind that sooner or later I'll find the spot and solve this mystery once and for all.

As my health improved, other reports of sightings turned up. A 13 year-old girl from Winnipeg, Darlene Bagley, reported seeing a similar thing. She made a sketch of it. Her sketch was not unlike the one I had made.

Then I heard about two boys seeing something near Falcon Lake about noon on May 20, the day of my experience with the object.

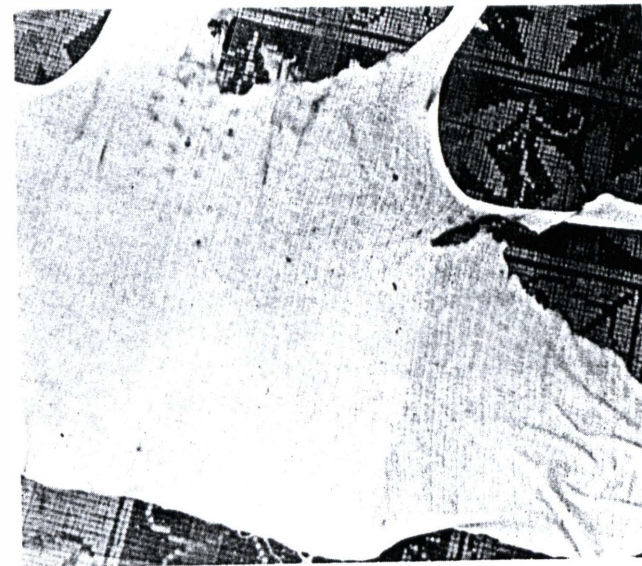
I found that within four weeks before and after my seeing the object there were at least 20 reported sightings in the area.

Slowly I tried to forget the events that had taken place. I returned to work and tried to get things back to normal.

Then on Sunday, June 10, three weeks after the day in Falcon Lake, I felt an itching in my chest. When I looked I noticed a number of blisters high up on my chest near the throat and a V-shaped rash that ran from the middle of my chest up to my ears.

I went to Dr. Shaw immediately. He examined me, took pictures and gave me some medication. It had no effect on the rash, and after a few days he sent me to Dr. Berger. I saw him for four weeks. During this time he gave me several treatments and the trouble disappeared.

On June 30th I contacted Mr. G. A. Hart, an electronic engineer in Winnipeg. He had offered me help earlier. I knew that he went to the Falcon Lake area quite frequently, so I asked him if I may accompany

him some time and perhaps search for the landing site.

He not only took me there but helped me in the search. I looked throughout the woods checking rocks I had seen before, examining chips I had made in the stone and finally, after six hours, we came upon the spot.

Our greatest surprise was to see very plainly the outline of the ship on the ground where it had landed six weeks earlier.

We found the remains of my shirt at the scene along with the tape measure I lost that day. We placed the articles in plastic bags, gathered some samples of rock and earth from the area and took some pictures of the spot.

We also discovered that branches of trees in the area where the craft came down had withered away and died, while all around the trees were flourishing normally.

After looking around briefly we returned to Falcon Lake, marking our way clearly so we could find the spot again.

Back in Winnipeg, I told Mr. Thompson and Sqd.-Ld. Bissky that we had found the spot. On July 2nd they travelled with me to the landing spot and took more pictures and samples.

Later in the week I went to see Dr. Berger because the rash had returned to my face. He again treated it.

Mr. Stewart Hunt of the National Department of Health and Welfare and Mr. D. Thompson of the provincial health department came to me later and with the members of the RCMP and the RCAF gave me a report on the samples.

Mr. Hunt told me the earth analysis showed radiation. He took geiger counter readings in my house, but apart from the earth I had sent in, no further radiation was discovered. They promised to return for more tests.

On July 2nd Corporal Davis and Constable J. Zacharias of the RCMP in Winnipeg came and took me to Falcon Lake. There we met Mr. Hunt, Mr. D. Thompson and Sqd.-Ld. Bissky. Together we went to the spot and made more tests. They said there was some radiation but not enough to be dangerous.

At last the investigation was over. All there is to do is to wait for the final results, but I feel that they will never be made public.

Samples of earth and rock were also sent to Colo

rado University and to APRO. Accounts of the events mentioned appeared in magazines throughout the U.S. and Canada.

So far there was no official word. Perhaps our scientists are ashamed to admit that somewhere there is an intelligence and technology greater than ours.

As for the Government, it is possible that they are afraid that they will cause national panic if they reveal all they know, but it seems to me that they should say something definite*).

The public has a right to know whether this thing came from our planet or from another world, whether it was friendly or harmful. People should be told what it was all about.

OTTAWA (CP) - A report arising out of a federal investigation into the sighting of an unidentified flying object at Falcon Lake, Man., this year won't be made public.

"It is not the intent of the department of national defence to make public the report of the alleged sighting," Defence Minister Cadieux said in a written reply to questions by Ed Schreyer NDP - Springfield.

He said the report last spring by Stephen Michalak was investigated by the defence department, the federal health and welfare department and the RCMP.

EPILOGUE OR INTERLUDE?

On September 21st, just five months after my encounter with the craft at Falcon Lake, another strange thing happened.

I was on the roof of the Inland Cement Co., where I work. It started as a burning sensation around my neck and chest. At first it felt as a bee sting, but the pain was too intense and covered too great an area.

I went down to the first-aid room to have the affliction examined. The pain grew worse and my throat began to feel like it was burning. My body began to swell. Tearing off my shirt, I noticed large red spots in the same place where the burns from the ship had been before.

The superintendent came in. After seeing what had happened he took me to a doctor immediately. In the next 15 minutes my body had turned violet. The swelling progressed so quickly that I could not take off my shirt again. My companion could not look at me, he kept turning away. My face must have looked horrible.

My hands looked as if they had been inflated with air - like a balloon, and I could feel my strength weakening. My vision was failing and I could make only dim outlines of things. The room was spinning around and I felt myself fading out into unconsciousness. I felt somebody lifting me onto a bed, but I was not aware of what was happening.

Later I was taken to the Misericordia Hospital for observation. By 9 P.M. that evening the symptoms

began to disappear, my strength was returning and I began to feel better. I was released from the hospital at noon the following day, and all the swelling and marks had disappeared.

Doctors at the hospital said the swelling was the result of some allergy, but it seemed rather strange that the spots appeared in the same places where the UFO had left its marks.

On September 30th I returned to the place where the craft had landed – to see if there were any other changes. I could not believe what I saw.

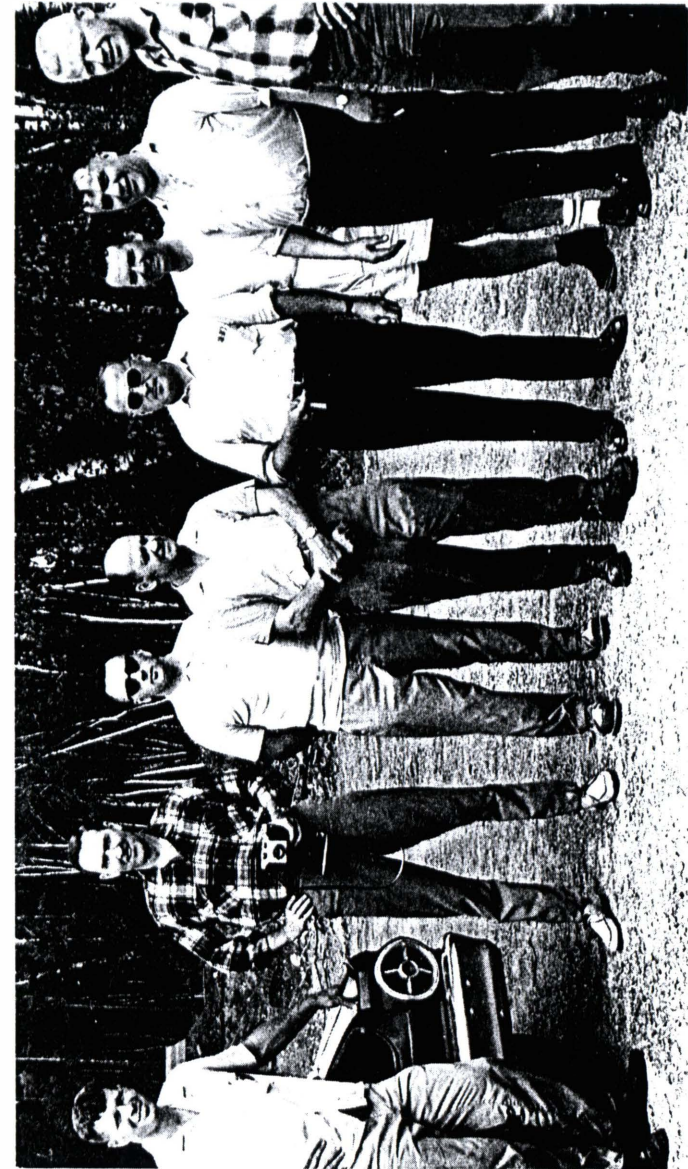
The leaves in the area looked as if they had been sprayed with some killing chemical. All were withered and dead. No vegetation grew within a 50 feet radius of the landing site. The area where the craft had touched down was still visible.

I took more pictures, also a geiger counter reading. It indicated a radiation count of 400 u. R.

I decided to return to the spot next May, one year after the sighting, to see if any changes have occurred and to see if the site is still discernible.

With regard to my health, I have been able to gather certain theories from various doctors and scientists as to the nature and source of the disturbances, their effects and any possible future results owing to the experience.

One official said that my shirt and body was burned by ultrasonic waves, while another feels that it was a thermal reaction caused by a blast of hot air under pressure.

Radiologists have said that radiation found at the scene was a product of nuclear fission, like that emitted from an atomic reactor.

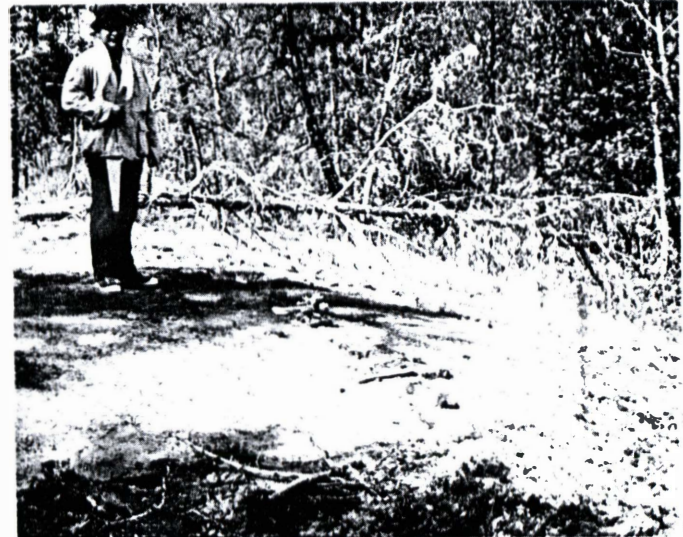
Another doctor said there were indications of the presence of the gamma rays which might have caused the burns and the immediate deterioration of food in my stomach which would have caused the awful stench I had experienced.

Yet another interesting observation showed that the amount of blood lymphocytes in the blood stream dropped from the normal 25 per cent to 16 per cent and finally returned to normal some four weeks after the sighting.

A federal report said that contact with the radiation may have caused or may yet cause blood cancer - leukemia.

Now that all seems to have ended as far as the events and after-effects are concerned, I would like to say that the burns and suffering I had endured were not caused by any aggressive moves of the craft or its occupants, as far as I can see.

The contact I had with the ship was of my own choosing and I was burned by the exhaust of the craft as it took off. Probably, if I stayed farther away from

the craft I would not have burned or suffered in any other way.

As a result, I offer this warning to all who may also encounter such a craft: keep away from it far enough to protect yourself and take all precautions against similar reactions.

That's according to CAC, the Cosmic Awareness Communications group, that claims to have channeled this prediction through a human interpreter for the aliens.

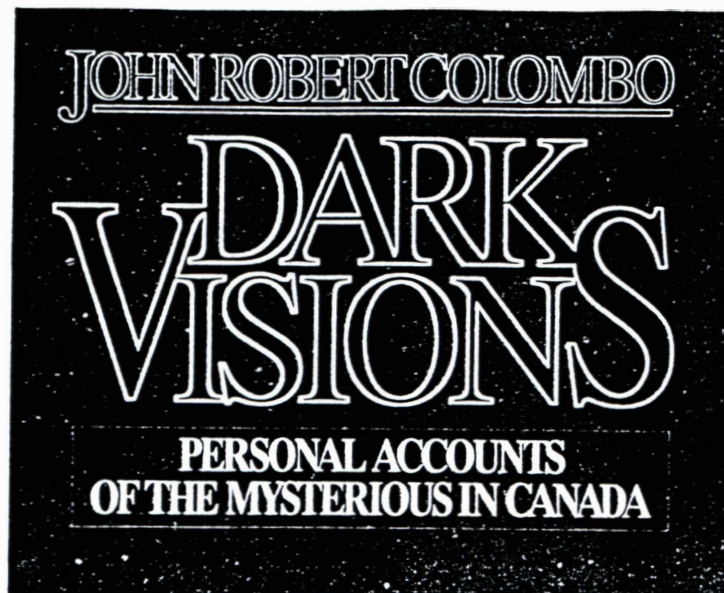

I Had a Mind Transplant on a UFO

Winifred G. Barton

Winifred G. Barton attracted newspaper headlines in the 1960s and 1970s when she travelled across the country conducting metaphysical workshops and collecting accounts of the paranormal. She edited a collection of "extraordinary experiences" called Psychic Phenomena in Canada (Ottawa: Psi-Science Productions Ltd., 1967). The appearance of her book predated the well-heralded advent of the so-called New Age; newspaper editors had not yet turned their editorial attention to spiritual and metaphysical adventures.

Mrs. Barton dropped out of the headlines and many people assumed that she had left for greener pastures or passed into the beyond or entered into a nunnery of some sort. But the writer Michael Poulton discovered her – through a classified advertisement in the "National Personals" of The Globe and Mail!

It turns out that what happened to Mrs. Barton is much more exciting than any of the assumptions above. It seems that she had a "close encounter" with alien intelligences and that she was abducted by alien beings and taken aboard one of their star ships. As she explained in a letter to the present editor, dated 25 April 1991:

I was abducted on September 26, 1973, and was taken "through the mirror." The next 17 years were spent in getting an intensive education. I was caught between dimensions, locked into a scenario over which I had no control. My psyche alternated between experiencing the heights of heaven and the depths of hell. It was like dying. Only now that I am fully "processed" as Biological Mutant can I come back to tell about it.

At one time Mrs. Barton ran the Institute of Applied Metaphysics (IAM). She now lives near Frankford, Ont., and serves as public-relations officer for the Golden Triangle UFO Club for Ontario.

Against my will, and without any anaesthetic, I had a mind reversal on a UFO. It happened during and in the period following an abduction on the evening of September 26, 1973, at the Lester B. Pearson Peace Park, at Actinolite, Ontario.

It had been a glorious autumn day. I was with a group of friends who had gathered from many parts of Canada and the U.S.A. to enjoy the end of the summer season. We were using the old Madoc Art School which sits at the foot of the hill next to the Peace Park.

The Peace Pagoda was a favourite place for our evening meetings, but on this particular night a sudden heavy mist seemed to envelop the area. The mist did not seem like a normal mist; it seemed to have a silvery glow as if there was a light behind it. I went to investigate and as I walked up the hill, pieces of the mist seemed to break away from the mass and coagulate into the forms of beings.

Nothing touched me but I felt a powerful magnetic attraction to continue towards the central glow. As I got closer I saw in it the outline of a Starship. I could hear some of my friends calling out to one another as they too were drawn towards the celestial car.

My will to resist was completely paralyzed. The hatch was down and I went into the foyer where I vaguely saw some of my friends being led to different rooms or parts of the ship. I was taken to a large circular room – a translucent aqua colour – with two transparent doors set approximately opposite each other. Through these I could see that there was an outer walkway which seemed to go right around the room. I could see a woman sitting at a communications desk through one of these windows.

In the beginning I was alone in the room. I felt no sense of fear, only curiosity. There was a large circular, lazy-susan type table in the centre of the room with chairs around it. I sat on one of these. There was a bowl of fruit – small berry-type fruit on the table. I was tempted to eat some but decided it was best not to.

A man came into the room from the opposite door to where the woman was sitting. (I guessed she was keeping an eye on me through the door.) The man barely glanced in my direction but walked straight across the room to what seemed like a circular shower stall, where he dropped off his dirty overalls and stepped into the stall which lit up. He emerged a few moments later and put on clean clothes.

Books I have written clearly record how since infancy I was trained in telepathic communication. So though no words were spoken, I had no difficulty in communicating with this Space Being. He offered some of the fruit. This time I took it and ate. It was like mango.

I could sense this man was trying to override my free will. At first I firmly resisted. Then they changed my electro-magnetic circuit from Alternating to Direct Current. I emerged as a circuit in a *Gigantic Ro-*

bot known as "Hal." I was wide awake but completely paralyzed during the proceedings. There were about thirty other persons beside me.

Now everything looks transparent. Form and finity is meaningless. It was as if my bony skull was replaced and my head put into a glass bubble. As a circuit in this *Giant Robot* I was powerless to escape over a fifteen-year period. If I struggled they prodded my neurons here and there with electrical sticks....

When I returned, just before noon on the morning of September 27th, 1973, I was no longer "Winifred." I was "Sasoleah," a citizen of Sumeria who had reincarnated in the 20th century through my physical instrument.

The same thing had happened to at least twenty of the other abductees. All had undergone some sort of a transmutation technique and mind transplant. All were trapped in the world of Robotics. Each had been given a silent mission. Each brain had been joined to an ancient personality. Each one was under total mind control and forced to keep the intruding ancient soul a secret.

Over the next decade the abductees got to talking about their "inductees" and how we found that "aliens" were actually ancient peoples who had completed a Universal cycle and were coming back to claim the modern world. They had left overwhelming mounds of evidence to prove this point... "That the sower and the reaper may rejoice together in the New Heaven and the New Earth" on the completion of the life cycle Genesis I – from chaos to cosmos via Robotics.

One of my fellow abductees was a man from Ottawa named Marcel Lafleur whom I had known for some years. After the operation we watched the whole scenery around us being torn down like a ragged canvas. The colours behind the canvas were brilliant. We understood that it is only the light energy of the real world shining through the web of matter that makes the holograph on our mirror world of the illusion tick.

Lafleur drove me home. We were both in a state approaching incoherence. He drove into the driveway of my home at 3045 Otterson Drive, in Ottawa, but I did not recognize the house. When I got in the house, I felt exactly like a stranger walking in for the first time. I could feel Sasoleah tapping Winifred's computer to find her way around. Sa was in total domination at this time.

About now I realized something else. "I" was neither of these two. I was an observer watching two actors using my mind. I watched them interacting, arguing points of logic, as they began to make an harmonic convergence in my mind. I understood the principle of the left and right-hand sides of the brain being kept in perfect balance. One living in the finite now, the other accessing infinity. One bent on "ren-

dering unto Caesar that which is Caesar's," the other committed to "and to God that which is God's."

But I am neither ... *I AM* ... My Divine Will is the Umpire between the two. I have watched Sasoleah writing "*I Am*," *The Book of Life*, using Winifred's professional skills. I look in one direction and see that Winifred has been held like a bond slave to serve the cause of Sasoleah and the Space People for eighteen years. In return, Winifred has been in an advanced interdimensional classroom wherein she received the full and complete knowledge of The Gods.

Winifred mostly ruled the daytime consciousness (Hadit). Sasoleah could flit all over the Universe at will and usually took over when the sun went down (Nuit). Sasoleah could work miracles with ease. For example, some fellow abductees took us on a fully paid, two-week trip to Egypt to celebrate the Equinox of The Gods. I knew nothing whatsoever about these people, nor they of me. That's what their instructions were and that's what they did. That's how the "COSMIC WAY COMMUNITY" operates. It's called spiritual humility.

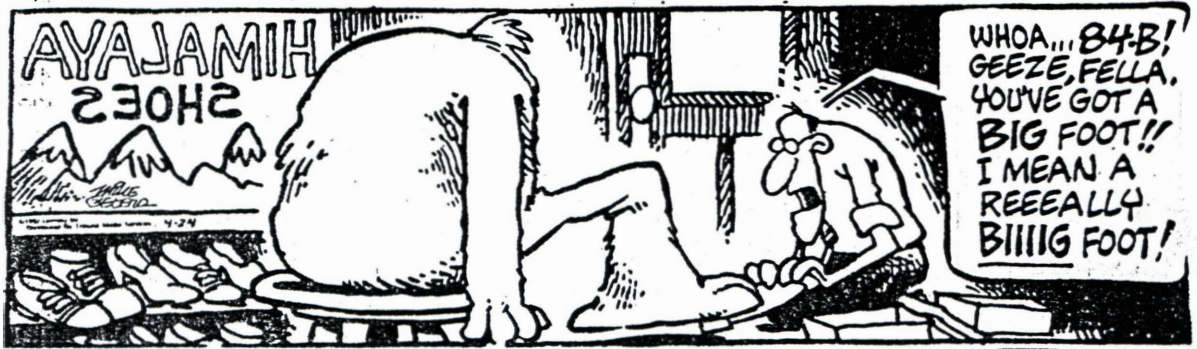

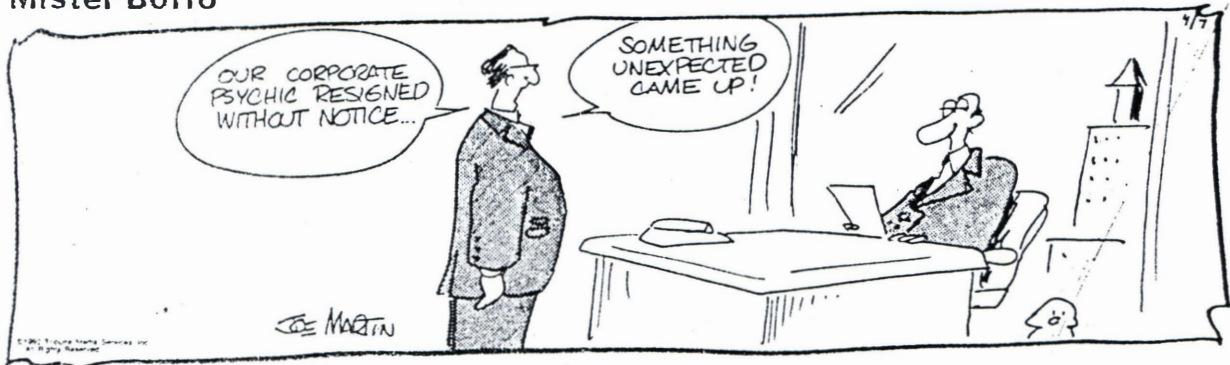

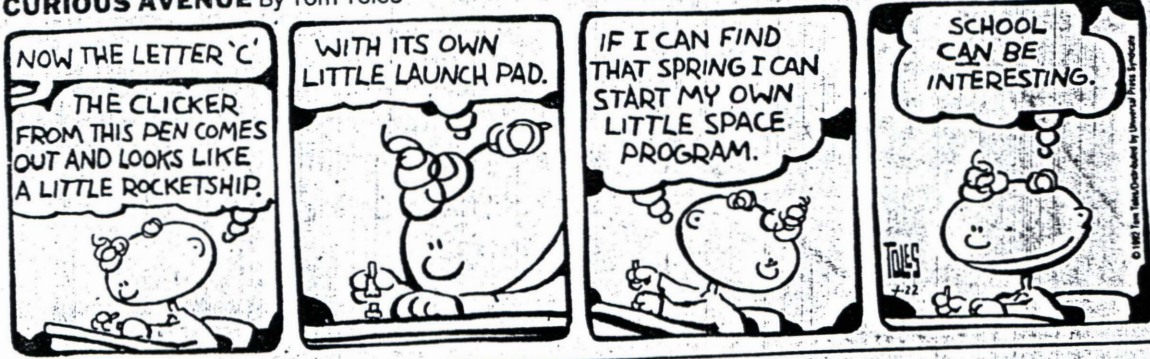

Milky Way black hole suggested

PHOENIX (AP) — Fast-moving stars and infrared radiation streaming from the centre of the Milky Way add weight to the theory that a so-called black hole is at the core of the galaxy, astronomers say.

Fresh evidence of an object with the mass of nearly a million suns at the heart of the galaxy was presented by University of Arizona researchers Tuesday at an American Astronomical Society meeting in Phoenix.

The Milky Way galaxy, which includes the sun and the Earth, is composed of perhaps 200 billion stars. Its core is 28,000 light years away. Black holes are mysterious objects that exert gravitational pull so powerful that even light cannot escape — the reason for their name.

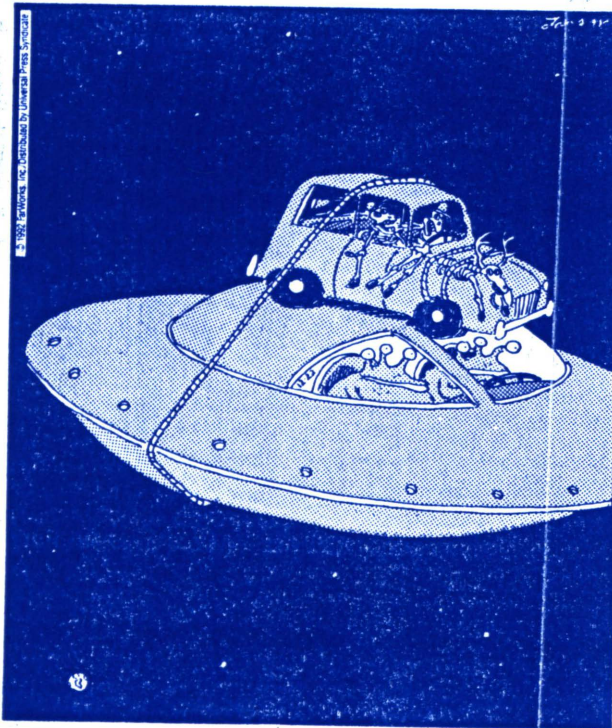
"We have detected a source of infrared which is powerful evidence that there is a huge object, likely a black hole, at the centre of the Milky Way," Arizona researcher Laird Close told a news conference.

He said the infrared radiation is spewing from Sgr-A-Star, an object long suspected by scientists of being a black hole.

The researchers used a telescope that takes out the twinkle of stars — caused by atmospheric distortion — and is able to pinpoint infrared radiating from Sgr-A-Star. Infrared would be generated as gas and other material fell at increasing speed toward the centre of a black hole.

Joseph Haller, another Arizona astronomer, also found evidence of a black hole. He measured the movement and concentration of stars in the galactic core and found that stars within about six trillion kilometres of Sgr-A-Star had accelerated to almost half a million kilometres an hour, a movement that could be caused only by a powerful gravitational pull.

HBO Plans New Film on Roswell Crash

New Witnesses to Alien Bodies Emerge

HBO is presently in the casting stage for a new movie that will appear on the cable station sometime by the end of this year. The movie will be a dramatization of *UFO Crash at Roswell*, a 1991 book written by Kevin Randle and Donald Schmitt. The film's release will occur simultaneously with that of a new book by the two authors, which promises to rewrite what happened on an extraordinary day in July 1947 near Roswell, New Mexico.

After learning of HBO's plans, I called Don Schmitt for the inside info and the latest on their continuing investigation into the most important event of our century--the crash of a craft from another world and the recovery of alien bodies. Before I cover my discussion and interview with Schmitt, I would like to briefly discuss the history of UFO crashes.

UFO Crash Reports

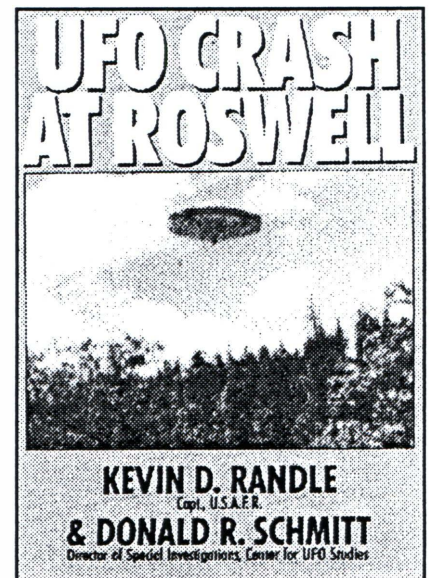
The first stories about flying saucer crashes unfortunately were hoaxes. The *Nebraska Nugget*, in 1884, wrote about a blazing object that plunged to the Earth spreading "fragments of cogwheels and other pieces of machinery . . . and glowing with heat so intense as to scorch the grass for a long distance around each fragment and make it impossible for one to approach it."

The crash was reportedly witnessed by a few Dundy County cowboys, and the object was

supposedly so bright that it blinded one of the witnesses. Well, it was later learned that the incident was a fanciful hoax, which made interesting reading for the *Nugget's* readers, and perhaps sold a few extra papers as well.

More Hoaxes

Frank Scully, author of the 1950 book *Behind the Flying Saucers*, wrote about crashes of Venusian spacecraft in New Mexico and Arizona. Two years later, it was learned that Scully's informants were nothing more than professional con artists. These and other spoofs left a bad taste in the mouth of principal UFO organizations of that time, such as the National Investigations Committee on Aerial Phenomenon (NICAP), the Aerial



Phenomena Research Organization (APRO), and the Civilian Saucer Intelligence. These organizations dismissed most of the crashed saucer stories, desiring not to be embarrassed victims of hoaxers.

The early UFO organizations felt the U.S. Government was covering up information about UFOs, but they never felt the government had actually recovered any of them. Perhaps if their attitudes were different, ufologists would have suspected sooner that our government possibly had at least one UFO in its possession.

Fictitious Claims?

Rumors began surfacing in early ufology that Wright-Patterson A.F.B., Ohio, was where flying saucer remains and *gray-skinned humanoid beings* were being studied by scientists. The whole matter was rumored to be highly classified because of fears of public panic, and to keep the Soviets from realizing that the U.S. had access to alien technology.

Again, these were only rumors, almost impossible to verify, and serious ufologists continued to dismiss them.

The Roswell Case

It was veteran ufologist Leonard Stringfield, one of the world's present day experts on UFO crash/retrievals, who, in 1978, began to push for the investigation of UFO crash stories. It was also in 1978 that Stanton Friedman, author of *Crash at Corona*, and William Moore, author of *The Roswell Incident*, got together to discuss an event that took place in early July 1947.

On July 8, 1947, the *Roswell Daily Record*, a small paper in Roswell, New Mexico, printed a story headlined, "RAAF Captures

Flying Saucer On Ranch in Roswell Region." The story broke like wild fire. Calls flooded into the area from around the world. However, the next day, the same paper ran a story announcing that officials from Roswell Army Air Field were mistaken; the debris recovered from a desert ranch was nothing more than a crashed weather balloon. After being shown debris from a weather balloon rather than from the actual wreckage, the reporters were convinced, and so ended the story . . . at least for a while!

Friedman and Moore decided to begin investigating the incident, and discovered enough evidence to strongly suggest that it was not a weather balloon but an actual extraterrestrial craft which crashed on that day. The two also learned that the military organized a retrieval operation, reprimanded local officials for their press release, and created a cover-up story involving a weather balloon to kill interest. The plans for a cover-up originated from high ranking officials at the Pentagon.

An illustration of the extent of cover-up can be seen in one story Friedman looked into. Linda Sleepy, a teletype operator at the KOAT radio station in Albuquerque, received a telephone call on July 7, 1947 from Johnny McBoyle, a reporter at sister station KSWs in Roswell. KSWs had no teletype of their own, so they used KOAT's whenever they wanted something to get out.

McBoyle excitedly told Sleepy

that a genuine flying saucer crashed near Roswell, and that the Army was presently picking it up. He claimed that he had seen the object himself, and described it as looking like a "big crumbled dishpan." McBoyle also said that the Army personnel were talking about "little men" that were found with the craft. McBoyle asked Sleepy to begin putting the story immediately on the teletype.

As McBoyle began dictating the story, Sleepy typed. A few sentences later, the teletype stopped. Thinking there was a mechanical problem, Sleepy explained to McBoyle what happened. However, McBoyle was distracted and Sleepy could hear him talking to someone else. In a strained voice McBoyle said, "Wait a minute. I'll get back to you." Immediately the teletype began again, this time it said: "ATTENTION ALBUQUERQUE: DO NOT TRANSMIT. REPEAT DO NOT TRANSMIT THIS MESSAGE. STOP COMMUNICATION IMMEDIATELY."

Now amazed, Sleepy told McBoyle what she was reading.

McBoyle answered by saying she could forget everything he told her; she wasn't supposed to know what he had said. Later, when Friedman asked McBoyle about the incident, McBoyle was quoted as saying, "Forget about it . . . It never happened."

Eventually, Friedman and Moore gathered about 100 informants involved with the case, and they pieced together a fascinating tale. Each man later co-wrote his own book about the investigations.

In 1988, the J. Allen Hynek Center for UFO Studies (CUFOS) decided to conduct its own separate investigation into the Roswell incident, spearheaded by Kevin Randle and Don Schmitt. Randle is a former Air Force intelligence officer, and Schmitt is the Director of Special Investigations for CU-FOS. They were able to turn up

of Roswell, New Mexico.

On the following day, Brazel discovered a large amount of debris in a remote pasture. The debris was scattered over a 3/4 mile area, and there was a gouge in the ground 200 to 300 feet wide and some 500 feet long. There appeared to be some sort of metal scattered about the crash site. It was very lightweight like balsa wood, but was much stronger. The metal was as thin as foil, but couldn't be cut or dented. There were also some I-beam shaped pieces with purplish geometric symbols on them. The language was unidentifiable to the witnesses. Brazel found one large circular piece of debris and stored it in his shed.

On July 6, Brazel drove to Roswell and reported his discovery to Sheriff Wilcox, who in turn

four alien bodies, for later that evening, a Sgt. Melvin Brown looked under a tarp on the back of a truck at the impact site and saw several alien-looking bodies. Also that evening, local mortician Glenn Dennis received several calls from the base about preserving tissue, and was asked about the smallest caskets that he had.

Dennis was told that there were three mortalities--two of which had badly mangled bodies, but the other was in good condition. Records show that there were no deaths at the Roswell Army Air Field during that time, and there were none at the base hospital either.

After the inquiries from military officials, Dennis drove to the base hospital out of curiosity, but was warned by a nurse friend of endangering himself by being present.

"My God, you are going to get yourself killed," the nurse told him.

He was then abruptly forced to leave by two military police, who grabbed him, lifted him off his feet, and carried him outside. Later, the nurse told Dennis privately why he was so rudely treated. The military, she told him, had recovered from the desert the remains of bodies that were not human!

Through their investigations, Randle and Schmitt have learned what these creatures looked like. The bodies were non-human, and were smaller than adults in size. They weighed about 40 lbs. and were about 3 1/2 to 4 feet tall. The hands had four fingers with no apparent thumb. Heads were very large in proportion to the bodies--

more informants than had previous investigations, and disagreed with some of the information from the Friedman/Moore research. Their results were later published in a book, the basis for the upcoming HBO movie.

Information From The Case

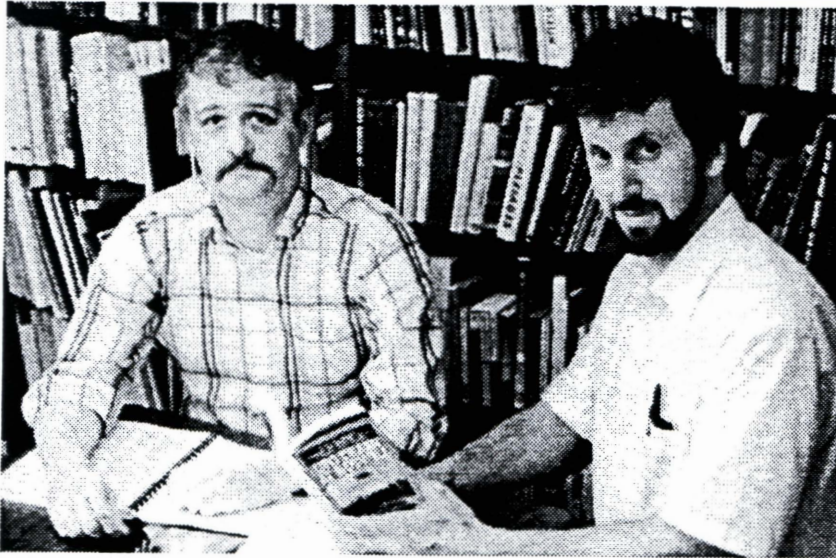
Despite some differences, all investigating parties agree that a craft not of this world crashed, there was a military retrieval of debris (followed by a cover-up story), and alien bodies were discovered. With all this in mind, we can briefly summarize the Roswell case as follows:

On the evening of July 2, 1947, Mac Brazel and others heard a loud explosion near his home northwest

notified the Roswell Army Air Field. Officials from the Roswell base examined the crash debris at the site, along with the piece in Brazel's shed.

On July 8, Roswell Base Commander Col. William H. Blanchard, dictated a press release to Public Information Officer Walter Haut that a flying disk had been recovered. Meanwhile, military officials began flying out the debris, and guards were posted on the access roads to the debris field to turn away visitors. That same day the *Roswell Daily Record* printed the "RAAF Captures Flying Saucer" story. The military at that point was flying over and searching the area. At some time during these early events, the military discovered

larger than human's--and were bald. Their eyes were large with a concave shape. In fact, the nose, ears and eyes were all slightly concave. They had a slit for a mouth, an indistinct nose, and small openings on the side of their heads for ears. The bodies were pinkish gray in color, and overall, the skull and bones were very fragile.

An interesting feature of the bodies were the arms. The bones from the shoulder to the elbows were shorter than the bones from the elbow to the wrist. Allegedly, the bodies were frozen and flown to Wright Field, which is today Wright-Patterson AFB.

This case, along with the tremendous amount of witness testimony surrounding it, surely represents one of the most important events in man's history. If all is disclosed (the craft and the bodies) by our government, it would represent solid evidence for the existence of other life in our universe.

It would curb the narrow-minded thinking among the NASA SETI folks that life is everywhere in the universe but just never comes here. It would also humble humanity. No

longer would we view ourselves as the highest forms of life in the universe. And, it would create a domino effect, revealing that the government has orchestrated large-scale cover-up programs on this subject, and perhaps countless others.

We may be able to learn more about our past, our future, and possibly our links and relationships to extraterrestrial lifeforms, when we fully know the truth. Many questions researchers have asked may be answered by those who we elected to rule over us, but who have lied and denied us the truth.

So this case represents a lot. And although for over 45 years the cover-up has been successful, it may not last, for the efforts of researchers such as the one we will introduce next are making a difference, and may turn things around for us all.

Interview with Don Schmitt

After learning that HBO was going to do a movie based on the book *UFO Crash At Roswell*, I was elated about the idea. I immediately contacted Don Schmitt to find out more, and he had quite a lot to say.

Schmitt told me that HBO first approached him and Randle with the idea for a movie before their book was ever released. The co-producer for the project wanted to write his own script based solely on their information. The movie will be a dramatization of the Roswell event, based 100% on their book. Schmitt and Randle will be working as technical consultants for the film. Location for the shoot will be somewhere in the Southwest with the exact location still undetermined. HBO is striving to release the movie by the end of this year. At the moment, no filming has been done--they are "still in the process of casting." Schmitt was asked not to release any info on characters.

I asked Schmitt if the movie will portray any actual ufologists. He told me that so far all scripts submitted have included Kevin and Randle, played by actors. However, they asked to be taken out so as not to appear "too self-serving." HBO also offered Schmitt and Randle small appearances but they declined.

I switched the conversation to the recent movie "Fire In The Sky," and the harsh criticism it received from ufologist for fictionalizing the abduction events (See *U.E.* Vol. 1 #6). I asked Schmitt if he was worried that the HBO movie might suffer the same fate--criticism because the movie makers change the story to create mass appeal. Schmitt explained that they were very fortunate to have met numerous times with the co-producer, the director, and the writer for the movie to ensure that the story remained accurate. In going through

the different drafts, Schmitt explained that there was a great deal of effort to stick to the original story.

The challenge was how to depict the events. Should they be described by retired military officers reminiscing about them, or should they be presented in a story set at the time of the incident? There were many different avenues to chose from, "but they always depicted the event itself almost entirely as we described it in our book," Schmitt explained. What HBO had to create was the dialogue, and even for this they consulted experts.

"What do you think about this line?" Schmitt said the producer would ask. "Would this person say this?" and so forth. "They kept very close contact with us," Schmitt explained.

As technical advisors, people are generally involved in the production, but are seldom allowed to have much input into the script, as have Randle and Schmitt. And to make sure everything is correct, HBO's legal department has been heavily involved in verifying the testimony of Randle and Schmitt's key witnesses.

I was curious to know what those involved with the production actually thought about the Roswell story.

"What's great about the entire production," Schmitt explained, "is that everyone from the producer, to the director, to the screenwriter, is 100% behind the Roswell case. . . . They really didn't know much about it until they read our book. Now they stand behind us."

To give me an example of the

commitment HBO has to the story, Schmitt read me a statement from Mr. Kopit, the screenwriter: "Randle and Schmitt's work is based on hard, extensive and rigorous journalism. *UFO Crash At Roswell*, a scrupulous examination of a purported government cover-up, is such a work. It makes a very serious charge. If proved true, *and I really think it is true*, what is being covered up is of major historical significance."

Latest Investigations And The New Book

Schmitt told me during our discussion that their investigation has uncovered a staggering 600 first-, second-, and third-hand witnesses to the events at Roswell. What is even more amazing is that they now have over a half-dozen living, first-hand witnesses to the alien bodies! And with their new book, "we will be including first-hand drawings--and certainly all first-hand testimony," Schmitt said. "Based on first-hand testimony, we will be rewriting much of what people's overall conception of what the Roswell case is. It isn't what most people have thought all these years. It won't be just an update. It is in fact a complete rewrite. I would say about 75% new information."

In Randle & Schmitt's first book, they were relying solely on second-hand witnesses to the alien bodies, such as "the Glenn Dennis story," Schmitt said, "even trying

to tie in the Barney Barnett story, which we have thoroughly dismissed." That's not all they have dismissed from previous investigations. "As far as everything that we have been unable to uncover, the entire Plains of San Agustin story is nothing but a rumor," he said.

Schmitt hopes that the simultaneous releases of the movie and their book will motivate some of the remaining witnesses to come forward. Their previous book, which was released in paperback, brought

in hundreds of letters with leads and information. Their future work will be published in a hardback edition, a more climactic ending to their years of investigation.

I asked Schmitt if he hoped to help initiate a congressional hearing on the Roswell events using the witnesses he and Randle have. He responded by saying that has been in the works for a couple of years, but because of the sensitive nature of the material, they were not ready to release all of their witnesses--not without more reassurance that the individuals won't be harassed into silence.

"Has there been any evidence at all," I inquired, "of any effort by any agency, government or civilian, to stumble you in your investigations, or keep you from getting your information out to the public?"

Schmitt answered, "Sadly, and as you mentioned earlier, Torme' [screenwriter for *Fire In The Sky*] ran into the same situation. Most of the roadblocks, most of the distractions, most of the harassment, if not

all, has come from the field [ufology] . . . everything from efforts to censor our book, letters to our publisher and threatened law suits."

Schmitt commented that his only regret is that he didn't begin investigating Roswell years before when many of the first-hand witnesses were still alive. He said that looking back on previous investigations, there was "a very half-hearted effort, very incompetent in many respects."

"The Roswell investigation until Kevin and I started five years ago," Schmitt remarked, "was in limbo . . . nobody was doing anything . . . it was all MJ12. And all of a sudden we start and it's like, 'Oh my God, we have to stop these people . . . we have to stop these guys.' Again it raises some very serious questions. What are the priorities in this field? Is it the truth? Or, is it totally monetary--totally self serving? I mean, how do you claim priority on a historic event? There are over 200 books on the Kennedy assassination, and they threaten to sue because we are doing our own independent investigation of Roswell. . . . I'm not going to name names here--people know who they are."

Schmitt talked about another obstacle that, for the last 45 years, ufology has had to negotiate--the media. "I think once the media would start looking into this and asking the hard questions and pushing for the true nature of the phenomenon, we could really open some doors overnight."

I asked Schmitt what other

difficulties he and Randle have experienced. "We've had some mild threats and have questioned whether or not our phone has been tapped," Schmitt said. "Vehicles with government plates, for example, have pulled in front of my house and even in front of my driveway on a number of occasions. . . . They occasionally put out little test flags, to see how we respond. 'What will it take to shake these guys?' . . . But we are encouraged by it; again, it must mean we are on to something."

I asked Schmitt where he would like to see the case go from here.

"There are still witnesses that we have been in hot pursuit (of) for the last five years--firsthand witnesses that we know were directly involved, not only with the debris and the craft itself," Schmitt said, "but certainly with the bodies. We've heard that there were hundreds of photographs taken. Certainly there had to have been a ton of documentation."

I asked Schmitt what it would take for him to back away from the case. He said he has been asked this before, even by two generals.

"Not by threat, not by harassment, not by intimidation and not by word," Schmitt responded. "They would have to show us--they would have to demonstrate to us that it would indeed be a threat to national security. Documentation won't do it; photographs won't do it. In other words, we would

have to see the genuine article, and then they would have to demonstrate why this is such a terrible secret. After all these years, why are we still unable to handle such an acknowledgment?"

"The point is if we can all concede that some event, some very extraordinary event took place down in Roswell and is still being covered up today, then the next question is, 'what?'"

"We have always been objective enough to go wherever the evidence leads us. And today, with over 600 witnesses unanimously telling us this was extraterrestrial, we are pretty well left with that explanation."

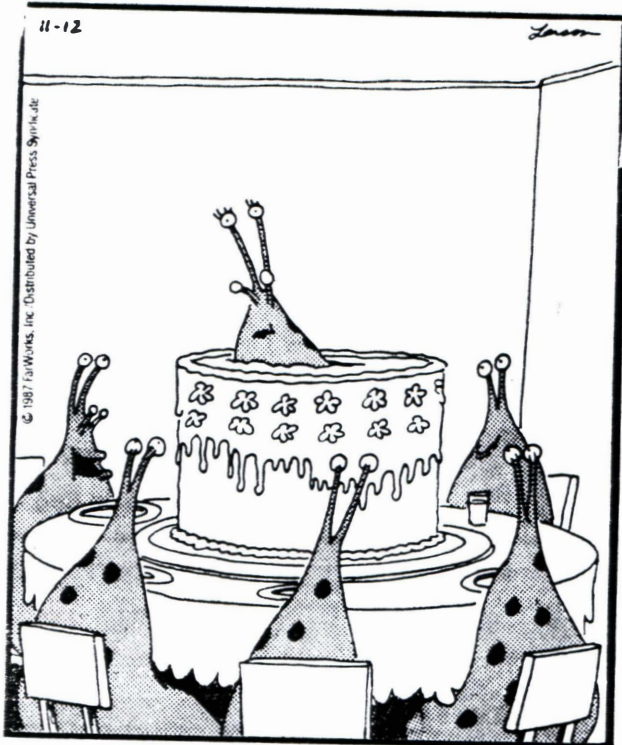
What Roswell has proven, Schmitt explained, is that no matter how old a case is, if there are witnesses still alive, there is great potential for significant discoveries. "There are files just sitting, begging to be reopened, because if a case is classified as unidentified, it is still an active case."

Surely there is another case as significant as Roswell that has never been investigated. We just have to keep searching. But who knows what tomorrow may bring? Another UFO crash could happen anywhere. This time we just have to beat the government to it.

Formidable Black historian makes a significant contribution to a theory of the destruction of Black civilizations and decline of the Black race. Though an enthusiastic partisan of his race and relentless critic of Whites, Williams does not fall for increasingly popular myths among Black nationalists that the entire African continent was Black prior to the White European incursions. As a student of early invasions of Egypt and North Africa by Asian Whites and later White Arab invasions he deals directly with the color bars formed by early White ruling ruling classes. He notes that Blacks have been confused by the subtlety of the color bar instituted by the White Asians and Arabs, while the clear separatism and White supremacy of the Europeans couldn't be misinterpreted. According to Williams, the White Asian invaders, with their policy of "Brotherhood", would accept with pride their mulatto offspring, often political marriages, and make them an adjunct of their new color-based ruling class while European Whites kept separate and rejected their mulatto off-spring. Needless-to-say, Williams makes a strong case against any idea that Islam, the religion of Arab invaders and slavers, imposed on so many Blacks at the point of a sword, is in any sense a "Black Religion".
