



Irish Circles Crop-up...


Antrim, Northern Ireland: 19th August 1993, one of Irelands first crop circle sites was host to a legion of journalists and curiosity-seekers in the normally peaceful area of Drummuck in the Antrim hills. The barley stalks remained unbroken despite being completely flattened in an

anti-clockwise direction to form the circles, one 30ft in diameter connected by a path 3ft wide to the other, measuring 15ft across.

They were discovered on Tuesday morning in the two-and-a-half acre field a short distance from Mr. Paterson's farmhouse in the townland of Drummuck near Broughshane. Pranksters have claimed responsibility for a number of crop circles but others are blamed on electro-magnetic forces, freak wind patterns - or extraterrestrial activity...

Earth: Laboratory for an Alien race?

There seems to be a high probability that all life forms on this planet have come into existance through the experimentation and test results of an alien race which, at it's physical foundation, is genetically linked to our own being.

The above conclusion has been reached after much insightive study using the accepted personal knowledge that the alien beings are bisexual in nature and of extremely high intellect, as an insentive guideline, what I am about to suggest is my own opinion of ideas, ideas which have manifested themselves as a direct result of witnessing a spacecraft 22 years ago.

This is an interim report compiled by BUFORA (Ireland) Branch for readers of our Journal. Sources used in this report are credited at the end, special mention should go to Doug Cooper (DUFORO) and Frank Marron (ANSO) for information supplied. The report begins with the first known sightings in Co. Clare and Co. Limerick.

At approximately 1:13 a.m. March 31st, two Gardai in a patrol car, which was heading toward the town of Askeaton (Co. Limerick), reported a "large object in the sky with two bright lights, one at the front and the other at the back". The object was first thought to be a Jumbo jet flying at low altitude, but it made no sound, there was a "sort of vapour trail like a jet behind it". The object "flew" right over the two Gardai towards the town of Croom (119 degrees S.E. of Askeaton), the Gardai thought the object might hit power lines or buildings because it was flying so low. This report would be one of the many 'reliable' reports to be made during the early hours of March 31st. Reports made to Shannon Air Traffic Control, who incidently said that "most of the reports came in between 2:00 a.m. and 2:15 a.m." (nearly an hour after the first sightings), told of "between 2 and 4 objects". Witnesses in Limerick City also reported "a silent craft like a Jumbo jet gliding over rooftops

of houses and looked like it was about to touch electricity pylons". (Fig.1 - Limerick Area)

The reports from this region seem very consistant, and it must be said that many of sightings were "probably" the debris of a Russian satellite launcher (spent rocket bodies), more on this later. I say "probably" because from information received it seems that there is also the "probability" that there was something else witnessed along with Russian space debris, these "unknowns" have been acknowledged as such by the British Ministry of Defence. It is plausible, and there is evidence to suggest it is, that "unknowns" are "monitoring" the Russian Space Programme. In Timothy Good's book "Alien Update", Chapter 11, there is more on these reports and, more importantly, these "unknowns" are very well known to the Russian authorities. interesting that in many of the reports on the night of 31st March, that other, fainter objects were also seen "trailing" behind the main object. In fact, a report to this effect was broadcast on a few local radio stations here in Dublin, David Moore of Astronomy Ireland said: "It was a spectacular sight seen by one of our members in Sligo (County) whos an expert astronomer, new it for what it was, it travelled N.W. to the S.E. at 1:10 (a.m.) in

the morning and, as two bright orange stars, leaving a firey train behind them and several other small, fainter objects, which also left trails behind them..." (sic) Without commenting further on this no doubt "expert" report, these other objects were also reported in the United Kingdom, more on these later.

Before moving on to the Dublin area, it is also interesting to note further reports from Shannon ATC. Unfortunately, they did not respond to our inquiries, but from newspaper reports it shows just how many witnessed the object(s), many aircrews reported the UFO to Shannon ATC, and although Radar at Shannon did not pick the object(s) up, it would interesting to see if any pilots made an "Official" report. Obviously, we can say that the object(s) was at a very high altitude because if Shannon Radar could not see it on screen it wasn't at a height below cruising altitude or carrying a radar transponder, therefore it was above Radar range. If this was a military aircraft (which

could have the ability to screen itself from civilian radar, then only military radar could track such a plane, (unless it was of Stealth technology!) would the Irish military have the ability to track aircraft other than civilian air traffic?) and this has been ruled out, it would have probably been seen by aircrew who could identify landing lights etc of such an aircraft.

So, we have the first reports from Limerick which indicate sighting times of approx. 1:10 a.m. to 1:20 a.m. If this object was travelling in a South East direction, surely it would be clearing the French coast by Approx. 1:50 a.m.? No? because reports from the Dublin area suggest it was there, from accounts made by three witnesses on a Dublin radio talk-show, and a credible witness, an RTE news reader, it seems the object had changed it's course several times. Consistancy remains in the description of the UFO, what does change however is the direction of flight and reported sighting times. Here are the three accounts made on radio, notice the consistancy of the descriptions:

A- Duleek, Co. Meath (Approx 25 Miles from Dublin City) - Witness called "Pam" was visiting her parents home in Duleek, she and her sister were looking for their cat when Pam looked up and saw two lights, "you could draw a straight line between them, in between was total blackness", she continued "there was jet wash and no sound or flashing lights, they were very low". Unfortunately, no time was given, except to say it

was "late at night", direction of flight wasn't mentioned.

B - Rathfarnham, Co. Dublin (South) - Witness called "Michael" was working, he saw "two lights, moving fairly slowly towards the North", he also mentioned that it was a clear sky and there was no sound, "it went clear straight in front of me" Michael said. The time of Michaels sighting was "about "2:30, 3:00 O'Clock." (a.m.)

C - Dunshaughlin, Co. Meath (Approx 18 Miles from Dublin City) - Witness called "Seamus" · saw "two lights moving across the sky and jet stream from both of them", he thought he had seen two planes, but he was "baffled" because "they were silent and quite low down." He mentioned talking to his wife about what he had seen the next morning, his wife rang him from work and told Seamus that the UFO's were seen in Limerick as well, travelling in a South East direction, but Seamus said this couldn't be right because when he saw the lights they were travelling in a South West direction. The time of this sighting was 1:15 a.m.

If we take this last report from Dunshaughlin and compare it to a report from a BUFORA member in Northern Ireland we can see more consistant reporting. The report from Northern Ireland describes the object(s) as silent with a faint vapour trail, more importantly, the direction and time of these two reports are the same. The majority of reports are in the region of 1:10 a.m. and 1:20 a.m. and apart from flight path reports, are very consistant.

An Air Corps Dauphin helicopter crew were flying from Casement aerodrome at Baldonnel (Co. Dublin)) to Finner Camp in Co. Donegal. shortly after 1:00 a.m. they recorded a sighting about 14 miles North of Mullingar (284 degrees N.W. of Dublin City). The "two moving stars" were an estimated 5,000 feet above the helicopter which was flying at 1500 feet, a Defence Forces spokeman said. Interestingly, a report from Leo Enright of the BBC (Dublin correspondent for BBC Radio 4) mentions an Air Corps Jet fighter being despatched to monitor the objects, though the operation was not successful because the objects were travelling at an estimated speed of 3,000 mph. (I will try and seek confirmation of this report.)

It must be mentioned at this stage that our many enquiries to the Dept. of Defence, Shannon ATC and some witnesses were unsuccessful. The reasons for witnesses not completing R & I forms are many, but mainly lack of interest or just inhibative of telling us thier account. With proper information about BUFORA (Ireland) Branch, and it is my aim to promote our organisation here, I'm sure that people in Ireland will become more aware of us and in time. when an incident does occur. R & I forms will be completed. At this stage, we are not very well known, that is why Astronomy Ireland are asked to comment every time a light is seen in Irish air space...

These are the credible accounts to hand, what did these

witnesses see? Earlier I mentioned the Russian rocket debris, and this does seem to fit the bulk of observations made during the night of March 30/31st. A study of the objects was made by Dr. T.S. Kelso, Asst. Professor of Space Operations, U.S. Air Force Institute of Tecnology, his studies covering this period (identified as Catalog Number 22586, International designator 1993-018B) identify the object as a carrier rocket body of Cosmos 2238 - a Russian ocean reconnaissance satellite which was launched by a "TSIKLON _ M" carrier rocket from Baykonur Cosmodrome at 16:00 hrs (Moscow time) on 30th March, 1993. The rocket body was predicted to pass over Ireland on a North West to South East trajectory between 1:06 a.m. and 1:12 a.m. local time at an altitude of somewhat less than 107 km.

This seems the most likely explanation, and unless on that night, no Russian rocket was launched, we could still be left undecided. The only oddity to be found in the very consistant reports, are direction, this is similar to reports from the United Kingdom, see figure 2. Now lets turn to those reports from the United Kingdom, because strange lights were being seen on the evening before, between 8.00 p.m. and 11:00 p.m., these objects were seen traversing the North Devon sky and hovering N.W. of the same area. In addition, at 2:00 a.m. on the 31st, an object of considerable size. flew over the River Parrot at Bridgewater (Sommerset - 216 degrees S.W. of Bristol),

disturbing not only a fisherman, but also the cattle in adjacent fields. There is the mystery of 3 helicopters seen at this time by other witnesses, and almost certainly of a military type, but as with the two fighter air craft reported over East Devon at 1:30 a.m. by a retired airline pilot, their presence was denied by the Ministry of Defence. - Why? Other reports came from St. Ives and Penzance at 1:30 a.m.. numerous sightings as well over Cornwall, Devon, Shropshire, South Yorkshire and Hampshire starting at 10:10 p.m. on the 30th and ending at 2:40 a.m. on the 31st (the last time being close to a report from Rathfarnham, Co. Dublin).

The conclusions of these "other" sightings, that is, reports not consistant to the Russian rocket debris evidence, are "at least one, if not more, UFO's were active over these areas on the night in question." (quote from DUFORO report). Until further evidence on these "other" reports is known, this must be the case, that these must be classed as UFO's.

There were initial reports of an American spy jet called "Aurora", possibly making a test flight over Ireland from a U.S.





Figure 3. Artists impression of the Aurora Spy Jet.

Air Force base somewhere in the U.K. If this was the case, and it has been discounted, this would have been an illegal act in itself. By flying over Ireland without permission could cause a diplomatic conflict, especially if this became public knowledge, that U.S. experimental aircraft were freely flying over our country, no matter how high it was! Flying at over 5,000 mph, the "Aurora" can circle the globe in about 5 hours. (Figure 3)

This interim report will shortly be up-dated and released seperately, we are hoping to have more information from several sources by the end of this year. I hope that the information here clears some of the mystery up for you, if you have any questions or, possibly some answers, drop me a line at the editorial address.

A visiter from Norway...

On Wednesday July 7th, 1993, Pat and myself headed for the Harcourt Hotel, Harcourt Street in central Dublin. We were to meet Mrs. Shelia McCabe, a BUFORA (UK) member, from Bergen in Norway. Shelia was in Ireland to do a course in the University of Galway, on the West coast of Ireland. She came to Dublin on the 7th in order for her to catch the boat to England so that she could attend the BUFORA Conference in Sheffield on the weekend of the 9th-11th July. She had written to us previously, telling us of her plans and hoping that she could meet with us before she left for England.

Having introduced ourselves to her we whiaked her off to dinner, by taxi, courtesy of BUFORA (Ireland) Branch, to a restaurant in Dame Street, where during our meal, Shelia told us all about herself and her interest in UFO's.

Shelia described to us a UFO sighting which she had many years ago in Trondheim in Norway. She and a friend were out for a walk one night when Shelia, for some reason, felt compelled to look up at the sky. On doing so, she saw a very bright white light which appeared stationary in the sky, it was shaped like a triangle and it had green coloured lights all around it which flashed continually. She observed it for a few seconds and then it disappered out of

view into the clouda, she did not see it again. The following day, the local newspaper reported that a UFO had been seen over the Trondheim by several witnesses, but they said it might have been connected to crop circles, some of which had been seen in the area prior to the sighting. However, the media soon grew tired of it and it became just 'another forgotten UFO story'.

She then went on to explain to us that her interest in the UFO phenomenon stemmed from her interest in the crop circles and she is a member of a prominent crop circle group based in England. Shelia belives that the sighting of UFO's and the appearances of crop circles in fields all over Europe, are connected.

We also discussed with her at length the many possible reasons why it is taking ET's so long to contact us. We all agreed that they are not interested in making their presence known to us because of the way we are, constantly destroying our planet, especially the way we are treating our rain forests and Ozone layer. (They will probably make their presence known to us when they feel we are ready to except them, or, powerful authorities on this planet do not want them to show themselves until the mass population have been better educated for such a revalation. - Ed)

We then turned our attention to the fascinating subject of alien abductions and asked Shelia if she was aware of any such abductions in Norway over the last few years, she wasn't aware of any. At 9:15pm, dinner had ended and it was time to go (such are the time restrictions on the working class!), Shelia surprised us with the announcement that she would like to become a member of BUFORA (Ireland) Branch, earlier we had presented her with two back issues of our Journal and an information pack. Naturally Pat and I were very happy to have someone like Shelia as our first European member of BUFORA (Ireland).

In closing, Pat and I found Shelia to be a most interesting person and well versed on the topic of UFO's and corn circles. We very much enjoyed her company and her stories, we would like to thank Shelia for taking time out to meet us at such short notice, we hope she enjoyed herself too.

We hope you enjoyed our synopsis (courtesy of UIP and Philip Mantle) of 'Fire in the Sky' in our last issue. It reached Irish cinemas before the U.K. release date and is still doing the rounds in the larger multi-screen cinemas, so if you haven't seen it yet we strongly advise that you do so.

However, some critics have an annoying habit of describing these type of films as 'entertaining'. The word 'entertaining' can be applied to a lot of movies, but to apply it to a movie like 'Fire in the Sky' is implying that such movies (based on fact) are light hearted, funny and generally good-all-round 'entertainment'. In fact, it makes the subject of UFOlogy, serious minded UFOlogists and the millions of witnesses look rather ridiculous when films of this nature are given the kind of 'sceptic once-over' by these film critics.

Regardless of whether or not the story is true (in this case, we belive it is), describing it as 'entertaining' is certainly not encouraging to people who are interested in the phenomenon to go and see this film. In the first place, the UFO phenomenon is not meant to be entertaining, it was never meant to be and should not be treated as such. To quote the former Soviet President, Mikhail Gorbachev - 'The phenomenon of UFO's does exist, and it must be treated seriously' (1990).

It is no wonder that the phenomenon is having such a hard time trying to become accepted when this frivolous attitude is adopted by certain people in society. Was Travous Walton's

abduction 'funny' and 'entertaining'? - no it wasn't, for him the whole experience was very real and traumatic. For people to make absurd statements or describe a film of this kind in the critical way they do, contributes much to the fact that they are not taken seriously, what of the thousands of other abductees, are they all as 'entertaining' as Travous Walton?

I'm not asking you to like this film, if you have seen it, maybe you didn't like it, thats your privilege. But if you went to see this film on the grounds of being 'highly entertained', then forget it, because there is no way you can experience all the pain and trauma that Travous Walton suffered, unless of course it has happened to you.

UFOs and Bookshops.

In the first issue of the Journal Karl mentioned how difficult it was to find UFO titles in Irish book shops. In most city centre bookshops they are mainly to be found in the "New Age" section.

However, this is not the fault of the bookshop as it is possible that they are not sure just exactly what section to file them under. Also when one goes hunting for popular UFO titles they are as scarce as UFO sightings themselves!

In one particular Dublin bookshop recently we counted six UFO publications which were not even new titles, and they appeared to have been there for quite some time. This seems such a pity because if the subject was taken seriously here, there is a vast wealth of new titles coming into print all the time.

However, filing UFO titles in the "New Age" section is like filing a Charles Dickens Novel in the Theology section, as it is not really a "New Age" subject, especially as UFOs have been traced back to prebiblical times and existed long before the "New Age" Movement was ever heard of.

It could perhaps be said that the study of UFOs and proper investigation of the Phenomena did not really get under way until 1947 when Kenneth Arnold had his famous sighting over Mt. Raineir in Washington State. I would like to point out here, that I am not in any way criticising the "New Age" Movement or those who belong to it - All I'm saying is that bookshops should have a particular section for the UFO enthusiast under the suggested heading of "UFO Phenomenon".

If this was implemented by the large bookshops especially those in Dublin, The would be doing a great service to Ufology and it would assist us greatly in helping to bring much needed credibility to the subject of UPOs.

In the future, we at BUFORA (Ireland) BRANCH are hoping to rectify this situation by approaching a particular bookshop in the City Centre to ask them if they would consider a special section for UFO titles only. We would also request of them to stock all the popular UFO authors especially new editions and we would also supply them with up to date lists of new publications as they come to hand.

We hope, that we will see the day when we can go into a bookshop and find a section stocked with lovely books under the general title of "UFO Phenomenon". Could this become a reality? What do you think? Write to our Editor, Karl, and let us know your views on this. We would like to hear from you.


Vatican Secrecy?

USO's - Life under the waves?

Today, the word UFO conjures up all sorts of images, from 'Flash Gordan' to 'Star Trek', but we all know that these UFO's are highly sophisticated interstellar craft from (we hope!) other civilisations many light-years from our own planet. Saucers are the most common image to think of when the word Unidentified Flying Object is mentioned, and of course, those 'little green' aliens! - But what would the word USO conjure up in your mind? In this article we will list a handful of the many USO sightings from around the world and just like the UFO phenomenon, we will see that the military are just as 'interested' in USO's as they are in UFO's...

U.S.O. - Unidentified Submarine Object

In November 1990, more than seventy people witnessed a USO change into a UFO while they were waiting for a ferry across the Araguari River in Brazil. They saw a solid object about 15 feet in diameter rise out of the water and climb to a height of 650 feet, there it hovered for a few minutes before moving slowly out to sea.

The First Mate of the Tugboat 'Catoba-Seahorse' may have seen a UFO/USO link-up on the night of 26th July, 1980. The boat was on a routine journey

some sixty miles off the Brazilian coast, near Natal. The First Mate was on duty and he became suddenly aware of a grey object, 30 feet across, floating on the surface of the water, he also observed a bright light over the sea which was approaching them rapidly. The strange floating object was in the path of the tugboat and so the First Mate changed course to avoid a possible collision. At the same time the floating object turned on various coloured lights - yellow, red green and blue. The aerial object, the bright light, had now reached the floating object and hovered about 200 feet above it. The tugboat came to a stop as the crew decided to watch with a mixture of fear and fasination.

The oval shaped light slowly descended onto the floating USO until they joined together. The USO's lights went out and the two objects rose from the water together, after hovering for some minutes the combined objects flew rapidly out to sea. Some questions that come to mind are, did the tugboat crew witness pick-up of USO by a UFO? or was this the rescue by a UFO of another UFO in distress? Either way, this sighting must rate as unique and even the Brazilian Naval authorities were impressed enough by the sighting that a high-level investigation was undertaken, but any conclusions, if any, were kept to themselves.

USO's sighted in North America: On the evening of 27th March, 1979, Wesley Gruman was driving to Oak Bluff, Massachusetts, when he noticed a green glow over the top of some sand dunes. When his view of the water became unobstructed he saw a 30 foot long luminous cylinder, floating 200 feet offshore. He stopped his car and watched as the strange object rose silently from the surface of the water. Gruman decided to leave his car, get a torch, and investigate further, but to his surprise he found that he could only move his head. This paralysis lasted until the object had flown out of sight, he also reported other odd effects. The first was a low frequency hum from his car's AM radio during the sighting (Radio interference and paralysis being a common report during many UFO encounters - Ed), the second concerned his wristwatch. The hand-wound model had been three days 'behind' with the date before the encounter, but the next day it showed the correct date.

Another mystery object was seen off the American coast by John Gallagher in April 1961. He was working on a house close to the beach at Newport, Rhode Island (Approx. 38 Miles by air from Oak Bluff, point to point - Ed), when he noticed a red sphere bobbing on the water. Intrigued by the object he moved

to the second floor of the building to get a better view. Gallagher observed that it was about 200 yards offshore and drifting seawards, suddenly it left the surface of the water and rose to height of about 60 feet, it then accelerated up to a speed of approx. 100 MPH, moving out to sea in a straight line. Gallagher was convinced he had not seen a balloon, it's movements were that of a controlled object rather than something that was being blown about by the wind.

United Kingdom: The driver and pasengers of a London bus had a grand- stand view when a silver coloured UFO dived into the river Lea. The cigar-shaped object had first cut through some telephone cables and smashed into a concrete bank. Bob Fall was driving his bus on the 13th April, 1964, when the object dived across the road in front of him and into the river. The Police dragged the six foot deep river but found nothing, suggesting that the witnesses had seen a flight of ducks, but that doesn't explain the broken

telephone lines and damaged concrete.

The following report suggests that some UFO's may need to cool their structures after flights through the atmosphere. In the Summer of 1967, a pack of Cub Scouts and their leader were camped on the shore of the Grand Lake, approx. 20 miles from St. John, New Brunswick, Canada. The boys were asleep and the leader and his assistant had gone down to the lake to get some water, an object, shaped like two saucers placed face to face, came through the darkening sky with red, orange, green and blue lights flashing around it's edge. The strange craft entered the lake accompanied by a 'sizzling' noise. The lake was fed by mountain snow contained cold, clear water, but the following morning the water was muddy and felt warm.


UFO's and USO's seem to find reservoirs particularly interesting since they have been many sighting over and in them. Some

researchers have suggested that they are monitoring the pollution we subject ourselves, it has even been said that 'they' might be doping our water supplies, but for what reasons?

Many of the worlds Navies have had encounters with strange underwater craft, which at times greatly exceed the performance of conventional vessels. A huge underwater craft was detected by the United States Aircraft Carrier 'WASP' and twelve other vessels whilst on manoeuvers in the North Atlantic in 1963. The USO travelled at 150 Knots (or 175 MPH). The strange craft stayed with the fleet for four days, sometimes diving to a depth of 27,000 feet, the record depth for a known submarine is 6,300 feet Approx.

It may have been a USO that the Norwegian Navy tracked for three weeks during November 1972. The mysterious craft was reportedly detected underwater and lost again in the Sogne Fjord. Apart from the Norwegian Navy, several NATO ships and aircraft helped in a search for the strange craft. Despite the use of depth charges the unknown craft could not be made to surface.

On the 23rd November, a large dark object was spotted moving below the surface in the Lustor Fjord, a branch of the main Fjord. At about the same time in another branch, the Aurlands Fjord, a warship had tracked a submarine with sonar. That night, six red rockets were seen fired into the sky from below the surface of the water, red and green flashing lights were seen on an




inaccessible peak overlooking the Aurlands Fjord.

The 24th November saw a concerted attack by the combined forces with depth charges, the result of this action was the opening up of a powerful, but unknown, jamming source. This completely disrupted communications and rendered all radar and sonar inoperative. On the 27th November, the Norwegian authorities stated that the craft had left the Fjord, still unseen and unidentified. Similar incidents have happened in other Norwegian Fjords, in Swedish coastal waters and around the coast of Greenland, they were usually in areas of no apparent Military importance, none of these mysterious vessels have ever been trapped or positively identified.

Another USO hunt took place in Southern American coastal waters, this time in the Nuevo Gulf. Argentina, in February 1960. For two weeks the Argentinian Navy chased two mystery submarines and were amazed by their speed and manoeuvrability. (Some of these incidents could probably be accounted to the use of experimental craft by unknown military powers, I'm sure that the new technologies, for example, the U.S. 'Stealth' technology, has been tested by 'teasing' other countries military authorities; After all, there's nothing like the real thing when it comes to the acid test, no matter haw many 'war- games' they play... - Ed)

Fire in the Sky

On a warm Tuesday in June (the 29th to be exact) Pat and myself made our way in the stifling heat, to the Carlton Cinema in Dublin's O'Connell Street, to see the Tracey Torme production of 'Fire in the Sky'.

When we arrived in screen number 4, we expected to find the cinema practically empty with the exception of ourselves, but to our surprise, on doing a quick head-count, there were fifteen people there. Not bad when you consider the time (2:15pm) of the screening and the fact that most people would be enjoying the summer sunshine. The audience consisted of one elderly person and some teenagers, the rest were adults, and throughout the film the audience were so quiet you could here a pin drop (or an alien surgical instrument... - Ed).

Now, onto the film itself. Well, for want of a better word, we really 'enjoyed' it, but not in the same sense as one usually 'enjoys' movies, but, we were viewing it from a UFOogists point of view.

There is no need to tell you the story of 'Fire in the Sky' here as we have already printed a preview in our last issue. This is one of the few movies (of this type) where the director or the producer did not set out to sensationalise the actual story. Torme produced it just as it happened that night to Travis Walton in the town of Snowflake, Arizona. There was nothing added to the story.

It's main message was that UFO abductions can happen to anyone.

in this case Travis Walton was a woodcutter, who had a dream of forming his own bike company (M&T) with his friend Mike Thomas. (Travis was portrayed very well by Actor D.B. Sweeney). Of course the reaction of the townspeople and the County Investigator (Portrayed by Actor James Garner) showed the extent people will go to discredit stories such as this one, that Travis's friends told to the County Investigator. His skepticism is typical of just what abductees and UFO witnesses have to face when recalling their experiences, as well as the scorn and ridicule from people they know and work with.

For example, five days after Travis had 'come back', he was sitting in his car waiting for his girlfriend to emerge from the local store with shopping. All around him were people who use to say 'hello', now they just passed him by, ignoring him completely, they most probably were afraid of him and perhaps thought he was a bit of a 'fruit-cake'... An interesting scene was when a kid came up to Walton's car window with a newspaper which headlined. 'Local Man Abducted By Aliens' - the kid asks Travis to autograph the newspaper, he does, but why did he autograph this paper. especially when the abduction had had such a traumatic effect on him?

The abduction scenario was one of the most terrifying scenes we've ever sat through at a movie. It's one thing to read about an abduction, and there are many books to read on this subject, but to see the aliens (quite



ugly looking they were too!) actually performing genetic surgery on this man, with some terrible contraption hooked up to his left eye and horrible slimey stuff pushed into his mouth is enough to put anyone off been abducted by such creatures (Do you really want to be abducted Anne? - Ed)

As far as we are concerned thi is the best scene in the film, you can't help feeling sorry for Travis and yet you feel so helpless. Travis deserves our sympathy (as do all abductees - Ed), as well as his friends. We do know one thing, what ever about UFO's, nobody should have to go through such trauma and terror, abduction is an invasion of a person's body, not just his privacy - but who can stop 'them' from doing these 'experiments'?

In closing, Tracey Torme is to be congratulated on producing such a fine film on the abduction issue and for highlighting the seriousness of it. Remember, abductions are not science fiction, they are science fact and it should be taken much more seriously by our scientists and Governments, though maybe they already know the why human beings are being abducted?



An Interview with: Zenny Randles

Q1: Jenny, how and when, did you become interested in UFOlogy?

(1) I recall a UFO sighting when I was 11 and on holiday in Blackpool. I saw nothing, but people in the hotel spoke of it at breakfast. I got intrigued. Later I saved up money from my newspaper round to subscribe to FSR magazine (in mid 1968) and was hooked. Then serious articles by Keel, Vallee, Hynek and Co. were a real thrill, only surpassed by meeting these same people - my original heroes - (in Keel's case some 24 years later!) As far as I know I had no UFO sightings to trigger my interest; although some odd things about that Summers day in Blackpool do still bug me...

Q2: Did you ever witness see a UFO or have a paranormal experience? If so, how did you feel?

(2) In 1969 or so I saw a red spark from a chimney pot that looked like a UFO. I knew it wasn't but wrote to Charles Bowen, then editor of FSR, to tell him about it. I was excited to get an answer. Since then I have seen about 12 things, in at least two cases they were reported as a UFO (one is described in UFO Reality). However, there are always conventional explanations. The only odd things I have witnessed were three lights in a triangular formation seen by my boyfriend and I in September 1980 over the Avebury stone circle in Wiltshire as we rode past on our motorbike. (discussed in the introduction to "The Green Stone") and a blue light which we also both saw in Chester in August 1978 for which I have been hypnotically regressed... but thats another (very long,

interesting, but easily misunderstood) story!

Q3: What was the very first article you ever wrote and for which publication did you write for?

(3) In the 1960's my parents both ran a junior football team and I helped them by editing the leagues magazine for several years. I even later wrote the odd football story for the Manchester Evening News soccer paper (not a lot of people know that, as someone said). Later I produced a magazine for a rhoematoid arthritis charity - so by the time I started editing the Norther UFO News (In 1974) I was well versed in writing. My first professionally published article (that is, I got paid for it) was \$50 from a short lived U.S. news-stand magazine - "Official UFO" - published in 1976. The same month it appeared (November) I sold my first book - "UFO's: A British Viewpoint" to Robert Hale (published in 1979, and taking three years as I was working at the time).

Q4: When did you join BUFORA?

(4) I joined BUFORA (again with newspaper round money) in 1969 and was a passive member until 1972. Then whilst teacher training at a little village near Crewe, I used the subject as a class project and was amazed at the number of children who had sightings but were afraid to talk. Soon after, I joined MUFORA (Manchester UFO Research Association) - then already 10 years old, but of which I have been a member ever since. In 1973 I became a BUFORA

investigator and with othes created the Northern UFO Network, as we felt that BUFORA was very London oriented and we wanted to fight for more regional input. In 1975 I was invited onto council as "Northern Liaison Officer", vindicating my stance. I took my present role as director of investigations in 1981.

Q5: Jenny, we hear a lot today about alien abduction stories. Do you think this particular aspect of the phenomenon is taken seriously in Europe and America and what is the attitude of those countries to the victims, is enough being done to help them?

(5) There are very different approaches to the abduction phenomenon in Europe and the USA. In Europe we focus more on the witness as a medium through which the experience is filtered. In the USA the literal reality of the story is presumed and it's minutae are studied. My experience tells me that this is a mistake, but I also feel that - as nobody has a monopoly on truth or knows what is really going on both approaches are important and should complement one another. Few people are willing to take both seriously, which is a pity. In many respects we are ahead of the U.S. in terms of objectivity and sophistication. In other ways they are far ahead in terms of how they can help the witness. This is largely because that are a nation of psychiatrists (everyone there knows an analyst!). Here it is very hard to find that kind of support for a witness. In my time with BUFORA I have recognised the importance of the needs of the witness. I wrote

aspect in one of my chapters in the 1988 BUFORA book "Phenomenon". I helped to create the code of practice now governing how investigators must respect the rights of witnesses and, eventually, to have acceptance of this as a mandatory part of any membership of BUFORA, not simply it's investigators. I also totally support the work of Ken Phillips, Judith Jaafar and Janice Georgiou running the "Witness Support Group" - which exists. almost like alcoholics anonymous to give self support to victims of close encounters. So, within our distinct limitations, we are trying, but there is a way to go yet.

Q6: After the Randelsham Forest affair, did you experience any strange visitations from MIB's or other of their type?

(6) I am pleased to say I have never had a MIB visit. If they turned up I would ask them to pose in front of my video camera or get thrown out! So I doubt they'll show up on my doorstep. However, as the story in "From out the Blue" recounts, I was threatened in a roundabout way by a Ministry of Defence scientist who told me that my work on this case was treading on dangerous territory, that he was dropping it and so should I as it might prove hazardous otherwise. Thats about as close as I've got, but he was no MIB. He gave me his name, I checked him out, he was a real nuclear scientist who worked for the government on secret projects.

Q7/8: What are your feelings on the world-wide cover-up of UFO's, and do you think the British Government will be more open about it's knowledge of the phenomenon with it's new 'Open Government' policy recently announced? (8) Do you think the

British authorities 'have' any alien hardware? If they do, is it based in the U.K.? Is there co-operation between the American authorities and/or other nations in relation to UFO's?

(7 & 8) The U.K. government is already more co-operative. Between 1978 and 1982 I had a series of exchanges with them (which I wrote about in FSR at the time as "The Ministry of Defence Approach") in which I attempted to rationalise them into becoming more free with their data. My premise was that if they kept clamming up their reinforced view (which they said was an illusion) that they were covering up, the only way to prove they were not doing so was to start releasing data. In December 1980 I was invited to address MP's, Lords and Ladies in Westminster on UFO's in this country. I met two former prime ministers in the process and had interesting discussions. The "education programme" concept was the first mooted to me then. On the whole I learned from all of the above that (like us) the government of the UK (and I think by inference everywhere else) know the following:

Most UFO's are mistaken identity

There are some that remain unresolved

Nobody knows exactly what they are, be they natural or alien Either way, they use interesting energies that could be harnessed for offensive or defensive purposes.

As a consequence, the powers that be had to maintain a monitor and study the energies to see what they could do. It would be stupid to go public and say "look folks, we thought you would like to know that these things are flying around, outstripping our aircraft, we don't

know what they are and can't do a darned thing about them, we don't think they are aliens and there is no evidence they are hostile, but we can't prove there not, okay?" That is the perfect recipe to lose the next election...

Ergo, the cover up, such as it is, is one of ignorance rather than of knowlegde. I have said this constantly since 1980 and it's beginning to sink in with people. Ralph Noves, former MoD section head, confirmed I was correct. In 1982 the MoD (at first secretly, then later they let me make it public) agreed to release their UFO files. However, when I asked to see the Brentwaters/Rendelsham Forest material (then still unknown to the public) they sent me cases from anywhere but to shut me up. When the case later became big news the MoD were embarresses and renaged on their promise.

However, since 1982 the man at the helm of Air Staff 2 A (for I think the first time ever) is himself interested in UFO's. As such he has taken the subject far more seriously, is releasing data on a cooperative basis much more willingly, will talk on the phone to BUFORA investigators to discuss cases (unthinkable even 2 years ago!) and is channeling witnesses through to us as well. This is a sensible, positive move. It may not outlast his rotation to another job when it happens. But if it does it reflects a general more open policy, then I think the MoD are doing the right thing.

In short, I do not accept tales of captured spaceships, dead bodies of aliens and fantastic secrets hidden for half a century. The Americans couldn't even hide a little burglary in the Watergate building, how the heck could they hide something as big as crashed UFO's and captured aliens? Mind

you, after saying all that to a local journalist, one UFOlogist sued me for a lot of money - so I don't expect it to be a popular opinion, sadly, I honestly reckon it's the truth

Q9: Do you think the 'aliens' have already made contact with Earth? If they have, why are NASA spending so much looking for them?

(9) I am undecided as to whether alien contact has been established. the vast majority of UFO sightings definately have nothing to say on the matter one way or the other. They are misperceptions (90% of cases) and UAP (i.e. several different natural, but explained energy phenomena) in the other 5 -10% remains to be seen, it is possible that 1% or so refer to contact with another intelligence, but that is unproven. Equally, I have a feeling that if any real hardware is involved it does not come from space but from our own future (this will be addressed in my book on time travel which Cassell are publishing). I am pretty certain there are aliens "out there", it is also possible that they visited us millenia ago (the face on Mars is fascinating). It is also at least 50/50 in my view that alien contact by way of some mind to mind kind of communication is occuring today in some extraordinary cases. But I am far from being persuaded that ET spacecraft are visiting earth. NASA are looking because they don't buy any of that nonsense (in most cases what they read about is nonsense so I don't blame them!) and they do not want earth to be alone. I think the idea of contacting aliens via radio telescope is about as useless as trying to talk to your cousin in Australia (Oz) via two tin cans and a piece of string (using the Oz factor would be a much better

bet!). It's archaic technology. worthless for intersteller contact and no self respecting advanced intelligence would use it. They would be harnessing consciousness which by-passes the speed of light (exactly as the UFO evidence infers). You can find a deeper discussion of this in "Looking for the Aliens" by Peter Hough and myself (Cassell, 1992) (although, I have a few copies available at half price, i.e. £4.00 (UK Currency only) via my home address if any reader is interested and cannot find it in the shops). NASA are using this duff technology as it is the best they have and they need to try for their own piece of mind. Of course, if the U.S. government really had made alien contact and had ET's in store, I cannot believe they would have been stupid enough not to simply veto the huge budget for project Columbus.

Q10: Staying with NASA, what are your feelings on this 'public' organisation? - Is SETI a P.R. exercise? Deep down inside NASA, do you think it is as open as it says it is? If SETI discovers life, NASA say they will hold a press conference at the U.N., or will they?

(10) Again, in "Looking for the Aliens", we report the on the protocol that we got hold of, discussing how NASA will release data if alien contact was made. We'd be about the last to know after an amazing series of checks, double, triple and quadruple checks and a presidential discussion. If they made contact in 1992, they might get around to telling us by about the year 2002. Part of the problem is the false echoes they've picked up before which, only after lengthy and embarassing investigation did they realise were not alien messages but something more mundane. This

time they'd want to be VERY sure before they said anything.

Q11: Tim Good reported a theroy by Paul Bennewitz in his book "Alien Liaison" about US Government involvement with cattle mutilations as 'part of a clandestine plan with the aliens', although Bennewitz was being fed a lot of disinformation, what are your thoughts on his theroy?

(11) I have no idea what lies behind cattle mutilations. They are pretty mysterious. Possible links with UFO's are interesting but not strong enough to be conclusive, in my view, I think the idea of the U.S. government being in league with aliens is about as credible as Donald Duck becoming the next U.S. president... Of course, Ronald Reagan made it...

Q12: Do you think the US 'Stealth' technology could be any way linked to recovered alien hardware?

(12) At Tonopah Air Force base, Nevada, they build secret aircraft technology far ahead of our seeing Stealth was flown there and later from around the world years before aviation experts knew. Today the cutting edge of aircraft technology (a reliable source tells me some aircraft are powered by nuclear engines) are flying, but we won't hear of them until the year 2000 or later. It's very handy for these sources to know that if such jets are seen they will be assumed to be UFO's. It gives them flexibility to fly very freely. Indeed, I suspect that may even go out of their way to make them look more UFO-like to aid that advantage. This may not be unconnected with what happened in Rendlesham Forest... Why bring aliens into this equation?

About our organisation...

The modern study of the Unidentified Flying Objects phenomena (UFOs) is commonly held to have started with the report of Kenneth Arnold. On Tuesday 24th June, 1947, Arnold, a private pilot, reported 'nine peculiar aircraft' near Mount Rainier, Washington State, USA. In fact there appear to have been many reports over the years before Arnold's report. In the UK and particularly Ireland there are reports of strange aerial phenomena back at least to the turn of the century.

There are many theories about the possible origins or nature of these phenomena including, amongst others, UFOs maybe natural phenomena and UFOs maybe advanced (alien?) technology. BUFORA (Ireland) Branch recognises that there are a number of explanatory hypotheses and does not advocate to any particular theory.

BUFORA, the Headquarters in England, was founded in 1962 as a federation of UFO groups throughout the UK. Many of these groups were formed in the 1950's. These included the British Flying Saucer Bureau, founded in

1952, which is belived to be the UK's oldest UFO group. In 1962 the group was known as the British UFO Association, changing it's name in 1964 to the present British UFO Research Association (BUFORA). In 1989 BUFORA Ireland was formed under the Directorship of Pat Delaney and Anne Griffin.

In April 1992 we were affiliated to BUFORA England, and are now officially known as 'BUFORA (Ireland) Branch' BUFORA (Ireland) Branch is registered under the Data Protection Act, and amongst other things our membership records are held on a computer data base. (It is the policy of BUFORA (Ireland) Branch NOT to release membership records to third parties.)

Membership is open to all who support the aims of the association, and whose application is approved by the Council of Management.

The aims of BUFORA (Ireland) Branch:

a) To encourage, promote and conduct unbiased scientific research of the Unidentified Flying Objects (UFO) phenomena throughout Ireland and England.

- b) To collect and disseminate evidence and data relating to Unidentified Flying Objects (UFOs).
- c) To co-ordinate UFO research throughout Ireland and to co-operate with others engaged in such research throughout the world.

Our activities include research and investigation. The investigators carry out on site field investigation of reported cases, while the research involves such activities as statistical and technical research support activities. We can also accommodate witnesses who need extra support, our mother house in the UK now runs a 'Witness Support Group' (WSG). These activities are backed up by a press cutting service and libraries of case reports, we can provide case information for recognised UFO reserach groups.

We publish a Journal three times yearly which keeps members up-to-date with the Irish and International scene. This Journal is also available to non-members of the Irish Branch of BUFORA for £3.00 inc. P&P.
