JOHN MACK INVESTIGATED: It is sad to see that the eminent Harvard based psychiatrist and Professor, John Mack is the subject of investigation by his colleagues because of his Research into alien abductions es-

pecially those who claimed that they had sex with space creatures.

It seems that before he became involved with abductees he was seen as a highly respected, rational and sane man but once he became involved with Abductees his colleagues immediately decided that he is a little strange and because he takes the time and the trouble to listen sympathetically to Abductees and their experiences, this automatically qualifies him for the "funny farm".
