Mrs. [REDACTED] stated that Mrs. [REDACTED] had called her stating that she had seen three saucer-shaped objects in the sky. Mrs. [REDACTED] was then interviewed by Lt. STATEMENT BY [REDACTED]

At 12:15 on the 22nd of April 1952, I was standing in my yard in Condon, Oregon. I saw three saucer-shaped objects moving East, North of Condon. They were in formation and the larger saucer apparently in the lead. They were gray-brown in color on the underside and shiny metallic on all other surfaces. They were moving at a fast rate of speed and I saw them only for approximately two minutes. The larger was revolving, but it was so far away that I couldn't tell the direction.
